City Council in Idaho City Determines Fate of Firehouse

IDAHO CITY -- On March 20th, at 6:00 p.m., the City of Idaho City held a special meeting regarding the Idaho City Fire Protection District's leased property with the city. They asked for members of the Idaho City Fire District to attend, along with the public.

The meeting was well-attended, with nearly 200 people in attendance.

Mayor Everhart stated that he was seeking input from the Fire Department, the Idaho City resi-

dents, and from the fire district residents. He said no decision would be made tonight, but that this meeting was declared to share input and information.

Mayor Everhart said, "I believe one of the biggest responsibilities I have is to oversee and take care of the assets that Idaho City has. I always believed, and still do, that the facility down there belongs to Idaho City. And even though there is some dispute, I think we can get through that. We don't have the last page to the sale of that property, but I think I would be remiss

of my responsibility as a city official, if we just gave that away, it doesn't seem to be right." "It's a benefit to the City and I think we can come to an agreement with the fire department, and the fire district and the Idaho City as well. We just need to work through details and figure out what that route is. The first this came to my attention that there was even any dispute of the ownership was in the early stages of the Fire District being formed. Then it was brought to our attention that the Fire Department thought that it was the

Idaho City Fire Department rather than the Fire District. But any expense that was not covered by that was just paid for by the residents in the Idaho City limits. It provided services to the entire area, but those who lived outside of the limits of Idaho City received a bill for putting a fire out, but none of the residents outside the city limits had any responsibility for that building. When that was brought to our attention, we were asked for documentation of this, any agreements between the fire department and the city that would clarify that, because again my responsibility is to take care of the assets of the city, and without documentation I would be remiss in my job if I just readily agreed and gave away that asset. So that is why we have a situation. The final goal that I see of this meeting and the talks we have had is to reach an agreement that is beneficial to both the district and the city."

Councilmember Tom Secor Jr. followed with the comment, "I am going to sit back and wait until we can have a good discussion after I hear all the information. People have said that I never supported the Fire District. But I felt that they used 'scare tactics' to form the Fire District. People said the Fire District would not respond to fires outside the city limits and that was completely wrong. When I was in the Fire Department we responded down to Thorn Creek and Clear Creek and other places. It's not like we were not going to help. I was put off by the fact that it was sold with the thought that we weren't going to help. So, let's keep going on."

Councilmember Mari Adams said, "I'm interested in what everyone has to say and hope we can figure out the best route to go."

Councilmember Ashley Elliott commented, "I really don't want this meeting to be a history lesson or a speech. The purpose is to bring us to an agreement between the taxpayers of Idaho City and

the taxpayers of the Fire District. My opinion is: ask the taxpayers of Idaho City Fire District to purchase the fire house and the taxpayers of Idaho City would be 'robbing Peter to pay Paul'. The property is owned by the City of Idaho City. This is an asset of Idaho City and an asset that the city would probably never sell to anyone besides the Fire District. I suggest the fire district purchase the property from the city. We're not talking about the building. So, taxpayer to taxpayer and purchase rights should be the excess amount of the land. I personally don't think it matters who does what or when, it seems there are too many accounts of community feelings when you try to talk about it. Let's talk less of the past and talk only of the future. The fact is the property is owned by the city and the fact that the fire department wants to see it in their name so they can write their grant. The fact is that the transaction would be taxpayer to taxpayer. The fact the city would probably never sell this property to anyone else. The land value when I checked was \$127,000.00, a land survey would need to be conducted plus the cost of the survey would fall to the purchaser and that way we are not talking about the building. I think this is a settlement that both parties, the city, and the fire department, could agree on and that both parties could make a concession. If it's less than what the city wants for the property or more money than the firemen want to offer, if that issue arises, there should be a compromise."

Councilmember Heffington said, "I just want to sit back and listen, I don't have anything to say. Thank you."

Brent Adamson, Commission Chair of the Fire District, stated, "I want to say in public that I love Ashley Elliott and I also disagree with her on one point. I think we

Idaho City's Wildcat Baseball Tournament in Challis

IDAHO CITY -- The Idaho City Wildcat Baseball Team travelled to Challis, ID to play in a division 2A baseball tournament hosted by the Challis/Arco/Mackay cooperative high school team known as the Rivercats. The Idaho City Wildcats came out swinging in the first game against the Soda Springs Cardinals. Hayden Higgins went 2/3 with 2 RBI's, Dax Olvera 2/3 with an RBI, Trey Martiny 2/3, Gabe Goodman 2/2 with an RBI, Sean Rousset 2/2, and Tell Jewell with a hit. Pitcher, Mason Taylor, would earn the win. The Wildcats put together 11 runs to beat the Cardinals 11-3 for the team's first division 2A win in the history of the program.

In game two of the tournament, despite a great effort pitching by Tell Jewell, the Wildcat's only hit came from Hayden Higgins who broke up the no hitter from the Challis Rivercat's hard throwing right hander Ruger Nicholls. Nicholls may be the best pitcher the Wildcats see all season. The Wildcats lost 10-1 to the Challis Rivercats.

In game three, the Wildcats came out slow and cold. A few errors and walks caused the Wildcats to get behind by 11 runs. Trey Martiny, Dax Olvera, and Tell Jewell were the only Wildcats able to generate some base hits and score 2 runs. The tournament

time limit came into play and the Wildcats were unable to get back up to bat to score more runs. the Wildcats lost to Salmon 2-11.

The Wildcats had a slow start in game three and went down 7-0 in the 3rd against Soda Springs in the battle for third place. Hayden Higgins fought a pelting graupel storm trying to finish the inning, but the umpire stopped the game and sent the teams to their dugouts to wait out the storm. The tournament director asked the Idaho City team if they wanted to call the game. Coach Hunicke requested we wait the storm out and finish the game. Higgins returned to the mound after the storm calmed down and struck out the batter to end the inning. Tell Jewell did not let the seven-run deficit discourage him,

he raised the spirits of the team in the bottom of the third inning with a leadoff home run over the right center field fence. After a couple hits and walks from his teammates, Jewell came up to bat a second time in the same inning with the bases loaded. Hunicke told Jewell, "Don't think you are going to hit another home run, take a little off your swing and hit it up the middle." Jewell ignored Hunicke and proceeded to hit a grand slam home run over the right center field fence again! Jewell went 2/3 and was joined by teammates Trey Martiny 2/3, Gabe Goodman 2/2, Damien Morrison with a double, and Sean Rousset and Hayden Higgins each with a single. Hayden Higgins earned the win as the starting pitcher.

The previous week, the Wildcats won their conference opener against Wilder HS 32-0, and beat conference rival Vision Charter 25-3, leaving the Wildcats 2-0 in conference. The Wildcats dropped a game to division 2 Melba HS last week 5-15. The Wildcats are currently 4-3 overall. The next game is Tuesday, March 26th at Simplot Field 7 in Columbia Village, Boise

need to go back into the history and think about it, and as I have talked to many people over the course of this since we have had a Fire District, one thing keeps coming back. The volunteers built the building to have a fire station. I think the city was grateful they did that work. There was never any intention of not letting the fire department stay, never. The problem came when the fire district was formed. Now that we have made the fire department separate, and the firemen think we'll always have this building, but now it has left us. I think Ashley has raised a positive plan that we really haven't discussed till this day. That we look at other ways this works. We never got an opportunity to spend the time and have this conversation with transfer tables. I think both sides are interested in getting it done. I appreciate Idaho City Council letting me come and talk. I hope we can come to a great idea."

Dave Kuwahara, Fire Commissioner of the Fire District said, "Everyone wants what is best for the town, and I think the one concern I have is that the all the fire commissioners and the city councilmembers are elected positions and with that comes other obligations, but we hope all will agree."

The mayor then read a com-

ment submitted by John Roberts: "We created a new entity when we created the fire district by popular vote. The city and the fire district have separate but overlapping constituents and taxpayers. The city has long supported many of us who don't pay city taxes but who travel the city streets and rely on the volunteer fire department for years and years. I suspect that this meeting is now an opportunity to decide who owns what and set those separate entities up for the benefit of both. The creation of a new fire district creates new taxing streams and should release the impact on the city, while allowing the fire district to become better and better. Of course, a lot of those decisions will be governed by what agreements were made in the past."

George Thomas, Fire Commissioner, responded, "I agree with what has been said, I think we need to get it resolved. So, when we want to expand the building that we will have the ownership of it, for another bay, another room that we can utilize, and the community can also use as a meeting place. It will be smaller than this hall, but one the community could use. We need to resolve this so we can progress instead of staying status quo."

Carl White commented, "I've lived in Boise County for 18

years, I was in the navy, where all were trained to be a firefighter. I am aware of the conflict between the city and firefighters. The fire station is in dispute. As a resident of Boise County, I feel that it is wrong for the city to claim ownership. Idaho City has done nothing but administered the grant because a public entity was required when the firefighters obtained this grant. Without volunteers, our station and fire district would not exist. If the fire district doesn't own the building, it cannot get future grants to continue to maintain and improve. The city cannot afford it, and if the city keeps the building, they will lose volunteers. Hopefully none of us will be trapped or burned because we lose our fire department."

Terry Teeter, Fire Chief, stated, "We need to get together and work this out. We are trying to get a grant to expand the building. If we can work that out it would be fantastic, please support us and speak your piece."

Liz Hastie shared, "My husband and my father are firefighters, I'm coming here with mixed information from both sides. But if the ownership of the building is not the building, but the property, does that solve all the issues?"

Mayor Everhart replied, "That would go a long way towards it, and I am not opposed to that, and

it's going to have to be...again this meeting tonight is to bring out that kind of information. And then we can use it and sit down with the commissioners again and try to work out an agreement. All of us up here have wanted to get to an agreement. We just have not got all that information and come to that point where we can make an agreement. Absolutely, we want.... we have never been opposed to a transfer, it was always...whether it was grant built or anything else, there was a lot of input done just by the city. I can't see my way to abandon all that, and please realize that the city struggles too, we don't have any money to do that kind of stuff. So that's always been part of the equation, don't think we are opposed to making this happen. We just have to get this information and come to an agreement."

Everhart continued, "Talking about grants, I've looked into that. There are grants available for the fire district to pursue a grant to purchase property from the city and then the district itself would not be out of any money. A lot of those are 100% grants, some have a match, but there are those possibilities out there, it wouldn't cost the district anything and it would benefit the city as well. So, think of some of those things to keep in mind as we go through these dis-

cussions."

Dave Woras, former firefighter, said, "I've lived in Idaho City since 1980, but I live just outside the city limits. For years I've been an active member of the fire department, we were in a little building over here. When we were able to get this grant to build this building it was a great deal. All the volunteers stepped up. I did all the survey work, others chipped in and designed. It was a great work and still is. As far as resolving this thing, I kind of like Ashley's approach. I think it should be a compromise. But I'm not a lawyer, I don't understand all the different sides to it, but if it's a compromise that works and it's something that the residents of Idaho City agree on and if it resolves the problem, that would be great. We have that facility, it should stay in Idaho City, we have young volunteers, and it is a great thing. Let's work to make it work."

Mayor Everhart responded, "To touch on that, Dave, we have had that conversation with our attorney and so transfer of property from one entity to another does not require a formal value, it does not require formal advertising. It can be done by meeting and making that agreement. It's as simple as that."

Attorney Callahan stated that a public hearing would be necessary.

Mayor Everhart clarified, "Yes, it would be necessary to have a public hearing, it is not required to be put on the ballot. The council would take that input and decide whether it was the direction they wanted to go or not, make the vote and then the transaction would happen."

Steve Shay thanked the city council and the fire department and said, "I've reviewed minutes and notes, and I am puzzled. Why can't this be an investment back in the community instead of a loss? I understand what the city council is up against and the fire department, but this is an investment back to all of us, this is not a loss, it's a compromise. Try to do this as a compromise, not that you are losing something as a city taxpayer but deal with it as an investment. At the end of the day, I think a simple compromise with reduced value as an investment, versus a sale type of situation. Can the fire department make a payment over a long term back to the agreement? I really don't want to see this as a loss. Make it an investment and positive thing."

Lisa Scarbrough said, "I am a resident of Idaho City, and I don't have a problem with you guys [referring to city council] giving the

property to the fire department. The way I see it, that building, and property is only worth anything to us as a fire department. We are not getting anything out of it in any other way except as a fire department. They don't have that kind of funds, \$127,000.00 obviously Idaho City doesn't have that kind of money either. I just want to say that I don't have a problem with the city just giving it to them."

Ashley Elliott interjected, "I just want to say that the amount of \$127,000.00 came from me because I used to work at the county and I worked with assessment numbers, so it's not a real number."

Pete Scarbrough said, "I don't know a lot about politics or running of a city of any size, but I do know a lot about the fire service. I've been a firefighter for 47 years, including a couple of years here. I think one thing that everyone involved in this discussion needs to think about is, 'what happens if there were no volunteers?' There are lots of studies out there that tell us what it costs to have a paid fire department. We don't have it. So, I think that is one of the overriding factors. Whatever the position of the property, the building and all that is, we need to support the volunteers. Because many years ago there was a big study nationwide, and it showed that the volunteers, man for man and woman for wom-

an, were better trained and better equipped than any paid department. And they did it all on their own efforts and the efforts of their community. I think it behooves both sides of this controversy to keep the fire department, and let's do what is best for all of us. Thank you."

Dave Martin commented, "I've been on the city council, and I am a volunteer firefighter. I want you to know that we are busier now than we have ever been. Maybe a lot of you don't know, but every time the ambulance gets called, so do we. So, we are out there a lot. We have had more calls this year than we have ever had. I really wish you could get this resolved. I've always been a supporter of

the fire department, even when I was on the city council. We need grant money, we're busier than we have ever been, and we are running out of room. We are bursting at the seams, we got trucks parked outside and stacked on one another inside. That's all I have to say: support your volunteers!"

Roger Jackson stated, "I believe that the city had to get the grant, it was turned in by the volunteer fire department, I believe that was the way it went. The City or County had to administer that grant. If I remember right, the grant paid for the land, it came from Dorland [he checked with Barbara Gardner, and she offered another name] OK. However, it's the fire department now, and it's second to none,

It's a great, great asset to Idaho City. We need to keep it going. I think it would be a great thing if you would sit down amongst yourselves and decide this, whatever you have to do. Just don't break them. Because they have done a heck of a good job down there! Thank you."

Mayor Everhart replied, "I agree, as Tom Secor just said, we don't have any intent to break the bank, or the fire district or anything like that, but again we have to deal with the circumstances of our city. So again, we are trying to work all those things into this situation and reach that agreement."

Jerry Abbott shared, as a resident and business owner, "My opinion,

Notice To Control Noxious Weeds - Idaho Code 22-2407. LANDOWNER AND CITIZEN DUTIES. It shall be the duty and responsibility of all landowners to control noxious weeds on their land and property, in accordance with this chapter and with rules promulgated by the director.

- (1) The cost of controlling noxious weeds shall be the obligation of the landowner.
- (2) Noxious weed control must be for prevention, eradication, rehabilitation, control or containment efforts. However, areas may be modified from the eradication requirement if the landowner is a participant in a county-approved weed management plan or county-approved cooperative weed management area.
- (3) The landowner shall reimburse the county control authority for work done because of failure to comply with a five (5) day notice, as outlined in section 22-2405, Idaho Code.
- (4) If an article is infested with noxious weeds, it shall not be moved from designated premises until it is treated in accordance with the applicable rules, or in accordance with the written permission of a control authority.

I think it should be awarded to the fire department. If there are any funds, if they get a grant and they purchase the property or the building. Those funds should be allocated towards the water system, they should be definitely designed for the infrastructure. When we hook up to a fire hydrant and it's not working, we need to take that money and put it toward the infrastructure of the fire system. I don't know if there is a way to designate that? I appreciate you, thank you volunteers."

Bob Quarles said, "I've been a full-time resident up here for 34 years, part-time resident for better than 62 years. Everything we have done in this town has been done by volunteers. This building, built on city property, but it was built by a volunteer group. Huckstead brought this barracks out of Gowen Field and put it in this place, and it's been a community center ever since. The senior center is built on city property, and it was built by grants, and volunteers and by the community, not by the city. It's the same way with the fire department, and if we only get half a fire department we'll be in big trouble! And this city cannot support it. So, I think the fire department needs to get the property and the building and continue on and keep up with the good work that they have been doing. Thank you."

Tanya Hansen shared, "I live outside of town. I've been here for about 10 years now. My feeling is that we need the fire department, and I understand that the city needs money. And I understand that they

need it 'pretty bad.' There's been talk about grants, and personally maybe you need people out there looking for some grants. I don't know how any of that works. Personally, for the fire department, I think a deal should be made very easily, by just giving them the property over, or selling it to them for about one buck or 10 bucks or something like that. Let them do their grant. Obviously, you don't have the people to do it, or something of that sort. Instead of just keeping the money or whatever is going on, it needs to be taken care of in a timely manner. Thank you for letting me speak."

Mitch Twain commented, "I am in the fire department, and I also was involved during the construction of the building. Roger was correct that the city was reimbursed through the grant for the purchase of the property, and they were also reimbursed for the administering of the monies. The fire department paid to have the grant writer get the grant for us. And, when we got the grant, we found out that it had to be a 'city entity' to administer the grant. That was the part the city played, was administering the payments to the labor force which I was a part of and paid for all the materials out of the money in the grant. I did all the paperwork, showed the federal government what was done each week and how many hours we put in. And I kept track of everything and took it over to the City Clerk, who dispersed the monies to the employees from the city. It was the grant money that was paying for that. Secondly, I know that some of you may think

that the establishment of the tax fire district was a 'scare tactic'. Actually, before we even started to get a tax district, Mayor Obland shut down everything except for Idaho City that we were supposed to respond to."

Councilmember Tom Secor responded, "That is false. That never happened. I was on the council at that time, and it was never said that we would not respond outside of the city limits."

Mitch Twain responded with an example where the mayor asked Duquette Pines to pay the city for the fire department to respond. According to Twain, they sent a check to Duquette Pines for over \$8,000 dollars to the city. And a lawyer said that they couldn't do that, and they had to refund the money back to Duquette Pines. Twain added that the mayor told people outside of the city limits that he didn't want the city to respond any longer. He said that was the history of that time.

Twain continued, "The grant was written by a grant writer, it wasn't written by the city, and the city just administered to pay us to use the grant money. In the grant it paid over \$47,000.00 back to the city for their involvement and to pay for the property. I am really glad that we're all here together trying to get this resolved because it's a sore spot between many people on the city council and some of the fire department volunteers; so we can come to an agreement, because we are getting busier, more calls, and it's only going to get worse with more people moving in and expecting services, and if

we can't provide the services, the county will be in trouble legally. We have to resolve this difference and move forward so we can keep up with the expansion that is just happening in just our section of Boise County."

Mitch Twain thanked all who came and said their input was very valuable and he appreciated their time and support.

Mayor Everhart said he wanted to explain the points that Mitch made and respond to Tom Secor Jr.'s comment about scare tactics. Everhart said, "The issue with that mayor, Jim Obland, who as everybody recalls, and this was a large part of it... A recall effort was made, and he was recalled for a lot of his actions that he was doing on his own and not involving the council. Keep that in mind too, the city and the council identified that problem and we made the steps we needed to resolve it and doing that recall and getting him out of that position. He was going around behind and doing things that were very wrong and possibly illegal at times. That is kind of the point that Tom was making about the scare tactic, because that is what the mayor was doing and that was what started the conversation about forming a fire district. It was because of his [Mayor Obland's] actions, it put fear into the people outside of the city that they were

not going to have that fire coverage available, that was never part of the city council's plan at any time."

Someone from the audience asked if the grant involved the paying of the property. The mayor answered, "This was back when the facility was first built, way before my time. I don't have that information. Some of it has been presented tonight. The city did not write the grant, the city was just the administrator of the grant. The fire department had a grant writer who did that part of it. One of the other things that goes along with that is: the grant and the facility and the fire department did fundraisers and those kinds of things, but anything that wasn't paid for, was solely paid for by the residents of Idaho City for twenty years. I don't know the numbers, but the surrounding areas received the benefit of that service, but the city residents were the only ones who were actually taxed for it. In my view that is why we are having this discussion, because the city itself has a vested interest in that and it has some value."

Bobby Matthews, owner of Idaho City Grocery, commented, "I am 100% uneducated how the fire department works, and about 99.9% uneducated as to how the city council works. This is how

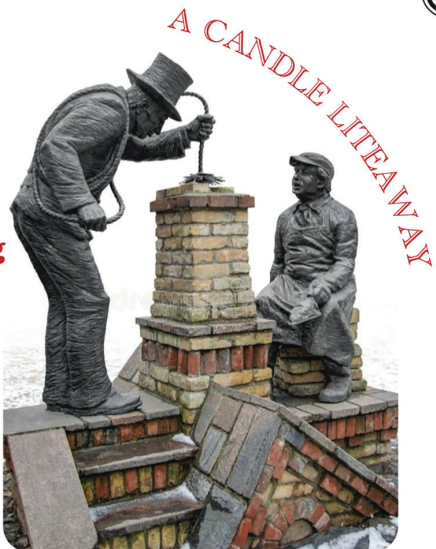

I feel, take the name away. Bill Smith owns this, and Bob Smith owns that. If you want to tear down the market value for a property, I get it, but where does \$1,000.00 a year come from? If you want the market value for a piece of property, why don't you rent it to them now? For \$1,000.00 a year, now hold on, that's 83.00 at 30% a month. So, I think I'm right, for fair market value you are charging them \$83.00 a month. It doesn't add up? That's my two cents."

Mayor Everhart explained, "The \$1,000.00 was for the city, we get it for the ambulance building. We have to rent these out otherwise if someone is in there for a certain length amount of time, they can claim ownership, I don't even know where we came up with the \$1,000.00, but just put a number on it and make it easy for the fire department."

"I neglected to mention the \$1,000.00 earlier, and as to fair market value, we are not even interested in that, we are not going to demand, or sell, or advertise it, we are not expecting that. We just want something that is a fair reimbursement for the city. We have needs just like they do, we have a city shop which is a dilapidated old building, it's uninsulated, you can't even heat it, there isn't even room to pull a piece of equipment in and work on it. All our road equipment sits outside. When we go to use equipment to plow the snow, you have to push the snow off first. We would love to be able to have a shop for our equipment as well. But fair market value? I don't think any of us have been in a position to demand that. We just want to come to a reasonable agreement with the district and then move forward with this. I appreciated all the comments, that was what we hoped to get from you, different opinions, and different views. We can use that to come to an agreement, I'm sure we can come to an agreement."

"Whether it be that the district applies for a grant to be able to purchase that, or the offer was made of \$65,000.00, maybe we can do, or for a few years you may get a little payment once a year. I don't know what all our options are, but we can come to an agreement on this that is beneficial for all of us. That is what I hope to see."

Fire District Clerk Carol Kirkland said, "I've been in and out of Idaho City since 1976, my son Matthew is a volunteer in the fire department along with my daughter Lisa. I was one of those volunteers who helped to move the buildings from the forest service to become an ENT building."

"I have been through 8 years of city council meetings in the last two months. I have never read so many minutes in my life. As I read all of those, several things jumped out at me. One: there was a huge amount of effort from the city and the county, and the volunteer EMTs, and the volunteer

firefighters to try and make things better for our community. To try to get buildings, to try to get grants, to try to make it all happen. I also noticed that not a whole lot of shit happened. It was four years of 'nothing happened.' Then the fire department volunteers got a grant and things started moving. But before that it was all talk and no action. The firefighters, the volunteers, they did the work. They got the grants; they got the volunteer matching funds. They got the equipment, they got people like Neal and Barbara Gardner, who donated hundreds of hours' worth of equipment, labor, and materials. Tag, everybody helped. But what I didn't notice was anything whatsoever from the city. There was no city equipment down there helping, or city employees down there helping. If it was in there it was never recorded, and it may be that it just never got recorded. But there wasn't a squat in there that the city was doing it. There were donations from people who lived in California, Montana, and Idaho. I typed all of it in an excel spreadsheet, and even though I can't recall exact amounts, I was flabbergasted at where we got money donated from. Everybody pitched in, everybody helped, Pete went around with a boot and hit up people on the streets to collect funds to create the fire department. The fire department built the building, that station would not exist if it were up to the city. In 1997, the city asked their employee, Darrell Bridwell, to get bids to build a city shop. There was nine months of discussion over those bids and a 30x50 foot building was going to be built for \$30,000.00. And Darrell brought it up, asking if they could do the flooring this year and building next year. And it died a quiet and painless death. There was nothing ever said again. My husband worked in that city shop back in 1986 and it cannot have improved much since then. The grants were done by the firefighters, the funds were raised by the firefighters, the entire project would not exist without the firefighters, and the volunteers, and the love of this community. We do need to resolve this, we need to resolve this immediately, because we can't keep doing this anymore. We need to pursue and write more grants, and I know just enough about grants to know that if we don't own the building, it's not enough to own the land. The grant paid for the land the first time so the firefighters should own the land already from the grant they got the first time. The station was built with grant money that they got, not the city. All the city did was pay the bills to somebody because a government entity had to do that. The fire district is willing to do what they can to make a compromise, help make a decision, and get it done."

At this point, Jerry Abbott made a pledge to work for 100 hours within this year to help Idaho City build a new shop.

Brent Adamson stated, "The fire department has spent money on this already. I presented all of this to our lawyer, and he said that Idaho City legally owns the fire station. The point of this issue is emotion, and we can't run on emotion. I have a recent agreement between the firefighters and the commissioners that we have a limit that we are willing to talk about. This meeting was brought up by the city council, and I agree with them. We need to hear what you all think. From the standpoint of the firefighters, it should be our building and the title should have been transferred and we shouldn't be paying a thousand a year, I get that but that is not what happened. We have spent money on both sides to come to an agreement. I hope to spend much less money this time. That we simply spend it to get the deal accomplished and do the transfer. That is where we are trying to go, and the city wants to go there too. As the chair of this commission, I guarantee that I will work to get this done without spending a great amount of your taxpayer money."

Mayor Everhart stated that he and the city council have a great appreciation for the volunteer firefighters and all that they do. He thanked everyone for attending and voicing their opinions.

BOISE COUNTY -- Spring is approaching, and we are all getting ready to hit the back roads and trails again in our favorite SXS/UTV/ATV or Motorcycles. There are a lot of different ways to ensure our safety when riding. I will cover two basic tips in this article and in more safety articles to come. The number one focus is the use of hand signals when you meet someone coming towards you and where to be driving on the trail/road. Hand signals are not something required by law, rather they are used to help increase your safety and the safety of others when you are out on your adventures.

Hand Signals Hand signals are used to tell oncoming traffic how many vehicles are in your group. This way they can be careful till the last vehicle passes them. It will let people know how many riders/vehicles are following. If there are three riders/vehicles in the group, the lead person would display two fingers indicating there are two following. The second vehicle would hold up one finger, and the last vehicle would hold up a closed fist. If a rider is holding up 5 fingers it means that there are five or more riders/vehicles following them. These signals should be used whether on a trail, or even a road like Centerville Road.

HORSESHOE BEND -- On March 18th, the communities of Horseshoe Bend and Garden Valley went on high alert as a string of commercial burglaries were committed. In Horseshoe Bend two markets were hit; Huckle & Sage and Ray's Corner Market. Further north on Highway 55, Cascade Raft & Kayak was also broken into as well as a gas station in Garden Valley. The culprits were dubbed the "Flaming Bandits" due to their unique style of breaking and entering. The suspects used a torch to heat up and break the glass doors of the businesses they burglarized. The Boise County Sheriff's Department released pictures of the suspects' vehicle and security camera footage of the pair to solicit tips from the community. According to the department's press release, their efforts paid off and at least one of the "Flaming Bandits" is now in custody thanks to the "diligent efforts of Boise County Detective Sprague and deputies from the Boise County Sheriff's Office (BCSO)" who followed up on community tips to douse the crime spree. On March 23, the BCSO, along with the Boise Police Department, served a search warrant that led to the apprehension of Justin Clayborn. Clayborn is charged in the series of burglaries that targeted the Boise County businesses. Clayborn had recently been paroled prior to this arrest. In their press release the BCSO extended their "deepest gratitude to the community members whose vigilance and willingness to share information played a crucial role in the arrest." Clayborn has been charged with 11 felonies including arson, burglary, and grand theft. A preliminary hearing is set for April 8.

If you are the person leading the group, this should be part of the initial briefing at the beginning of the ride. There are lot of people who see this and just think the person is waving at them when they are making you aware of the size of their group.

The Trail or Road We have all been on our roads, and it seems like there are people who don't realize there are two sides to the road. On our mountain road there is no centerline. Whether we are on a mountain road or trail we must ensure

that, even when going around corners, you must stay completely on your side. Having a head-on collision would not be fun.

According to U.S. Consumer Product Safety Commission on OHV incidents, there were 2,156 deaths in the United States -with 46 of them happening in the State of Idaho- in a three-year period from 2016 to 2020. There is an average of 105,400 Emergency Department treated injuries per year.

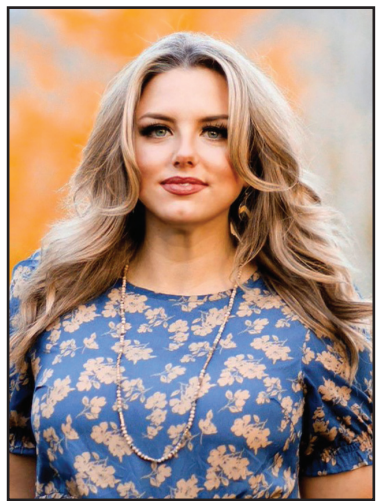

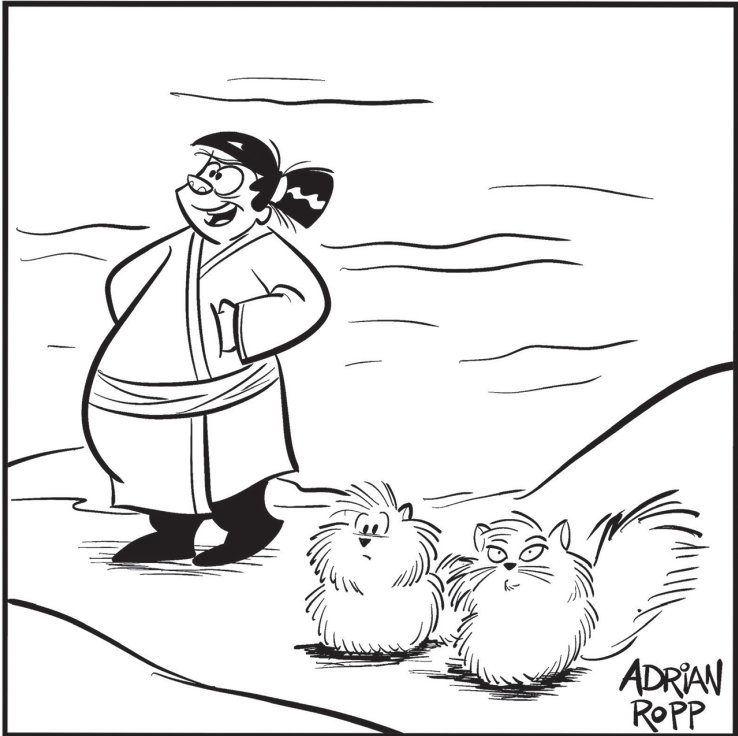

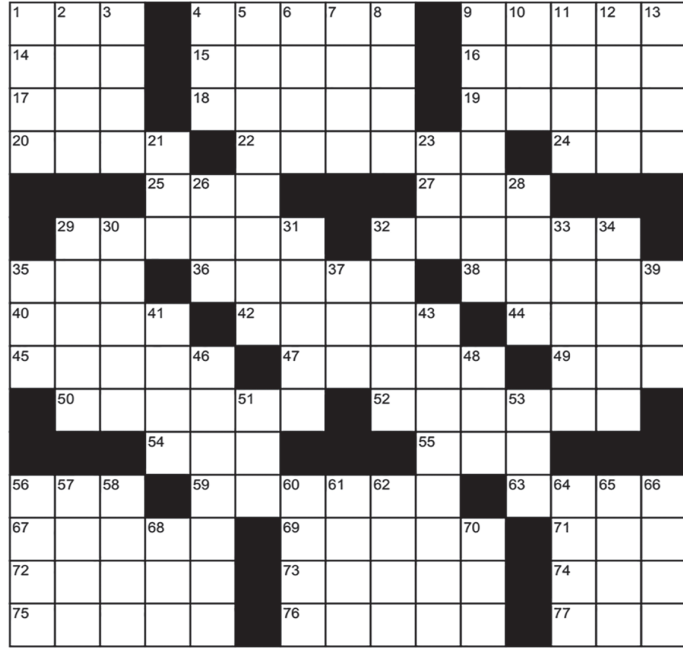

Original State Seal of Idaho from 1891-1957

BOISE COUNTY -- The Idaho state seal was designed by Emma Edwards Green. The First State Legislature created a committee to have a contest in December 1890. They had artists from all over the country that submitted designs for the Idaho State Seal. Emma was born in 1856 to Emma Richard and former Missouri Governor John Cummins Edwards in Stockton, California. In 1890, she stopped in Boise, Idaho to visit friends on her way home from New York and decided to stay. She taught art classes and submitted a design for the state seal competition. The emblem depicts a miner, a woman, and

various Idaho natural resources. Emma was notified by Governor Norman B. Willey, second governor of Idaho, on March 5, 1891, that she had won the contest. She was awarded a prize of \$100. Emma Green passed away in Boise on January 6, 1942. Her original painted artwork of the seal is currently held at the Idaho State Historical Society in Boise. To this date, Idaho is the only state in the United States that had their flag and seal designed by a woman.

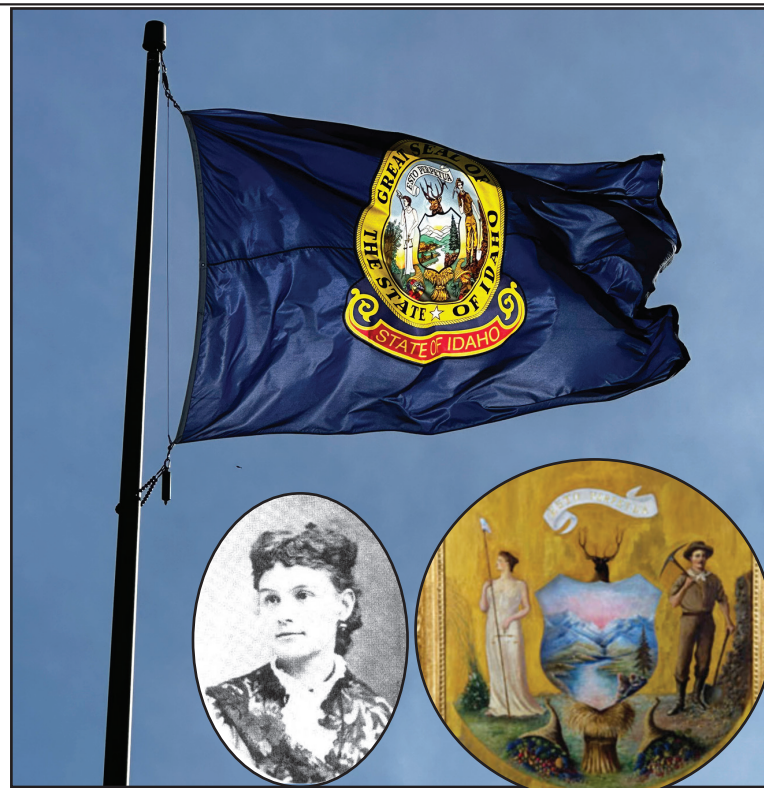
Seal Meaning: The seal depicts a miner and a woman representing equality, liberty, and justice. The symbols in the seal represent the State of Idaho's natural resources,

mining, forests, farmland, and wildlife.

State Motto: On the inner ring of the seal is the state motto in Latin, "ESTO PERPETUA". The translation is, "Let it be Perpetual" or "It is Forever." The motto was adopted in 1891.

Idaho State Flag Adopted: The Idaho state flag was adopted and made official on March 15, 1927.

On behalf of Women's History Month, the *Idaho World* recognizes the accomplishments of Mrs. Emma Edwards Green for being the only woman to design a state seal. It was used until 1957, and currently a modified version is used on the Idaho State flag.

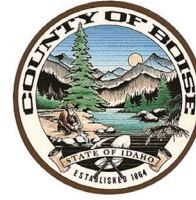

HORSESHOE BEND CITY COUNCIL MEETING

HORSESHOE BEND -- The following is a synopsis of the Horseshoe Bend City Council meeting that was held on Wednesday, March 13, 2023. All councilmembers were present. There were three audience members when the meeting started, but two additional spectators joined after the start of the meeting. Mayor Pat Goff made the call to order at 7:00 p.m. then led the Pledge of Allegiance. After unanimous approval of the agenda, minutes from the previous meeting of February 14 and the authorization to pay the city's bills, Goff opened the meeting with the agenda's new business which included the following;

Gem Grant: For Woods Veteran's Park Master Plan and pump station- City Engineer Amy Woodruff told the council that Horseshoe Bend Valley Chamber of Commerce Lead Kimberly Welsh brought a grant opportunity to the city to help fund new restroom facilities at the park. The 50k grant would help the city start on the comprehensive park master plan. According to Mayor Goff, a park committee will be formed, made up of stakeholders and community members who will have input into the park's master plan. Woodruff said the grant would help pay for the construction of concrete restrooms that will be virtually vandalism proof, plus a pump station to remove waste from the facilities. The Gem Grant would cover both the water and sewer connections needed for the restroom. Councilmember Patti Burgess asked, "Are we responsible for matching it [the grant]?" Woodruff replied in the negative but Horseshoe Bend City Treasurer Terrie Nolan spoke out and said there was a 20% required contribution from the city. Woodruff corrected her original statement and said the 20% buy-in from the city would be provided by labor performed by city staff to install the water and sewer hook ups. Councilmember Martye White asked City Attorney Tony Pantera if he had seen the grant. Pantera said he was getting his first look at it now. Nolan said time was of the essence because the application was due March 18. "This is out of left field, what the hell!" White told the other councilmembers.

Woodruff then said that the Gem grant is available every fiscal quarter and the city could choose to apply at a later date if they weren't comfortable with the time factor. After some discussion and with Pantera stating that there was "no negative to applying," followed by Woodruff telling the council that she agreed things were "moving very fast," but there was "no risk to the city at all" city councilmember Stephen Chartier said "It's worth a try, I think." Nolan said the action item on the agenda regarding the grant was just to notify the city that they were applying for the grant.

Mayor Goff told the council that

if Woodruff was the city's expert on staff and that if the council trusted her judgment, then they should approve the grant application. White asked, "Who comes up with the fees on the last page?" Woodruff said the fees were to pay for a landscape architect to delineate the park's flood plain and would be covered by the grant. Someone on the council asked how the make-up of the park committee would be decided and Mayor Goff said it would be composed of citizens who had a "vested" interest in the park. "It's not a good ol' boys club, if that's what you mean," added Goff. Woodruff said, "Parks aren't so simple to plan, it's going to take some thinking."

Councilmember Jennifer Patterson then motioned to approve submitting an application for the Gem Grant which was seconded by Chartier. The motion carried 3-1 with Burgess dissenting.

Audit Presentation-Kurt Folke from Quest CPAs presented the city audit via Zoom. He started by stating that "The audit did go very well."

He added that the process went smoothly and was completed in a timely manner thanks to Nolan and City Clerk Gina Elmer. There were no findings that the accounting wasn't accurate and he said the city had a good set of internal controls in place. The city has three funds, general, water and sewer. He did say that the numbers in the funds were somewhat "muddied" due to the recent backhoe lease being paid for by all three funds, but only on the books of one fund. The general fund had a positive balance of \$49,210 revenue over expenses. The city also has a \$665,451 operating and capital reserve which equates to an 18-month operating reserve. Both the water and sewer funds experienced losses. Water had a \$30, 475 decrease/loss and sewer was at a \$57,643 decrease/loss. Expenditures were the reasons for the loss but Folkes told the council that was typical for most municipalities last year. Mayor Goff had a short discussion with the council on raising sewer rates to match the water rate increases. Patterson asked if there was a program to help senior citizens pay for increases in water and sewer utility costs. No one knew of any programs available. Folkes said the LGIP's (Local Government Investment Pool) interest rate had increased to 5% and recommended that the city transfer savings to this account to take advantage of the higher interest rate. The council then unanimously approved the audit findings.

Fireworks for the Fourth of July- Mayor Goff said that due to the "huge amount of blowback" the city was going to move the fireworks show back to the Fourth of July. He stated that the city would put in 5K, minus any funds raised by the Optimist Club and the city. Any monies raised or donated to the show will be taken out of the city's donation. The

Horseshoe Bend Valley Chamber of Commerce is donating the \$2,500 worth of fireworks that they received from Big Sky Fireworks. The motion to restore the fireworks show to July 4th was approved unanimously.

USDA Grant- The grant is a facilities grant based on community need and would be used in conjunction with the Gem Grant to fund the construction of restroom facilities at the Woods Veterans Memorial Park. Woodruff did not ask the council for a commitment but stated that she would, possibly by requesting a special meeting later this month to present the council with a "full package proposal."

Department Update: EMS- No official report, Nolan said the department had 11 runs in the previous month. Burgess asked how the city was reimbursed for runs, Nolan said that the city does not receive any reimbursement at this time because they don't have a billing company. Mayor Goff said he sees the city transitioning to an ambulance district in the future in place of the current city run EMS. He told the council, "No matter what we do it's going to be the wrong move and somebody's going to get mad." The city currently has only two EMTs working the service.

Public Works- The department told the council that they were dealing with a little dirty water here and there as well as challenges in water distribution. They have recently changed some things around and have started repairing potholes when the weather permits. The department also reported that the repairs done on the cedar water tower didn't hold and the unit is leaking again so it is not at capacity. Councilmember White asked when backhoe training would begin. He wanted to know why the city was contracting out for backhoe work when they have a \$150k backhoe not being used. He was told that training would start soon.

City Engineer- Woodruff reported that the emerging contaminants project was finalizing construction numbers and the loan application. Deer Valley project was approaching final plat approval for Phase 1, just a few minor issues remained and she will be meeting with the developer sometime in April, building permits should be pulled soon after. She said the developer is currently planning on pulling 5-10 building permits at a time. The developer

has also submitted plans for Phase 2 of the community.

City Attorney- Pantera told the council that he is currently working on the Deer Valley Development agreement as well as working on the HUD resolution. He has not received a reply for ITD on any obligation the city may have for the bridge.

Mayor- Goff said, "I don't have

anything to report." The council discussed going into executive session but decided it was not needed. The meeting adjourned at 7:54 p.m.
