Memorial Day's History, Tradition, and Weilmunster Park

GARDEN VALLEY -- On Memorial Day, May 27th, Weilmunster Park hosted the annual flag ceremony and dedication of the last twenty-two bricks that went into the Wall. The Wall is now complete, with 396 bricks donated by family and friends who are honoring their service members. The American flag was at half-mast from sunup until noon, as is the tradition. Veteran Bob Seal emceed the proceedings, starting with the Pledge of Allegiance, then recognizing the local five Gold Star Families, dedications of each new brick, and finally Veteran Phil Arnold reading the poem WE REMEMBER by an unknow author (edited by Veteran Cathy Garner). Taps was then played and there were several tears shed during this touching moment. Over 75 people were in attendance.

Another special reading was done by Cari Severance. Severance shared a poem written by her mother-in-law's family, a Gold Star family, after the loss of her two brothers during their military service. It read:

G.I. JOE

Lost in the middle of nowhere,

Korea is the spot.
We're doomed to serve our time
In the land that God forgot.

Down with the Chinese and buzzards,
Down where the man gets blue,
Down in the middle of nowhere,
Seven thousand miles from you.

You sweat, you freeze and shiver and swear,
It's more than a man can stand.
We are not a bunch of convicts,
We are defenders of our land.

We are soldiers of the First Cavalry,
Earning our measly pay,
Guarding the people with millions
For two and a half a day.

Staying here with only our memories,
Waiting to see our gals,
Hoping that while we're away
They haven't married our pals.

Few people know we are living,
Few people give a damn.
Although we are not forgotten.
We belong to Uncle Sam.

But when we go to Heaven,

BOISE COUNTY -- Each year, Memorial Day arrives again as a special day on which we in the United States honor those that gave all for their country. It is the day we honor those who died in Military service for their country. Since 1775 over 600,000 have given their life while in service. As such, Memorial Day is regarded as one of the most solemn days of the year.

The tradition of Memorial

Day began when Major General John A. Logan established Decoration Day on May 5th, 1868, to be observed on May 30th. The day commemorated the sacrifices of the Civil War soldiers. James Garfield was the first president to speak on Decoration Day at Arlington National Cemetery in 1868. Decoration Day was honored every year after that until Congress passed the Uniform Monday Holiday Act in 1968. It was put into law that Memorial Day would be the last Monday of May and be honored as a federal holiday.

Since then, family traditions have sprung up to take place over the Memorial Day weekend. Towns and cities have parades, many in Idaho see it as the start of camping season, while others hold BBQs or visit grave sites of loved ones that have passed on.

Throughout the United States, on Memorial Day, flags are flown at half-staff from sunrise until noon. The day is also represented by the wearing of a red poppy flower and by placing flags on veterans' gravesites. Wearing the red poppy became a tradition following WWI. It symbolized both remembrance and hope for future peace. The flag com-

memorates and honors those who have fallen for our country. Most cemeteries, or fellow veterans, place flags on the grave sites marked as veterans.

One of the best lesser-known traditions is the practice of placing coins on the grave markers of veterans. If you find a coin on a grave marker, there is a reason behind its placement. This means someone has visited the grave. Anyone can honor a veteran in this way. You may find either a penny, nickel, dime, or quarter. The most common coin left is a penny. A quarter has the greatest significance, as it is left by someone who was physically with the service member when they died. A nickel signifies that the visitor served with the deceased service member in boot camp. The dime means the visitor and deceased service member served together at some point.

Memorial Day is a holiday set aside to spend time together and remember those soldiers that have fallen. If you are in Boise County, there are several historic places to visit, related to the lives of veterans: Idaho City's Pioneer Cemetery, Garden Valley's Veterans Memorial Wall at Weilmunster Park, and Horseshoe Bend's Veterans Memorial and Wall of Heroes.

Garden Valley High School Grads

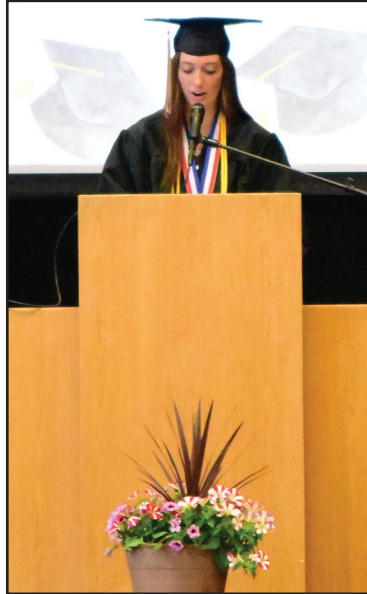
