Veterans Ceremoniously Honor American Flags

EAST BOISE COUNTY -- In honor of Flag Day, Veterans of Foreign Wars Post 142 held an annual ceremony to honorably retire American flags on June 15th. The Creekside Campground graciously allowed the ceremony to proceed on their beautiful grounds. The owner, Gayle Strack, helped her father Bill, a survivor from WWII, to also attend on this cool Saturday afternoon among the pine trees and nearby Mores Creek.

Post Commander Jim White explained, "During the course

of the year, we encourage people, with the help of our *Idaho World*, to remind people periodically to bring their tattered and worn flags to the Sheriff's Department." With sincere thanks, a good number of American flags had been received from the Boise County community. As part of the retirement ceremony, CDR White offered these words to all those who were reverently gathered, "Today we honor a symbol of our American freedoms, the American flag, as we retire her from duty. As long as

Americans cherish liberty more than life itself, the stars and stripes shall continue to be the enduring banner of the United States of America. Look at her with renewed allegiance, honor her, respect her, and defend her."

Chaplain Dave Dahlen was then asked to offer the invocation and he uttered these words in prayer: "Almighty Father, we thank thee for our country and its flag, and for the liberty for which it stands. To clean with a purging flame, we commit these flags, worn out in

worthy service. As they yield their substance to the fire, may thy holy light spread over us

and bring to our hearts renewed devotion to God and Country. Amen."

Freedom Fight Night Canceled



HORSESHOE BEND -- The Horseshoe Bend Valley Chamber sent out a press release on Monday, June 17th, explaining that the Freedom Fight Night has been regrettably postponed indefinitely. The event had been scheduled for June 29th in Horseshoe Bend and proceeds were to go to support the Veterans Memorial Park. The decision came on the heels of being informed by the State Division of Occupational Professional Licenses

of the requirement that each of the participating novice fighters obtain licenses. The press release read, "Freedom Fight Night was established as a non-sanctioned exhibition event specifically to provide a platform for young novice fighters to experience live competitive bouts and determine their interest in pursuing fighting as a sport. The Chamber is disappointed by the necessity of this decision. We firmly believe in the value of Freedom Fight Night as a developmental opportunity for aspiring fighters in our community." All tickets for the June 29th event will be refunded.

The Chamber will explore other options to restructure the non-sanctioned event and will release updates on their website, FreedomFightNight.org

Present: Commissioners Clay Tucker and Lindy Lindstrom

Absent: Commissioner Steven Twilegar

Pledge of Allegiance

STATEMENT: Prosecutor Alex Sosa provided a statement for the record. Sosa said that under Idaho Law he has a strict duty to ensure that open meeting laws are complied with and discussed the possibility of violations. The agenda should be posted 48-hours in advance, but the Boise County meeting agenda was not posted on the website for this meeting. However, the notice of the meeting was posted. Sosa explained, "Because we do not have an agenda that lays out certain decisions that could become final from the board, I do not feel it's appropriate that the board take any final decision today." He said that they could take public comments and participate in executive session, but just not make any final decisions during this meeting.

CONSTITUENT INPUT: Jamie Anderson of Garden Valley spoke about the "Move it" group and said, "we're circulating petitions, calling for an election to move the county seat and we specify in that petition that we want to move it from Idaho City to Horseshoe Bend." She said it would require a two-thirds vote in order to pass. She said there were expenditures approved for \$56,000 of geo-technical work, "and as a taxpayer, I think that I deserve a little more information." Chairman Tucker replied, "I'm not 100% sure what I can or cannot say right now." He asked if the prosecutor had anything to add and then said, "I'll say that we're very preliminarily looking at some new properties to build, possibly a new building for county offices. But as far as that, it's very preliminary right now."

Prosecutor Sosa said, "It is an appropriate executive session item. When there are discussions to acquire an interest in real property not owned by the public agency, the board certainly has that authority." He said it was a fact that the discussion was preliminary and has not taken a significant approach.

Anderson said that this was the sixth time that this effort has been tried to move the county seat, dating back to the 1800s.

Jayne J. shared concerns that the commissioners were not sharing information with the public, and meeting in what could be misconstrued as a "conspiracy" or a "secret" plan in executive session.

Craig W. with the Garden Valley Chamber of Commerce asked for a road closure for the 4th of July. The soapbox derby will go from the library, down Old Crouch Road, and then to the park. He asked that the Old Crouch Road be closed for four hours, 12 noon to 4pm. He also asked that the parade route be closed from the river pond campground, down to the intersection of Middlefork and Old Crouch Road, from 5:45pm to 7pm. Tucker reminded the representative that they couldn't make any decisions, but thanked him for coming in.

EXECUTIVE SESSION: Prosecutor Sosa recommended going into executive session to discuss a personnel issue. Chairman Tucker added for the audience, "Before we do that, I apologize to everybody, we messed up. That happens, sorry." He then motioned to go into executive session. [Time 9:15am to 11:27am] Coming back into session, Tucker said, "No action required."

EXECUTIVE SESSION: Chairman Tucker motioned to go back into executive session to discuss pending litigation. [Time 11:27am to 12:29pm] No action required.

EXECUTIVE SESSION: Tucker then motioned again to go into executive session for a discussion of "acquiring real property." [Time 12:29pm to 12:47pm] No action required.

Adjourned at 12:47.

June 11, 2024

FIRST HOUR OF MEETING WAS ACCIDENTALLY NOT RECORDED. During which time, Chairman Tucker read the resignation letter from Commissioner Steven Twilegar.

It is with great consternation that I am compelled to resign my position of Boise County Commissioner, effective today May 30, 2024.

I can't begin to adequately express the depth of my gratitude towards the citizens of Boise County, other elected of-

icials, and county employees. You've backed my play at every turn, even when it wasn't popular.

Thank you to my family and friends for tolerating me while I navigated the difficult decisions that had to be made with hours and hours of consultation with lawyers and trusted advisors. I am a better person for having served you.

Personal circumstances, specifically my work situation, have caused me to seek and accept employment with extensive travel involved. It was my intention to phone in remotely to meetings. It seems, however, that my management duties limit my availability to do so. My commitment to provide for my family is paramount in this decision and I'm happy to make it. God, family, country (not government, but COUNTRY) every time.

I am absolutely confident that I am leaving the county in very capable hands.

Commissioners Tucker and Lindstrom are, not only generational natives, but both are honest, hardworking, and intelligent.

My hope is that the county will get behind them and support their efforts. Believe me, you will need unwavering leadership to navigate what is coming.

I am going to miss the convoluted conversations over a glass of whiskey and the constant jackhammer beatings over the head about road conditions while 35 miles south, they have 100% paved roads, a commie for a mayor, and all the taxes a feller could ever want to pay!

On a serious note, I implore residents of Boise County to be grateful for the community that has embraced you. To new residents, please don't bring the cancer of perpetual victimhood, personal entitlement, and "woke" politics here. No one gives a damn about your pronouns. We love God, Guns, and Freedom. AMBULANCE: Commissioner Tucker motioned to sign a title for the ambulance, so that East Boise County Ambulance becomes the owner for Unit 15 ambulance.

Alex Gross gave an update on the proposed ambulance redistricting, "We had enough signatures on our petition to do redistricting within one day of starting to get signatures." They are moving forward with redistricting and have spoken with Idaho City and Placerville about the dissolution of the district, for the new taxing district. Mari Adams said in speaking with people, "they just didn't understand where the ambulance was, the fact that they're not essential and what the state was. So now it's getting out there and people are very, very supportive. I'm very appreciative of that."

PUBLIC HEARING: Mr. Gross addressed that there were some email problems that the county encountered and that public comments may not have been received. They agreed to table the hearing for the following week. Chairman Tucker opened the public hearing for Harris Creek Heights and then tabled the hearing through a motion. Motion carried.

EXECUTIVE SESSION: Clerk Mary Prisco said there were "a number of things" to discuss regarding personnel issues. Chairman Tucker

motioned to go into executive session under personnel. [Time 10:09am to 10:40am] No action required.

SOUTH IDAHO SHERIFF'S STEWARDSHIP COORDINATOR: Brian Davis spoke about some "proposed modifications" to the Good Neighbor Authority Agreement. They will need to update the new person in Boise County who will be serving in the capacity as emergency coordinator. They will update the funds and start date of that person.

EXECUTIVE SESSION: [Time 10:59am to 11:47am] The board motioned to go into executive session for a personnel issue(s). Coming out of executive session, Sheriff Scott Turner asked to make a statement. Sheriff Turner spoke in regards to the "kinds and levels chart" presented before the board of his five different "sworn positions" in his department and the ten employees that it would affect. He asked that the numbers highlighted in red be put into effect starting with the pay period of June 16th. "The purpose being

to, not only for public safety purposes, but for retention and hiring purposes," the sheriff said. Commissioner Lindstrom said he thought this was necessary "to get good employees." Chairman Tucker added, "Going into the summer with less deputies than we currently have, and doing anything we can do to retain all of the deputies is very necessary. I think we owe it to residents of the county to do what we think is right here and get this done, so we don't lose any more deputies, along with retaining and hiring. To keep the situation in hand as possible." Lindstrom

added, "And to retain employees, instead of hiring new, saves the county lots of money in training."

Chairman Tucker spoke about other changes to the "kinds and levels chart," including adding the HR part-time director position. He then motioned, "to update the kinds and levels chart, effective June 16th, 2024." The motion carried.

Tucker then motioned to approve a resolution to increase the Boise County general fund budget to budget for their HR position. Clerk Prisco said it would cover a total of 520 hours and they were using the "contingency account for the general fund." The motion to adopt the resolution carried.

EXECUTIVE SESSION: Tucker motioned to go into ex-

ecutive session to discuss risk management. [Time 11:57am to 12:22pm] Coming out of executive session, there was no action required.

CONSTITUENT INPUT: Alex S. with Torch Fire spoke regarding a contract with the Boise County Forester and work done on private land to reduce fire fuel. Chairman Tucker offered to contact their attorney and learn the specific details of the contract. He encouraged Alex S. to return for next week's meeting.

Future agenda items included reaching out to Garden Valley Chamber regarding road closures, time with Alex S., and to continue with the public hearing that needed to be rescheduled.

Adjourned until June 18th.

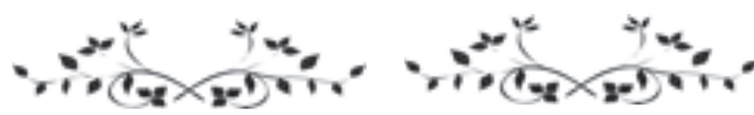

City Council Meeting in Idaho City

IDAHO CITY -- The regular City Council meeting was held June 12, 2024. After the City Council approved the minutes, the Council accepted and approved the Idaho City event checklist for the 4th of July. The Idaho City Fire Protection District will sponsor this celebration and organize a parade down Main Street and Montgomery Street from 12:00 p.m. to 3:30 p.m. In the evening, there will be fireworks at the Idaho City High School football field from 8:30 p.m. to midnight.

The next item that the Council discussed involved the Idaho City Fire protection district action item. The Idaho City Fire protection district presented Mayor Everhart with a letter:

June 12, 2024

Dear Mayor and Council,

We have discussed the firehouse for a few years and the Fire Protection District feels that we have come to an understanding of the taxpayers' desires. We have made two offers based on conversations with firefighters and the taxpayers of Idaho City. Both of those have been flatly rejected.

In a desire to complete this transfer we present this as our offer:

The City of Idaho City will transfer the deeds to the property that the firehouse is currently utilizing.

The Idaho City Fire Protection District will pay \$50,000.00 in cash, provide any easements needed to access City wells, and pay for legal expenses to draw up the necessary papers.

Mayor Everhart said, "Thank you for the written offer, our next step will be to discuss this in an executive session with council, which we have on our agenda, at this point, thank you, I don't feel that there is any other need for a discussion. This has been discussed and discussed, so at this point it would be best for us to leave and go into executive session. So, thank you."

Councilmember Elliott quoted the section to go into executive session and the City Council members, Mayor, and Attorney, Joan Callahan, left the meeting.

After returning to the meeting, Mayor Everhart stated: "We will return to our regular Council meeting at this time. Councilmember Elliott made a

motion to authorize the mayor to propose a letter. This motion was seconded by each of the other council members."

The mayor said, "so we will be having our attorney prepare a letter which will be sent out to your commissioners and this will be soon."

The meeting continued to agreeing to participate in a new Ambulance District. The Mayor and City Council consented to participate in the new proposed ambulance service district and to dissolve the East Boise County Ambulance District.

A resolution of the City Council was approved to authorize the disposition of surplus personal property from an online auction. This involves a 2000 Ford Expedition and a 2011 Ford Explorer which were used by the Idaho City Law Enforcement Department.

The City Council authorized the mayor to enter into an agreement with Boise County for services related to its building code. This includes inspections, planning, reviewing of all construction, improvements, extensions, or alterations of buildings, for residents or structures under the City's jurisdiction.

The Cowboy Campground's owner, Sabrina Amidon, was given approval for the water and sewer service connection.

Kent S. Lamberson
1938 - 2023

Kent S. Lamberson, 85, passed away at home on November 30, 2023, after battling long-term medical conditions. He was born in Boise, Idaho on June 7, 1938 to Leland C. and Helen L. Lamberson. They moved to Ogden, Utah in 1942 while his dad worked in an arms production plant during the war. At war's end in 1945, they moved to Idaho Falls, living there until October 1954 when the family moved back to Boise.

Kent finished school at Boise High in 1956 and joined the Idaho Air National Guard. In

1958 he trained with, and later transferred to, the U.S. Army Reserve to join the newly-established 301st Detachment of the 17th Special Forces Group (ABN). During his five-year tour, he became Jump and Jumpmaster qualified, Special Forces qualified, earned the rank of SFC E7, attended OCS, and was responsible for many field training exercises. The Detachment was disbanded in June 1964; having met his military obligation, Kent chose to accept an Honorable Discharge. He then attended Boise Junior College and enjoyed a career through 1969 as a designer of signs and storefronts, after which he engaged in the business of interior design and contract furnishing.

Kent had four children from two previous marriages and then in 1978 he married Alice, who had three children. After 14 years of city life, Kent and Alice moved to the mountains northwest of Idaho City where they enjoyed hosting visitors, exploring the back roads on their ATV, befriending critters,

and photographing scenery. In 1992, they opened "Morning-side of the Mountain" art gallery, located on Main Street in Idaho City, featuring Kent's carefully cultivated sketches and fine art paintings. He was also a published cartoonist and book illustrator.

Highway 55 Upcoming Road Projects this Summer

Drivers urged to plan ahead as several projects set to kick off on SH-55

BOISE COUNTY – Idaho drivers are urged to plan ahead when traveling north of Eagle this summer as the Idaho Transportation Department (ITD) is advancing several projects along State Highway 55. These projects include lane closures and reduced speeds in various locations between Eagle and New Meadows.

“Each of these projects is intended to improve traffic flow and safety along this regional route. We look forward to a safer, smoother State Highway 55 after these projects are complete,” District 3 Engineer Ja-

son Brinkman said.

The projects include:
Little Goose Creek Bridge (Construction: June 2024 – late 2024)

ITD will begin replacing the Little Goose Creek Bridge today along SH-55 near Last Chance Campground in New Meadows. SH-55 will be reduced to one lane in the area with flaggers and a traffic signal during construction. Drivers should expect delays.

SH-55 Smiths Ferry to New Meadows chip seal (Construction: July 2024 – fall 2024)

This July ITD will start applying a chip seal to several areas of SH-55 between Smiths Ferry and New Meadows. This

project will extend the life of the pavement. The highway will be reduced to one lane with pilot cars where crews are working. Drivers should expect delays. In order to see where crews are working, travelers should sign up for updates on the [project website](#).

Rainbow Bridge (Design: 2024-2026)

ITD is currently conducting soil and rock sampling in the area of the Rainbow Bridge for a project to build a new bridge over the North Fork of the Payette River in Valley County. Drivers can expect 15-minute delays on weekdays in June.

SH-55 DMS Sign (Construction: fall 2024)

ITD will install a dynamic message sign on SH-55 between Round Valley and Cas-

cade. The new message board will notify motorists of detours or incidents along SH-55. Minimal delays expected. Any traffic impacts during the installation will be posted at [511.idaho.gov](#).

SH-55 Banks-Lowman Road Intersection (summer 2024)

Flaggers will direct traffic at the Banks-Lowman intersection on all Sundays in July. The project team is planning to install an interim traffic signal at the busy intersection later this year.

SH-55 Fleming Creek Bridge Replacement (Construction: fall 2024 – late 2025)

This fall ITD will begin replacing the Fleming Creek Bridge on SH-55 approximate-

ly four miles south of Banks. SH-55 will be reduced to one lane in the work zone with speed limit reductions during the week.

SH-55 State Street to Horseshoe Bend Rehabilitation (Construction: fall 2023 – fall 2024)

ITD is milling and resurfacing SH-55 between State Street in Eagle and Horseshoe Bend. Work is expected to be complete this fall. Details are available on the [project website](#). Drivers are encouraged to slow down in the work zone as there have been too many close calls with flaggers.
