Property of the Idaho City Firehouse

IDAHO CITY -- Recently, a letter of response was prepared and delivered to the fire district on behalf of the City of Idaho City concerning the future ownership of the firehouse located on Highway 21. The Idaho City Fire Protection District had offered to pay \$50,000 for the building they believe should rightfully be theirs through a grant co-awarded with the city years ago. However, the city states that it has been collecting taxes on the building from its citizens, and therefore the building belongs to the city. Mayor Kenny Everhart was quoted saying at a special community meeting on March 20th, “I believe one of the biggest responsibilities I have is to oversee and take care of the assets that Idaho City has. I always believed and still do that the facility down there belongs to Idaho City.”

The letter directed to the fire district, addressed from the city's attorney, stated: “One thing is clear from the prior communications between the parties; there are tensions on both sides of this matter. Neither side feels its past contributions are fully appreciated or accounted for by the other. And, dwelling on past resentments has proven to be unproductive and not in the best interest of anyone. We suggest we set all that aside because we will never agree on the past. The fact remains that there is



no dispute that the City owns the firehouse property and the District has a vision to improve the property. Therefore, we should focus on finding realistic solutions that can help accomplish the District's goals and that are not detrimental to the City.”

The city has agreed to continue to work with the district to help meet improvement goals on the property. The attorney went on to say, “We appreciate that the District has come to the table with an offer of \$50,000 plus legal drafting expenses. The City cannot accept that offer. However, the City is willing to sell the firehouse property to the District for \$350,000.00. This represents half of the assessed value

of the property as estimated by the Boise County Assessor. We believe this is a fair offer, well below fair market value, that recognizes that the City Council and Mayor must be good stewards of the City's assets and the City and District have some shared interests.” The letter also indicated that there may be additional grants that the district could apply for to help purchase the firehouse property.

The letter concluded, “We feel confident that the parties will be able to reach an agreement regarding this matter.” The topic of the firehouse was not placed on the agenda for discussion on the Wednesday, July 10th, regular city council meeting.

New Commissioner is Sworn into Office



BOISE COUNTY -- Bob Callahan was chosen to serve out the remainder of the term held by Commissioner Steven Twilegar. Idaho Governor Brad Little met with Callahan on Monday, July 1st, for an interview prior to making his selection from three candidates.

Boise County's District 1 Commissioner Steve Twilegar officially resigned his position effective June 11, 2024. The Boise County Republican Central Committee Chair Jean Mollenkopf held a Special Meeting on Tuesday, June 18, 2024 to address the resignation, and according to Idaho State Statute, Resignations and Vacancies, the BCRCC in turn hand-delivered a letter to Governor Little on June 20, 2024, which listed the three top candidates from the Boise County May election. Callahan won the Boise County Commissioner District 1 seat by 50.17% of the votes in the Primary Election.

Callahan was sworn into office during the Boise County Commissioners' regular meeting held on Tuesday, July 9th. His term will extend for a period of two years. According to Boise County Elections Department's Valerie Dresslar, the election term begins in January and ends December 31st.

Present: Commissioners Clay Tucker and Lindy Lindstrom

Pledge of Allegiance

Chairman Tucker said, "I was hoping to swear in a new commissioner, but I do not think they are ready yet." [The swearing in of Commissioner Bob Callahan was held on Tuesday, July 9th.]

CONSTITUENT INPUT: None

MINUTES: Chairman Tucker motioned to approve the minutes from June 25th. The motion carried.

ROAD AND BRIDGE: Commissioner Tucker motioned to accept a payroll addition for an administrative addition. The motion passed.

VOTING MACHINES: Clerk Mary Prisco presented a sales order for two additional voting machines, acquired through a grant from the Help America Vote Act. They require a two-year service agreement, said Prosecutor Alex Sosa. Prisco said that the manufacturer will visit and service the machines prior to the elections. Chairman Tucker motioned to accept the order for two new express voting systems in the amount of \$7,900. Commissioner Lindstrom seconded the motion and the motion carried.

ROBIE CREEK FIRE PROTECTION DISTRICT: Tucker motioned to approve the order dividing the Robie Creek Fire Protection District into three zones. The motion carried.

SNOW GROOMER: Chairman Tucker motioned to accept the grant award for the

Idaho City Snowmobile Program, for snow groomer facility upgrades and repairs. He motioned for a second grant award for the snow plow. Clerk Prisco shared her congratulations for the receipt of the grant and commented that an enormous amount of work went into securing this grant for Idaho City.

CENTRAL DISTRICT HEALTH: CDH sent a letter to the board to commit Commissioner Clay Tucker for five years to serve on their board. Lindstrom had declined the opportunity, so Tucker accepted the position.

LIQUOR PERMIT: A motion was said to approve a liquor catering permit and the motion carried.

FIRE ALARM: A motion was said to approve a demand warrant for "fire alarm monitoring" in the Miner's Exchange Building in the amount of \$432.60.

EAST BOISE COUNTY AMBULANCE DISTRICT: Mari Adams presented a potential service contract through T-Mobile. If T-Mobile finalizes their contract with Starlink, their service will offer the ability to call from anywhere, at zero cost to the ambulance. Commissioner Tucker motioned to accept the addendum "connecting heroes" with T-Mobile. The motion carried.

Clerk Prisco announced that the signatures for the petition were received for the "dissolution of EBCAD and the creation of the new district... We have more than enough signatures on that." A public hearing date will be scheduled at next week's meeting.

PROPERTY EXEMPT: An

application for a tax-exempt property was received, and the prosecutor read the statute by which he recommended that the board accept exemptions going forward. A motion was said to accept the exemption conditioned on the achievement of the intended qualifications stated in the application.

BOARD OF EQUALIZATION: A hearing was held and Assessor Juszcak was sworn in along with the individual opposing the decision. A property value was opposed in Horseshoe Bend because it was highly valued. The property owner said it would equate to \$536 a foot and was appealing this assessed value for a commercial property as a restaurant and bar. It was difficult to find a comparable property in Horseshoe Bend. An individual from the assessor's office said that all the properties comparable sold above market value, "We by law have to follow and fall in line with [market value] and we were out of compliance. And we had to adjust those commercial properties within Horseshoe Bend." She said that Boise County needed to adjust those sales from two years ago, or the state would come in and change the assessed values. The individual responded, "You don't go from an appraisal at \$435,000 in 2021 on the building to \$2 million dollars three years later on a business." Assessor Juszcak said, "If he's willing to provide his income and you guys are willing to table the decision to later on this afternoon, we can work it... We're always open to that information." The owner offered to provide that information and

the discussion was tabled.

Another individual had bought a home in October 2023 and the home is now assessed at \$113,000 more than the purchased and assessed value cost of \$675,000. He said he couldn't sell the house now at the higher cost in Garden Valley. Justification, costs per acre, and other comparable properties to set appraisals were discussed by the assessor's office staff. Chairman Tucker motioned to sustain the assessor's value. The motion carried and Tucker thanked the individual for coming in.

Another representative for a property owner came in and testimony was heard on both sides, but the assessor's values were sustained by a motion. An individual was provided with some accommodations for a disability to contest the assessed prices of parcels of land. Written testimony was provided by the assessor's office and the individual. New evidence was provided; however, a motion was said to sustain the assessor's values.

An additional property was discussed for a mobile home in Lowman and the assessor's office recommended a change in

their assessed value. A motion was said to change the mobile-manufactured home's assessed value. The motion carried.

Several other representatives presented evidence on their properties, in person and in writing, and each were motioned to sustain the assessor's values. There was an additional geothermal lot that was assessed, and the assessor's office said that on average they sell for about \$50,000 more per lot of land.

The first individual provided his profit and loss statements to the county and it was reviewed by the state of Idaho. There were compliance requirements and concerns, and an adjustment on the building's size, which the county said would bring the assessed amount with the land down to \$1,519,251. The individual contested that this price was still not market value. Chairman Tucker motioned to accept the corrected assessor's value and the motion carried.

There were also assessed changes because of a shed that were removed from a property through a motion by the board of commissioners.

Adjourned at 3:23 pm.

AMERICAN INDEPENDENCE DAY HISTORY

BOISE COUNTY -- There were three landmark moments in the journey our country undertook to gain our Independence from Britain and establish our freedoms. The first was our declaration of independence from Britain and our victory in the Revolutionary War. The second was the writing and ratifying of the United States Constitution. The third moment came with the writing and amending of the Constitution to include the Bill of Rights.

On July 4, 1776, the Continental Congress adopted the Declaration of Independence. This separated the thirteen colonies from Great Britain, establishing the United States of America. One of the primary reasons for the Declaration of Independence was the colonies' will to self-govern and escape the king's high taxes. This

set off a chain reaction that made the United States what it is today.

Our founding fathers declared war against Great Britain, which led to the establishment of an Army and Navy, development of an initial form of government, and the formation of alliances to support the U.S. against Great Britain. George Washington was appointed the Commander of the Continental Army. The war claimed 25,000 to 70,000 soldiers' lives. Though historians cannot agree on the number, some soldiers were killed in battle, more were killed from disease, and many died in British POW (prisoner of war) camps. These soldiers, along with many others, fought for the freedoms we have today.

Finally, there came a victory in October of 1781. The Revolutionary War formally ended with the signing of the

Treaty of Paris on September 3, 1783. All British troops left the United States by November 25, 1783.

After the war, the Continental Congress wanted to keep the thirteen colonies united and form a government and freedoms that would withstand time. They wrote the U.S. Constitution. Thomas Jefferson was the main drafter for the Constitution, which laid out our federal republic form of government and established the three branches of the government and how they were to operate. This was to ensure our people would be represented by elected representatives and an elected leader. The Constitution also established a division of power between the three branches of government. The Constitution was ratified and signed on September 17, 1787.

In the summer of 1789, members of Congress met


with the goal to ensure that the people would always have certain rights and freedoms and a way to keep the government in check. They formed the Bill of Rights, which contained the first ten amendments to our Constitution. The Bill of Rights was passed by the House and the Senate in September of 1789 and ratified by all states on Dec 15, 1791.

To this day, the Bill of Rights is in place, and through it we have certain protected rights and freedoms, with the ability to respond to governmental abuses of powers. Our Constitution and Bill of Rights are unique compared to any country in the world. We have been able to keep these rights in place due to the efforts of the American people.

The Fourth of July is the most celebrated holiday in America, because of the sacrifices that our people have made

over time. On June 28, 1870, Congress passed a law making Independence Day a federal holiday. Many Americans celebrate July 4th with BBQs, fireworks, and camping trips. This July, consider celebrating by obtaining a copy of the Declaration of Independence and reading it with your family.

IDAHO CITY -- As people flock into Idaho City to enjoy the town, they search out historical sites to explore. Thanks to the Idaho City Historical Foundation, folks can learn and appreciate more about our buildings and history. The ICHF is a non-profit organization that was created in 1958 to "restore, preserve, and interpret the history of the Boise Basin" It started with the Boise Basin Museum and has grown over the years into three museums, four parks, one garden, and six additional historic buildings.

This year, on weekends and on the 4th of July, marked the first time that all three of the museums were open to visitors and locals.

The Boise Basin Museum, located at the corner of Wall and Montgomery, is open daily from Memorial Day to Labor Day.
