# **Boise County Delegates Attend Republican National Convention**

**BOISE COUNTY** -- Idaho's Republican Party was well represented at the RNC in Milwaukee, WI where we took 32 voting delegates and 32 alternates to the RNC. Boise County was represented by Jean Mollenkopf Moore (voting delegate), Steve Moore (alternate delegate) and Thelma Medina (alternate delegate) selected by the IDGOP to attend.

A Welcome Reception was held by the RNC at the Henry Maier Festival Park in Milwaukee, WI. Words cannot describe the amazing selection of food and beverages. Entertainment for the evening was Trace Atkins. Idaho's delegation attended this festive evening.

The 2024 RNC kicked off on Monday, July 15, 2024 at the FISERV Forum in Milwaukee, WI where capacity seating was estimated to be 10,000. During the official nomination process of Donald J. Trump - President, he first announced via social media that J. D. Vance was his choice for Vice President. All states, District of Columbia and Territories declared their delegate votes. Idaho's delegation led by IDGOP Chair Dorothy Moon, cast Idaho's 32 votes for Donald J. Trump. Donald J. Trump received 2,437 delegate votes.

Many state delegations attended Tuesday's party at the Harley Davidson Museum hosted by Western States Association. Local music was pro-

#### July 16, 2024

Present: Commissioners Clay Tucker, Lindy Lindstrom and Bob Callahan

#### **Pledge of Allegiance**

CONSTITUENT INPUT: A constituent from Garden Valley shared some opinions regarding the county's budget.

MINUTES: Chairman Tucker motioned to approve the minutes from July 9th and 11th. The motion carried.

ROAD AND BRIDGE: Curtis Dill presented information on a Mack truck which came with a sander. Commissioner Lindstrom recognized that the sander on its own would cost more than the truck, "and they break down all the time, so an extra would not be bad." This would be one of the department's newest trucks, and Commissioner Callahan commented, "And the price is right." There were only approximately 130,000 miles on the truck. Commissioner Lindstrom motioned to approve the purchase of the 2010 Mack truck with a sander. [The actual dollar cost was not discussed.] The motion carried.

**COMMUNITY JUSTICE:** A motion was said to approve an offer letter for a grounds/ maintenance worker with the pay. The motion carried.

HORSESHOE BEND AN-**NEX BUILDING:** Engineering work was done concerning a redesign and expansion of the building. Callahan suggested visiting the location and doing a walkthrough. Tucker said they should come back to this topic while discussing the budget.

**RESOLUTION TO FORM** AN AMBULANCE DISTRICT: A hearing date was set for August 13<sup>th</sup>, and the petition was accepted by the board of county commissioners. The resolution will be conditional upon the vote of those in the ambulance district. Commissioner Lindstrom motioned to accept Resolution 2024-29. The motion carried.

**BOARD COMMITTEE AS-**SIGNMENTS: Commissioner Callahan said he would like to be involved in the road department on the east side of the county to, "check in and help out where I can." He also would serve on the magistrate and snowmobile club. Chairman Tucker commented, "We'll just switch your name for Twilegar's name." **ISSUE TRACKING**: Unit 14 Ambulance is still needing \$8,000 worth of repairs. An ambulance loaner was discussed.

A mass gathering ordinance update was discussed, and Chairman Tucker said, "I wouldn't mind taking public comment." Prosecutor Alex Sosa suggested advertising and holding the public hearing on September 10<sup>th</sup> at 11am.

The Arrowrock Road and Atlanta Highway District contract was discussed. A Zoom meeting will take place between LTACK, Boise County Road and Bridge, and Prosecutor Sosa in the coming weeks.

Land acquisitions and capital facility funds were briefly discussed, and there was no update. Discussions will continue, according to Chairman Tucker.

Bogus Basin and their nonprofit status were discussed. Commissioner Callahan said. "I don't know how you can claim nonprofit when you're charging eight bucks for a lift ticket and twenty bucks for a burger."

Alex Gross disclosed that the Planning and Zoning building was decaying, and parts were falling off. He also reminded the board that the East Boise County Ambulance building is in need of a new roof and has been leaking. Curtis Dill said that the Idaho City shop was also having issues.

The board discussed revisiting the county's ULO [Unified Land Ordinance].

LIQUOR CATERING PER-MIT: A motion was said to approve a liquor catering permit. The motion passed.

**IDAHO ASSOCIATION OF COUNTIES**: The association is intending to meet in Idaho City on October 9th. Historic preservation folks in Idaho City will be contacted to potentially provide tours through some of the historic buildings for the IAC representatives and potentially some legislators.

DEMAND WARRANT: Tucker made a motion to approve a demand warrant for the Idaho Transportation Department in the amount of \$12,500 for a truck and sander. The motion carried.

A motion was said to approve eleven new employees' membership with Air St. Luke's in the

mentation. However, we did not do that. We implemented at 80%, so we have an additional 20% that we are trying to get to, based on the last year's data that we collected on every position." She added that there had been a 3% cost of living increase within the last year, but they are just focusing on that 20%. The chart reflected years of service, levels on the pay scale, etc. This was to "raise wages to get closer to market." To get the pay and benefits up to 100% for all employees, the cost to the county would be \$405,000. However, a 3.3% cost of living would be \$181,000 for all employees across the board.

There are currently six vacant positions open with the county: three road and bridge operators, an uncertified appraiser, solid waste administrative assistant, and a roll clerk in the assessor's office.

**OLD HIGHWAY 55 DISCUS-**SION: An individual from Horseshoe Bend was concerned that the old highway was getting harder to maintain and that there are several homes and a subdivision that connect to the road. There are potholes in the asphalt. The road was given to the county in 1999 and the county does not maintain the whole road.

Curtis Dill with the Boise County Road Department said they do help maintain the upper and lower portion of this road, "But right now, we don't have the manpower. Right now, all my efforts are concentrated on trying to clean up Banks Lowman [Road]." Dill said they were down four employees in his department. It was clarified that no Boise County property taxes go to the road department, although it was said there are roughly 140 taxpayers that live along that road. The money comes from sales taxes, fuel sales, and grants. PUBLIC HEARING WITH THE GARDEN VALLEY FIRE DISTRICT COMMISSION-ERS REGARDING IMPACT FEES: Alex Gross detailed the events leading up to this point, including a meeting that was held by the Boise County Planning and Zoning in Garden Valley last April. There has been no public comment. The fees for this application were waived for the fire district. The steps taken by the applicant include amending the Boise County Comprehensive Plan to collect enough taxes from new development and construction. Gross specified, "However, if an existing homeowner goes and


wants to put in a barn, they will not be charged an impact fee."

One constituent complained that there was not any information on the fire district's website. Impact fees were reviewed. Chairman Tucker acknowledged, "This is new growth helping to pay for itself." The fire district provides 321 square miles of coverage.

Chairman Tucker made a motion to approve the findings of fact for the Garden Valley Fire Protection District and the motion carried. He then motioned to adopt individually Boise County Resolutions 2024-30, 2024-31, and 2024-32, and each of the motions carried. Tucker motioned to adopt Ordinance 2024-03, and the motion carried. He then motioned to enter in and sign the Garden Valley Fire Protection District and Boise County joint powers agreement. All were in favor and the motion carried.

**BUDGET DISCUSSION:** Clerk Mary Prisco said the estimated property tax for 2025 was \$5.9 million. She spoke regarding allocated funds, tort fund, and several other funds. She then discussed sales tax funds. The clerk said there was a 5% increase for medical, vision, and dental plans for employees. The insurance premiums are also going up, a \$3,100 increase. Requested items from the different departments were discussed, including an additional deputy.

Building repairs were also discussed at length, and Commissioner Callahan added to the discussion and gave estimate repair pricing. The commissioners would like to take a "fieldtrip" to see where repairs need to be made. Adjourned at 3:42pm.

## **Pulled Over in a Traffic Stop**

**BOISE COUNTY --** When we encounter law enforcement in a traffic stop, we all hope it is a safe one. Ok, I admit the driver hopes they do not get a ticket. The main goal is that the stop should be safe for both the officer and the driver. everyone wants to go home. There are actions we can take to help make it a safe traffic stop. We all want to ensure that we are calm, and the law enforcement officer is calm. I assure you that is the goal of the Boise County Sheriff's Office.

If you see those lights come on behind your vehicle, the first step you need to take is to turn on the right turn signal and pull over to the safest place possible. If a safe place is a way off, turn on your flashers, it shows the officer that you have seen their lights and have every intention of pulling over. Scott Turner, Boise County Sheriff, asks that, "motorists pull to right when safe. All too often, people stop or pull over on blind corners, making things worse."

Once you pull over, ensure you are as far to the right as possible to help the officer approach your vehicle. Turn off your engine, any audio you have playing, place your hands on the steering wheel, and wait for the officer to approach. If there are any passengers in the vehicle, they should either put their hands on the dashboard, or if they are in the rear seat, they should place them on the back of the front seats. This might seem silly, yet it helps the officer to not see anyone as a threat in the vehicle. It helps the officer to remain calm.

Next, do not move until the of-

ficer asks you for anything. When they ask you for your driver's license, registration, and proof of insurance, let the officer know what movements you are taking and take them slow. All passengers should remain still. This applies when the officer is not near the vehicle. If they see a lot of movement, they will wonder what you are doing, and whether you are obtaining a weapon that could hurt them. It will put them on high alert. This is never good for the occupants of the vehicle or the officer.

Follow all the officer's commands. If you object to the officer, you should tell the officer for the record, and then follow the command. You can fight the objection out in the court of law if necessary. Per the Idaho Statute Idaho Code §49-316, it is required that the driver hand over their driver's license if requested during a traffic stop. The law is vague on whether passengers must or not. If you are a passenger and it is requested by the officer, you can object, then it is recommended to provide the license. You have the courts system to settle disagreements. It is impossible to win an argument with law enforcement on the side of the road.

It is important that we all have safe stops so everyone involved can make it home to their loved ones. It might not occur often for us; it does for the law enforcement officers. The Boise County Sheriff's Department makes many stops each day, they put their lives on the line for us, so let's make their job easier and safer.

As most of you are aware by now, the council members and mayor of the City of Idaho City and the Idaho City Fire Protection District are at odds over the fire station and property in Idaho City.

HISTORY: The Idaho City volunteer fire department personnel received a grant for a new fire station, back in the late 1990's. The City purchased that property the fire station was built on, then the City was paid back out of the grant. The fire station building was the first item that was paid out of the grant. As the grant money had to be administered by a public entity, the city was chosen. An independent person was paid from the grant to take care of the money. Therefore the city was not in control of overseeing this project. The property was leveled by volunteers from the area. Fill materials were brought in by volunteers from the area. The city made a contribution of an old dump truck to haul materials for about two days. The building was built by local people and the fire department. There were money donations from a lot of individuals from many states. Then a nice building was born, thanks to the hard work from our community.

The city reports that they gave the fire department money out of the tax dollars for approximately 18 years. They should have. The fire fighters provided a nice building to house the trucks and equipment. They provided fire protection to the area of Idaho City. The residents outside of Idaho City paid for the protection when they had a fire. The

pittance they gave the fire department was for equipment for the fire fighters, fuel, tires, maintenance for the building, heat, power and phones, etc. The fire fighters fought for donations any way they could to help keep the department running.

The fire trucks the department was using during that time were on loan from the Idaho Department of Lands. The ladder truck, the chief received from another fire dept for free. The little Jeep was from the 1950's and the only new fire truck, until now, that Idaho City has had.

In 2016 a taxing district was formed. The city transferred all the fire departments assets to the Fire Protections District except the building and property. Since then, a grant was received for a NEW tanker fire truck. A used/newer fire tanker truck and ladder truck have also been purchased. Newer pickups have been received and added to the equipment list. New equipment for the fire fighters, hoses, and other equipment that was so badly needed have been purchased.

The city's attorney and mayor do not want any history to come to light. Every day before today is history. We all live with our history, including those two. Our community thrives on the hard work of all those who lived in that history.

As was stated at the first meeting at the Community Hall with the City Council, the reason this property is an asset to the city is because they have the deed to the property and building. The best asset this fire department has is its mem-

bers and all the people who care for it to continue running. The city wants the fire district to pay them \$350,000.00 for the property and building that the firefighters built. The city also charges the fire district \$1,000.00 per year for a lease of the property and building the firefighters built. If not for the fire fighters, there would not be a nice fire station and property for the city to claim as theirs.

Does anyone in this area have approximately one acre of property and a nice big building they want to give me? Free, I don't want to pay for it. Isn't that the same thing they are doing?

Maybe it is time for the residents of Idaho City to think about electing new council members and mayor; time to think about a recall election.
