Boise County Fire Updates and Evacuation Notices

BOISE COUNTY – Triple digit heat waves in August, coupled with the current weather conditions, have not been conducive to the firefighting efforts, even voiding containment lines after escaped fire breaches caused by gusty afternoon winds. The Boise County Sheriff's Office has issued further notices to residents of possible evacuations. There are currently several "go now" evacuations in effect in Boise County, including those in the vicinity of the Wapiti Fire, a large fire burning uncontained in the Grandjean and Stanley area, and the Nellie Fire, which is encroaching on Lowman and Garden Valley. As of Tuesday, August 27th, the Wapiti Fire was estimated at over

70,000 acres burned, and the Nellie Fire, part of the Middle Fork Complex, covered about 40,000 acres burned.

Boise County Sheriff Scott Turner has been attending public fire meetings and incident command briefings nearly every day over the past five weeks. Although the continued effort has been taxing, public safety continues to be his top priority as he remains in close conversation with fire officials. Over the past several weeks, Boise County deputies have made an effort to safeguard the public by going door-to-door, informing residents of possible imminent fire danger.

Some residents have heeded the warnings prior to a Level 3 evacuation, "go now" order, and left to get situated

away from the fires. Patricia Robinson of Lowman said she decided to follow the voluntary evacuation order and left Lowman a week ago but is still staying close to home and in the county. Robinson was reassured that the fire crews were everywhere and, "busy, busy, busy."

Keith Lewis with Evergreen Resources Inc. was contracted to help set up spike fire camps, positioned away from the main fire command center. One such camp that was set up for the Wapiti Fire about ten miles west of Stanley actually burned over the weekend. Lewis said the wind-driven fire reached

the camp within the two-hour window the firefighters had to evacuate. Lewis' crew had to detour through Sun Valley to access the spike camp due to road closures, and by the time they arrived, the fire had already reached the camp.

There are currently several road closures in the county due to fire activity, including Highway 21 from the Sourdough Lodge to Stanley, and Highway 17 from Lowman to Alder Creek.

Mike De Fries, Public Information Officer with the Wapiti Fire, says more crews are arriving every day and defensive fire measures are being implemented to protect the town of Stanley and several subdivisions in the Lowman area. The winds have proven tricky, but firefighting efforts are pushing forward. He said that four Hot Shot firefighter teams are engaged, working long hours

and through the night to apply structure protection measures as aggressively as they can, safely and appropriately. There is cooperative key infrastructure, like homes and powerlines, that the firefighting efforts are focused on. However, there is zero containment on this active 70,271-acre fire.

He also cautioned that at times the fire activity can become so intense that it creates its own cloud, known as a pyrocumulonimbus cloud. In this instance, hot embers are funneled up into a smoke column which can easily cause spot fires up to half a mile away.

De Fries stated that firefighters are ready to react, be flexible, and be effective against the multiple challenges that the fire presents. However, he was encouraged that more resources were on the way, including firefighters and aircraft. He ex-

August 20, 2024

Present: Commissioners Clay Tucker, Lindy Lindstrom, and Bob Callahan

Pledge of Allegiance

CONSTITUENT INPUT: None

MINUTES: Commissioner Lindstrom motioned to approve the minutes from August 12th and 13th, 2024. The motions carried.

EXECUTIVE SESSION: A closed meeting for risk management was called and motioned per the request of Sheriff Scott Turner. [Time 9:08am to 9:33am] Coming back into session, Chairman Tucker said, "No action, yet."

The Boise Basin Senior Center was discussed. It is designated as an emergency shelter, but the sheriff said that due to being undersized and having bad wiring, "blew up." He said that Idaho Power determined the size generator needed for the sheriff's office and reported that the current one is undersized and far enough "beyond its life," that replacement parts can no longer be ordered. Turner shared concerns about their ability to keep the emergency center open and communications going 24/7 with the frequent power outages that have been occurring. Sheriff Turner said there is federal money available to help replace the generator and the clerk agreed. The sheriff said that money would cover the generator, shipping, and insulation.

There was discussion about the additional work that will need to be done to install a larger, newer generator at the senior center.

Lindstrom motioned to approve the quote for the senior center in the amount of \$46,569. The motion carried. He then motioned to approve the quote for the sheriff's office in the amount of \$68,782. The motion carried.

BUILDING REPAIRS: Sheriff Turner said that the assessor and himself are willing to do the work to save the county some money. Assessor Chris Juszcak listed items that were purchased such as fascia, metal flashing, nails, screws, and roof caulking. Commissioner Lindstrom motioned to approve the request for the building material for the sheriff in the amount of \$977.44. He then motioned to approve the building material for the Planning and Zoning office and courthouse, not to exceed

\$1,900. The motions carried.

PHONE SYSTEM: A new hosted phone system and 2-year package was presented to the board by a company. There will be ability to tap into the cell service when the internet goes down, and the system would move away from the copper wire and utilize the cloud system. The cost would be less than the current payment for the county. Prosecutor Alex Sosa would like to see a revised quote for 18 months.

EXECUTIVE SESSION: A motion was said to go into executive session to address a concern by Treasurer Gina Turner, to discuss risk management. [Time 10:13am to 11:02am] No action was required.

PLACERVILLE FIRE PROTECTION DISTRICT: Prosecutor Sosa discussed the annexation of eight parcels of land. There were some concerns that the law was followed and this topic was tabled.

PUBLIC HEARING: Alex Gross, with Planning and Zoning, presented a staff report for the board to review regarding a parcel of land in the Terrace Lakes subdivision. A variance was requested for a building permit because it was a residential undue hardship. The commissioners had a few questions for the applicant and there were not any opposing letters sent in by Central District Health, fire department, or surrounding neighbors. Commissioner Lindstrom said for the record that people should research their property when they buy it, "so that you can avoid these things." He then made a motion to approve the variance drafted by P&Z, and the motion carried. The couple was now allowed to purchase a building permit.

PURCHASE A STORAGE SHED: An 8x10 shed was discussed for the Assessor's office. Lindstrom was concerned that electronics would be put in it. Assessor Juszcak said that it would be placed underneath the roofline of the county office building. He acknowledged that they were "busting at the seams." Juszcak would like to reach out to the shop teacher at the Idaho City High School.

Lindstrom motioned to approve the purchase of a storage unit for IT equipment up to \$3,000. All were in favor and the motion carried.

BAT REMOVAL: A quote was received, and another is still expected. The topic was tabled for the Community Jus-

tice building.

EAST BOISE COUNTY AMBULANCE DISTRICT: A census of the number of residents was carried out to assist in completing a map. A legal release will be drafted. Commissioner Lindstrom motioned to approve EBCAD commissioner district work authorization for legal descriptions for \$5,000. All were in favor and the motion carried.

BOISE SCHOOL DISTRICT: A motion was said to grant an extension for the Boise School District. The motion carried.

RETAIL ALCOHOL BEVERAGE LICENSES: A motion was said to approve a list of numbers associated with businesses in Boise County for their retail alcohol beverage licenses. The motion carried.

DEMAND WARRANTS: A road department item, a spreader, used for distributing road mix along the asphalt was described by Curtis Dill. He said it helps to maintain the asphalt and is normally a \$7,000 machine. He said, "This machine will help reduce a lot of manpower." A motion was said to approve this auction item from the Idaho Transportation Department in the amount of \$200. The motion carried.

A motion was said to pay state fund insurance in the amount of \$5,440 for workman's comp premium. The motion carried.

EXECUTIVE SESSION: The board motioned to go into executive session to discuss a personnel issue. [Time 12:23pm to 2:23pm] Commissioner Lindstrom motioned to implement compensation changes as discussed. All were in favor and the motion carried.

FUTURE AGENDA ITEMS: There were several items discussed, and the assessor reported that the Idaho City High School shop class would not have a storage shed ready before the winter. Adjourned at 2:26pm.

A motion was said to approve EBCAD FY 2025 budget publication. All were in favor and the motion carried.

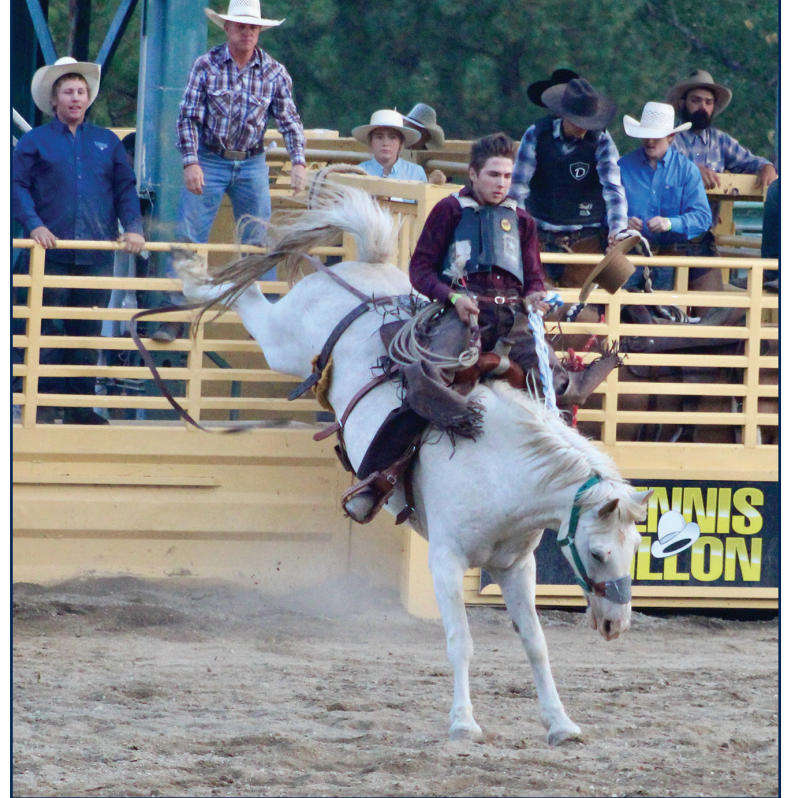
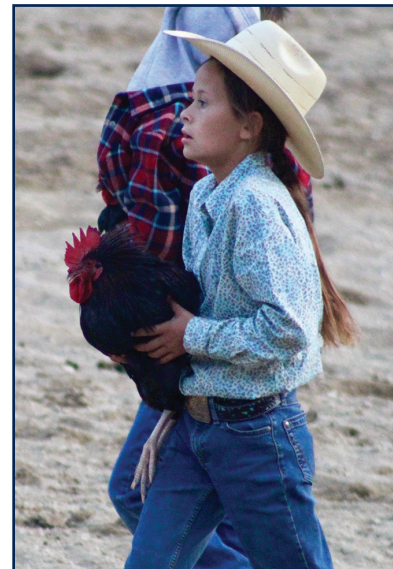
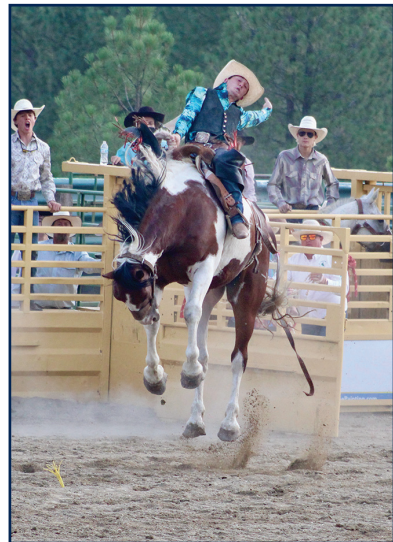

Perimeter Fencing Installed at Horseshoe Bend School

HORSESHOE BEND -- Horseshoe Bend School District welcomed students back to school on Wednesday, August 21. Students were able to see the changes made by the district when they arrived on campus. Thanks to the Securing Our Future grant made possible by the Governor's Office, the Idaho Legislature, and The Idaho State Board of Education the district is currently installing a six-foot-tall perimeter fence around the campus which will include three electronic gates at vehicle entrances. The parking areas were resurfaced, and interior painting was freshly done. The transition from summer break to back in the classroom went smoothly until an underground electric transmission line blew during the early morning hours of August 22. After Idaho Power assessed the problem, the district made the call to send students home, since they were informed that the entire campus would be without power for at least 5 hours. Partial power was available until 10:00 a.m. in some areas while others like the cafeteria were completely dark. The middle school and the high school were able to hold their welcome back assembly before students were dismissed.

plained that there are several standards that need to be met to determine a fire line containment, and they are making great progress. Firefighters work long hours, often sixteen hours or more in a day. De Fries said they try to give their firefighters the best opportunity to get rest, food, and the supplies they need to do their job.

The Nellie Fire, a 40,000-acre fire within the Middle Fork Complex, has a total of 724 personnel currently involved in fighting it. It is located approximately nine miles east of Garden Valley and was caused by lightning on August 8th. Strong west-southwest winds and a dry cold front have increased the fire activity leading to tree torching and spot fires. Structure protection is being provided in the Garden Valley and Crouch area. Air tankers have been used to drop retardant and strengthen the fire lines.

There have been Level 3 evacuation orders issued for Danskin Station, east of Garden Valley, and Hanging Valley Subdivision, located north of Lowman within the Wapiti Fire.

Several community fire

meetings with the Complex Incident Management Team have been held at the Community Center, Garden Valley Hall, located at 342 Village Circle in Crouch, Idaho. Fire community meetings are also being held in Lowman, but can be reviewed on Facebook at "Wapiti Fire Information 2024."

The Flat Fire threatened the Idaho City water supply from Elk Creek and was approximately one mile northeast of Pioneerville. It was lightning caused, burned 3,734 acres, and was 61% contained on August 26th. Summit Flat Road, located between Pioneerville and Coulter Summit, was closed due to fire activity. The last report indicated they had six hand crews, five fire engines, five water tenders, a dozer, three masticators, one helicopter, and a total of 301 personnel on this fire. Sheriff Turner said they are reducing their staff and turning the fire back over to local firefighters.

Due to the dry and hot summer conditions, fires continue to threaten the county. Robie Creek Volunteer Fire District was called out on a grass fire on Tuesday, August 27th, due to an auto accident. An emergen-

cy Life Flight ambulance was also dispatched to the incident. This fire was quickly extinguished by volunteer personnel and Boise County Sheriff's deputies. Wildland firefighters dispensing from the Flat Fire offered their assistance.

A second fire was started off of Highway 21 at the intersection of Forest Service Road 384 and 312, Edna Creek, when a vehicle caught fire. There was no containment on this fire, and it was last estimated at 10 acres on Tuesday evening. Air resources were quickly routed to this new wildfire to help slow its progress. Those traveling to Atlanta were encouraged to take Rabbit Creek or Arrow-rock Road.

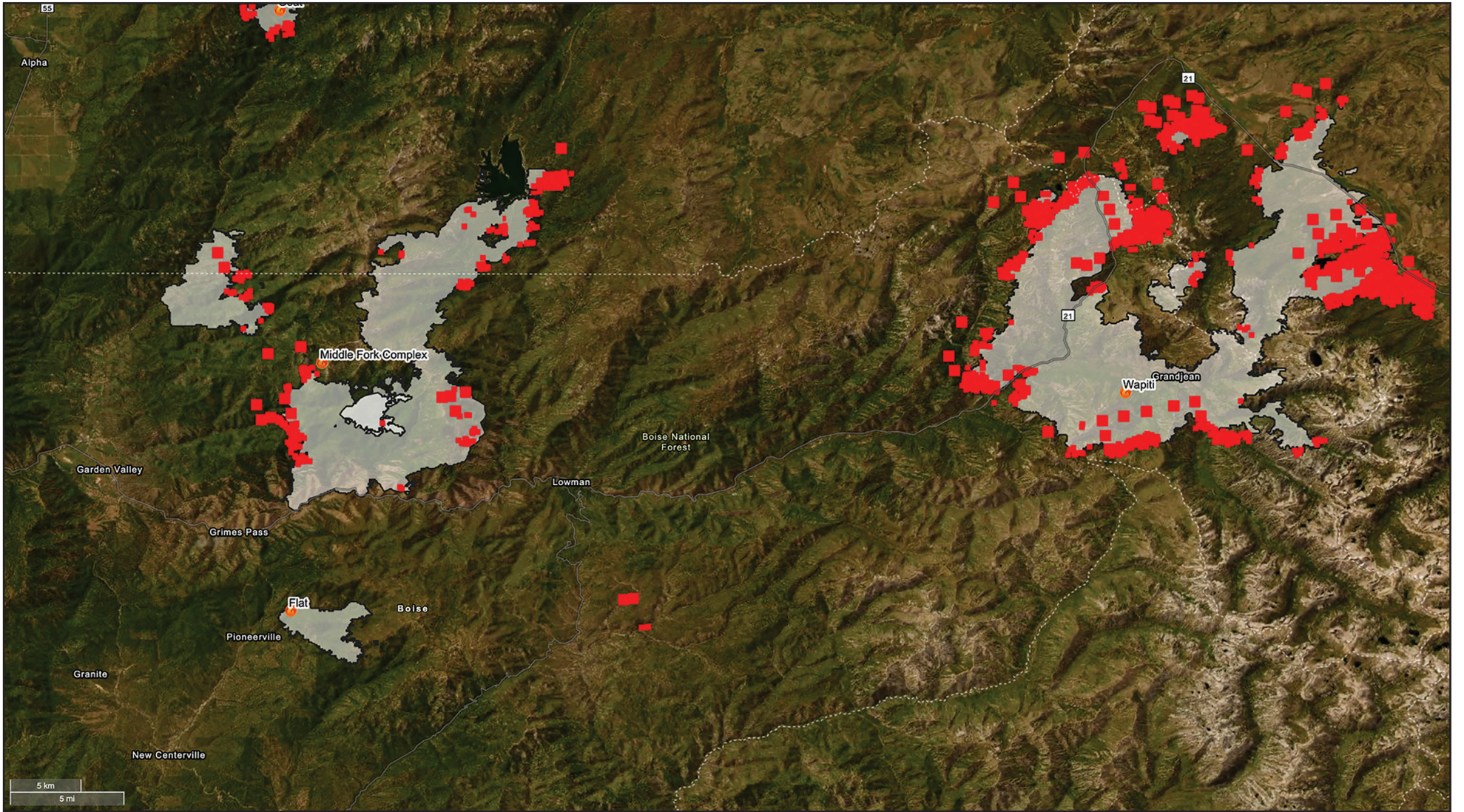
