Urgent Need for Sustainable EMS in East Boise County

The Urgent Need for Sustainable EMS in East Boise County

East Boise County, like many small towns across America, relies on the dedication of its

volunteers to sustain its emergency medical services (EMS). This reliance, while noble, has placed the East Boise County Ambulance District (EBCAD) in a precarious position, with

our EMS on the verge of shutting down. Despite having 56 volunteers on our roster, only 20 of them have been able to meet the 24-hour monthly commitment. The demands of

life and increasing pressures on their time are causing this number to fall, making it more difficult to maintain the service our community depends on.

EBCAD is constantly struggling to staff shifts 24/7. We are often one person away from closing many shifts during the week. Each shift requires two people: one to drive the ambulance and another to provide advanced medical care. For years, we've depended on volunteers to be the backbone of our EMS, but this model is becoming unsustainable.

Our community's story is echoed in rural areas across the nation. As younger, healthier residents move to urban centers, they leave behind an aging population that relies heavily on emergency services. The shortage of willing volunteers and the extensive training required—50 to 60 hours for even the most basic roles—makes it increasingly difficult to maintain our service. Those running the ambulance all the time are asking themselves, “If I don't do this, who will?” so they continue to push themselves.

Imagine calling 911 and having no one show up. This terrifying reality is something I cannot accept for our community. When EMS services close, even temporarily, it places an immense strain on the community. In Idaho, unlike more densely populated regions, neighboring communities are

often 30 to 50 miles away, resulting in longer response times and increased risks for those in need. Without our EMS in East Boise County, help would be driving from Boise, or even further remote locations that had an ambulance available. Right now, Horseshoe Bend is going through this exact situation.

Our funding model exacerbates these challenges. EMS programs are paid per emergency call through reimbursements from Medicare, Medicaid, or private payers. However, the long distances mean fewer calls and, consequently, less funding. Additionally, EMS volunteers respond regardless of a patient's ability to pay, further straining our financial resources. Calls often end without a patient to pay the bill due to cancellations, refusals, or fatalities. Year to date, we have responded to 270 calls, of which only 88 were billable. Many of these calls included standbys for law enforcement or fire services or were cancelled before our arrival. Each of these instances contributes to the operational costs.

In Idaho, EMS funding comes from a 25-cent fee on motor vehicle registrations and a minimal property tax rate of .00013%, (\$13.00 per 100,00.00 of home value) both of which are inadequate for our needs. For comparison, the local library in Idaho City and

Stage 1 Fire Restrictions Implemented in Boise County

BOISE COUNTY – The Boise National Forest, Idaho Department of Lands, and Bureau of Land Management met on Wednesday, July 31st, to discuss implementing Stage 1 fire restrictions for the Boise National Forest. The restrictions went into effect on Monday, August 5th. The U.S. Forest Service has indicated that, “the fire restrictions are intended to reduce the risk of human-caused wildfires during high burning conditions, especially those caused by escaped campfires and smoking.

“With Stage 1 fire restrictions, campfires and charcoal/briquette fires can only be within designated campgrounds and in a permanent campfire structure, usually metal or concrete. Smoking outside of a vehicle or building can only be within a designated recreation site or while standing over an area cleared of flammable vegetation within three feet.”

The Forest Service advised, “For those who are dispersed camping, such as car camping along the roads or backpacking, fires are only permitted if using a stove with liquid fuel such as propane and while over an area cleared of flammable vegetation within three feet. Wood stoves are also permitted if using a chimney at least five feet in length and using a spark arrestor. Private landowners are allowed to use charcoal (disposed of properly) or propane barbecues on their own lands.”

Due to the high potential for wildfires, fire managers have asked the public to be extra cautious with their outdoor activities. Take a few minutes to review recreating responsibly at <https://recreate.idaho.gov/>.

Boise County Sheriff Scott Turner has been assisting the U.S. Forest Service with road and area closures due to fire traffic and active burns within the Boise National Forest. The Wapiti Fire had grown to 205 acres on Monday, August 5th, and is located two miles southeast of Grandjean with a 0% containment. The Bull-

trout Fire is located 35 miles northeast of Lowman, burning at 292 acres, and was 41% contained. The Bulldog Fire, located about 8 mi. north of Crouch, has grown to 300 acres. It is about one mile from developed private property along the Middle Fork Payette River. Firefighters, including an engine and handcrew, are on site suppressing the fire. Each of these fires is due to lightning. Sheriff Turner indicated that additional fire fighting resources are difficult to obtain and are stretched very thin. He would like to remind the public that under the current weather conditions, any new fire has the potential to get very big, very fast.

Present: Commissioners Clay Tucker and Lindy Lindstrom

Absent: Commissioner Bob Callahan

Pledge of Allegiance

CONSTITUENT INPUT: Valerie Dresslar, a member of the Robie Creek Fire Department, asked that the commissioners "not make appointments during this meeting." She said the fire district commissioners should be present to vet the potential candidates. This decision would affect 582 residents.

MINUTES: Commissioner Lindstrom motioned to approve the minutes from July 23rd and 24th, and the motion carried.

IDAHO CITY SNOW GROOMER: Clerk Mary Prisco reminded the board that the IC snow groomer program has received a grant for \$38,000 to be used for facility improvement. Commissioner Lindstrom motioned to approve the purchase request for Idaho City's Snow Groomer Program in the amount of \$7,818 for an overhead door.

SOLID WASTE: The department would like to hire a new site operator as a full-time position for Horseshoe Bend. The department head is concerned that they may be out of compliance and per liability they should hire a new operator for this site.

Clerk Prisco said that this department must support itself, and funds would come out of the cash reserves to pay for this individual. However, the point was then discussed that the previous year, there was a raise for solid waste fees. A draft for the job description will be reviewed by the prosecutor.

COMMUNITY JUSTICE: Amanda Leader reported that a number of dead bats were found around several of the county office buildings. "My concern is that there is something wrong, that they're dropping off like flies," said Leader. She said that entering her building in the early morning has become a problem with all the bats flying around the front door. She has been "saving" the dead bats and talking with Fish and Game. She explained, "There's a very short window of opportunity to test them." Leader had a "fresh bat" from that morning that she had double-bagged and put in the fridge. Leader hoped to run it down to Boise that day and have it tested. Fish and Game

has so far indicated, "Heat is lethal for bats, so that could be part of the issue. It could also be that we have a maternal colony at the building. The female bats get together and they stagger the births." Leader added that they've seen "pups and bigger, more mature bats, so it's a combination." She said that about one in one thousand bats have rabies, so she would like to get the bat tested. "In order to contract rabies, they have to break the skin, usually by biting." Leader cleans the windows several times a week and reported that there is bat urine on all the windows. "I think the population is getting bigger and bigger," Leader said. She will seek out an updated quote for bat control.

There were also issues with the county generators.

PROSECUTOR: There was some discussion about the old Horseshoe Bend Hill, Old Highway 55. Prosecutor Alex Sosa reached out to the state and county insurance to discuss the potential of volunteers patching the road. He offered a few options to the commissioners. Sosa said that the county currently essentially maintains 277.9 miles, which includes a portion of Old Highway 55.

SHERIFF: A grant for the E911 system was discussed by Sheriff Scott Turner. He said this grant would help pay for 80% of the maintenance cost. The grant has also been helpful in the past for the purpose of gaining new computers for dispatch. The total of the grant would be \$40,342.97. A motion was said to approve the E911 grant approval for the application and the motion carried.

LICENSES: The retail alcoholic beverage license applications were approved by a motion.

SQUAW CREEK SOIL CONSERVATION: Clerk Prisco said this support was budgeted for and the amount has not increased over the years for their projects. Lindstrom motioned to approve the cash donation of \$2,750 to Squaw Creek Soil Conservation and the motion carried.

DEED: A small strip of land was transferred through a resolution for the Idaho City Historical Foundation to have and maintain a Veteran's Park. Prosecutor Sosa said that if they ever stop using it for the purpose of the resolution, then the question of land usage would come back to the county. Lindstrom motioned to approve the quick claim deed that

is identified in the resolution from 2022.

MOTION: A motion was said to sign a letter of correspondence with Compass Organization to increase relations and perhaps provide funding.

RESCUE TRAILER: Chairman Tucker motioned to approve the freight cost of \$974 for the Sheriff's rescue trailer.

BUILDING PERMIT REFUND: A motion was said to approve a building permit refund for a permit that was withdrawn.

AIR ST. LUKE'S: A motion was said to approve a new membership cost of \$55 and the motion carried.

EAST BOISE COUNTY AMBULANCE DISTRICT: Mari Adams said that they had a tire "blow out" and they would like to get new tires as a matter of safety. Tucker commented, "I did see a picture of that tire. It was a pretty bad blowout." They had a quote for six new 12-ply tires. EBCAD is down two ambulances again. Lindstrom motioned to purchase new tires for Ambulance 15 in the amount of \$3,002.04.

A motion was said to have a company visit and check for asbestos in the amount of \$150 and the motion carried.

TREASURER: Gina Turner said they received all their 2019 and 2020 property tax payments, except for one parcel. She said that they are unclear of the ownership of that one property and it may be owned by the government. She also said that they will be sending delinquent tax requests for 2021 to the sheriff's office.

SHERIFF: Sheriff Turner reported that there were three decent-sized fires in the county. The department did evacuations in the Grand Jean area for the Wapiti Fire and the Forest Service issued a closure. The deputies also did an evacuation for the Bull Trout Fire, by Bull Trout Lake and campground. There's a third fire by Lowman that has grown to 12 acres. Sheriff Turner spoke with the Idaho Department of Lands and Forest Service, and reported that, "The big issue that we have right now is resources. There are no resources."

He said they had a fire chiefs' meeting and there were a lot of questions about fire restrictions, "and why we are not in fire restrictions. There is a process... We have met the criteria now for going on almost three weeks to be on fire restrictions. The Forest Service, IDL, and

BLM fire managers are meeting on Wednesday to discuss fire restrictions." The sheriff informed these entities that if they did not approve the fire restrictions, he would ask for a special meeting of the board of county commissioners to invoke their power to enact a Stage 1 Fire Restriction. He said there was a consensus among the fire chiefs that this restriction is needed, due to lack of resources and the hotter temperatures.

The commissioners asked about the shut-off by Idaho Power. Sheriff Turner said, "There's definitely some issues with Idaho Power. I definitely expressed some frustrations and concerns with Idaho Power. At the end of the day, Idaho Power doesn't care. I mean, they're their own entity. They're going to do what they've got to do. The restoration of power was an issue. We had places without power for 20-hours. They claimed that they did not turn the power off in the county, that the power outages in the county were all weather related. I disagree with that, because over half the county didn't even see anything really weather wise."

Turner said that having 18+ hours to restore power was unacceptable, and that the generator for their building was so old that he could no longer get parts for it. He added, "I don't know what the answer is for Idaho Power," but suggested that if they should stage crews to quickly respond and restore power. "Even areas that have no overhead power, they are all underground, did not come on until 2 o'clock the next afternoon. So, there's definitely some issues that they've got to get worked out," the sheriff said. He commented that, nationally, particularly in California, because of wildland fires and power companies, "It's a really touchy subject."

EBCAD: Mari Adams with EBCAD said that there are a lot of elderly people up here and that oxygen machines last for a limited period of time.

She said they have a lack of volunteers and there were several calls for service at the same time.

The new ambulance was ordered in 2021 and has not been received.

PROSECUTOR: Sosa said they were "busy as ever," but

everything was going well. There have recently been a lot of DUIs and drugs in the county.

CLERK: Prisco said that nearly all of her time was focused on completing the budget for the next fiscal year. She will be presenting the budget the following week. She also has two new employees, one for the accounts payable and other for payroll.

She warned the commissioners that there will be a lot of liquor licenses to be renewed coming up.

"We still have the audit, 2023, and still have open items that we're working with auditors on," the clerk said.

A Planning and Zoning "mega" workbook is being revised.

FORESTER: The representative said properties had been "done" for the grant. Prescriptions had been written and there are burns that will need to be carried out. More work is to be undertaken throughout Robie Creek and Wilderness Ranch. There are also project areas around Terrace Lakes and Castle Mountain, among others.

He then spoke about fire restrictions, should the area enter Stage 1, "You can only have fires in designated areas, campgrounds. You can only smoke cigarettes in vehicles."

ROAD DEPARTMENT: "Word's traveling fast. Today has not been a great day. We had a mechanical failure on a truck and one of our trailers and our broom is now in the Payette

River," said Curtis Dill. There were no injuries. They were clearing a lot of large rocks from the Banks Lowman Road when the failure occurred. Dill said that there were many trees that came down in the storm that fell on powerlines.

Dill said they were on track to work on some culverts starting on September 1.

The new employees are receiving equipment training.

Dill reported that they are done with dust abatement for the year.

Clerk Prisco spoke about including funds to potentially fix the Centerville culvert in the 2025 budget. Dill said they had purchased the culvert but anticipate spending another \$60,000 for materials. Prisco would like to make this a reimbursement.

She also made suggestions for other potential funds that might qualify.

ROBIE CREEK FIRE: District commissioners were discussed and the clerk passed along one candidate for the board's review. Prisco agreed with Dresslar that she too would like to see some effort

be made toward, "making sure we get the right commissioners for this first set of commissioners." She said the new fire district would "not be able to levy until next year." Lindstrom said there were now four names submitted for consideration, and there will not be an election held, the first fire commissioners must be appointed. Lindstrom would like to interview the candidates and provide a form. He would like the Robie Creek Fire Protection District to participate more.

EXECUTIVE SESSION: Chairman Tucker motioned to go into executive session to discuss pending litigation. [Time 11:00 am to 11:23 am] Coming back into session, there was no action required.

FUTURE AGENDA ITEMS: Road department topics were discussed, including getting cell phones for operators and forwarding calls if employees are not in the office.

Clerk Prisco discussed getting the tentative budget approved and the EBCAD dissolution.

Adjourned at 11:32 am.

the Fire Districts receive three times the amount of property tax funding than the ambulance service does. This disparity highlights the inadequacy of our current funding model. Since 2020, EBCAD has been running on cash reserves to keep our services operational. The cost to run an ambulance service includes personnel, equipment, maintenance, and training—all of which are substantial and cannot be sustained under our current tax rate.

To secure the future of our EMS in East Boise County, we must update our funding structure. East Boise County ambulance operates on outdated tax brackets from 1987, which no longer cover current needs. Redistricting and updating these tax brackets are crucial steps toward providing the financial support necessary to keep our services operational.

We need your vote to save our county's ambulance service! Two critical measures are

on the ballot on November 5, 2024: one to dissolve the East Boise County Ambulance District and another to form the East Boise County EMS District. Your "yes" vote on both measures is vital. Without this vote, the uncertainty of having an ambulance service in our county will persist, putting lives at risk.

The impact of losing our local EMS is more than logistical; it's deeply personal. Every time an ambulance is dispatched, it is heading to help a neighbor, friend, or family member. The thought of not having this vital lifeline is heartbreaking.

By addressing these funding and structural issues, we can ensure that no call for help goes unanswered. Maintaining a local EMS is about preserving the heart and soul of our community. We must act now to secure the future of our ambulance service and protect the lives and well-being of our residents.

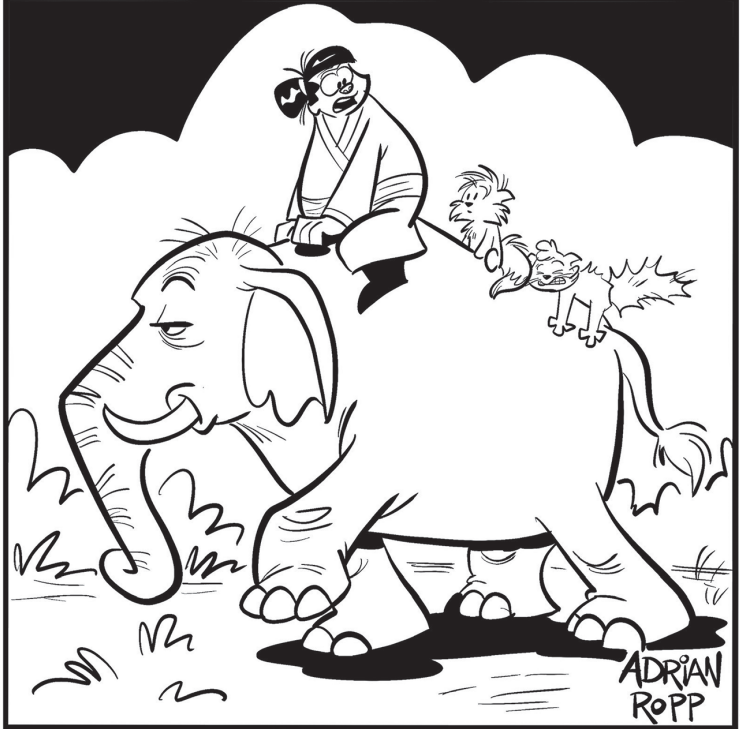

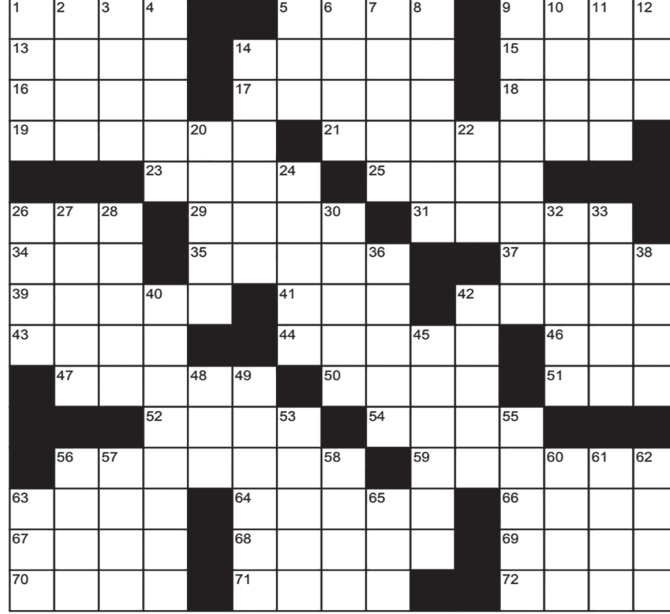

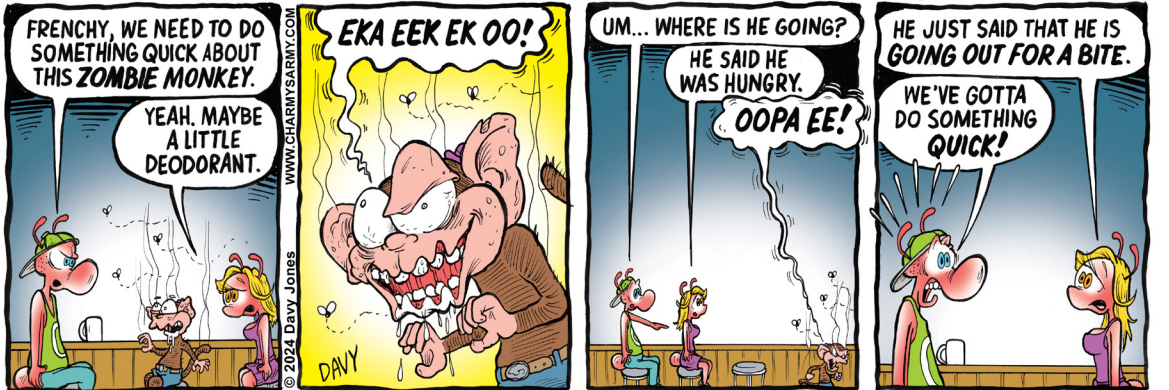

1. That pursuant to Idaho

That pursuant to Idaho Code § 31-3911(4), the County Clerk transmit this Petition and the City Resolution to the Board of County Commissioners; and 3. 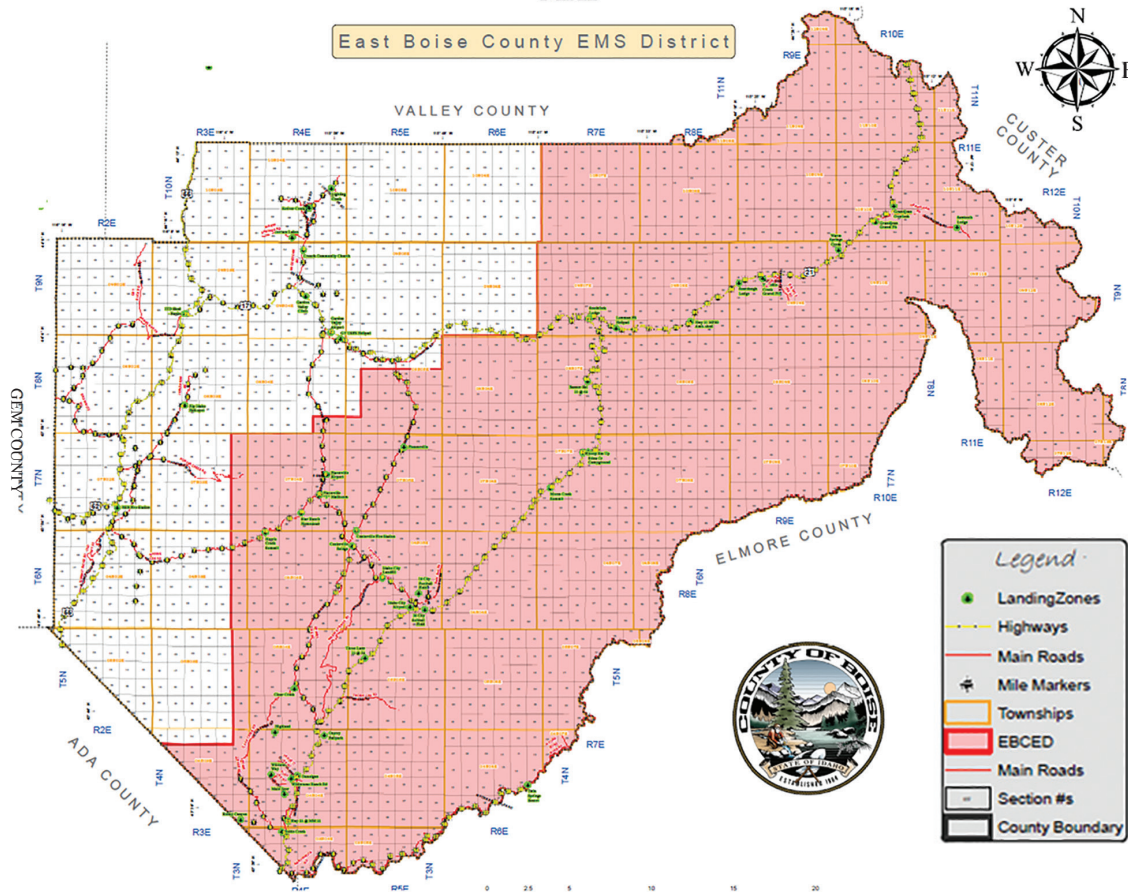

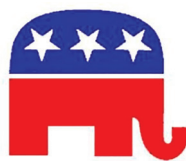

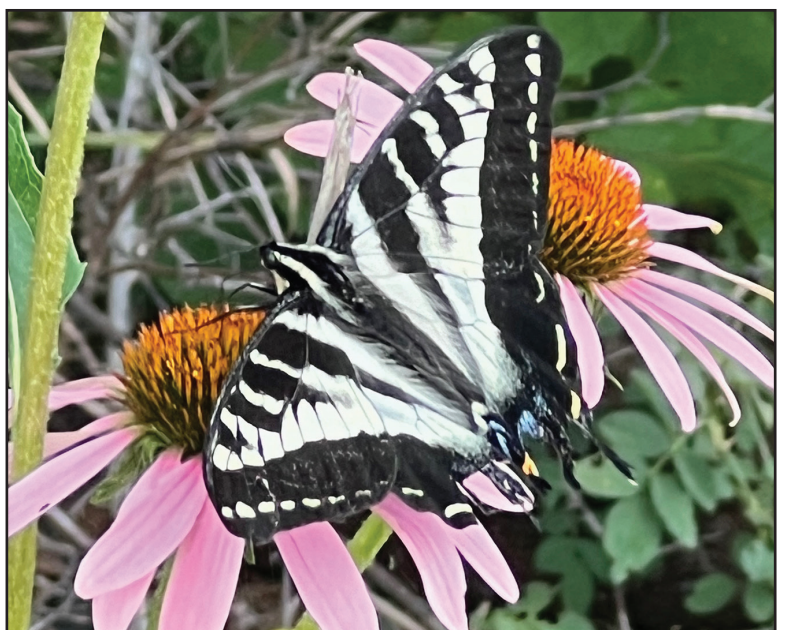


Jerry Hines

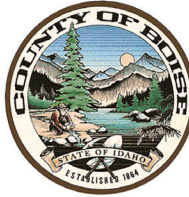

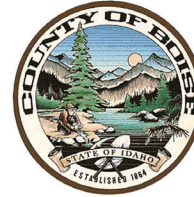

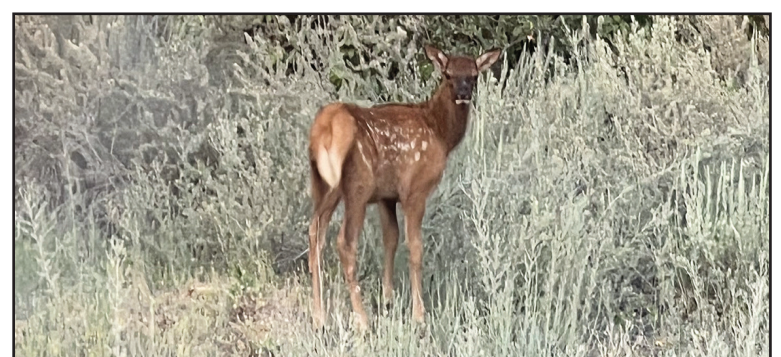
