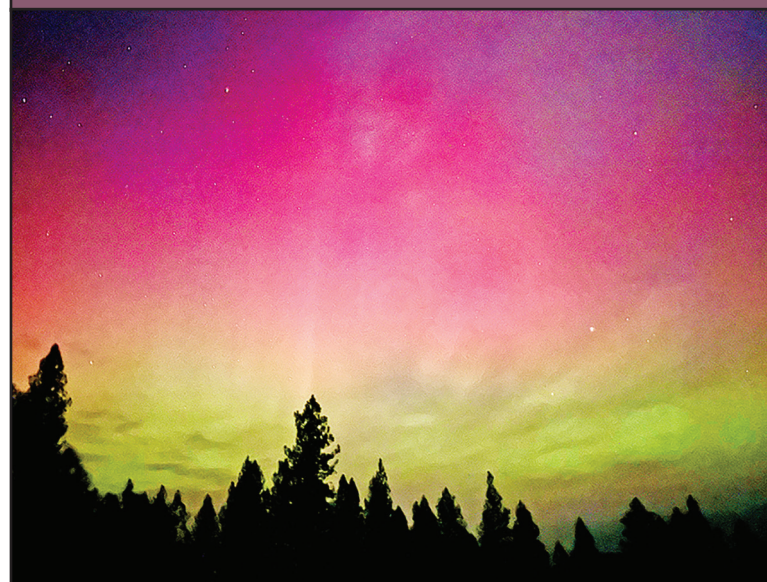

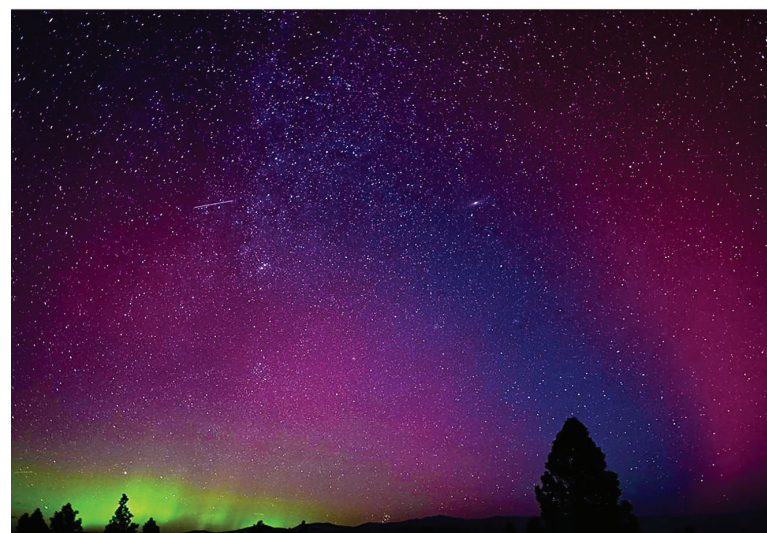

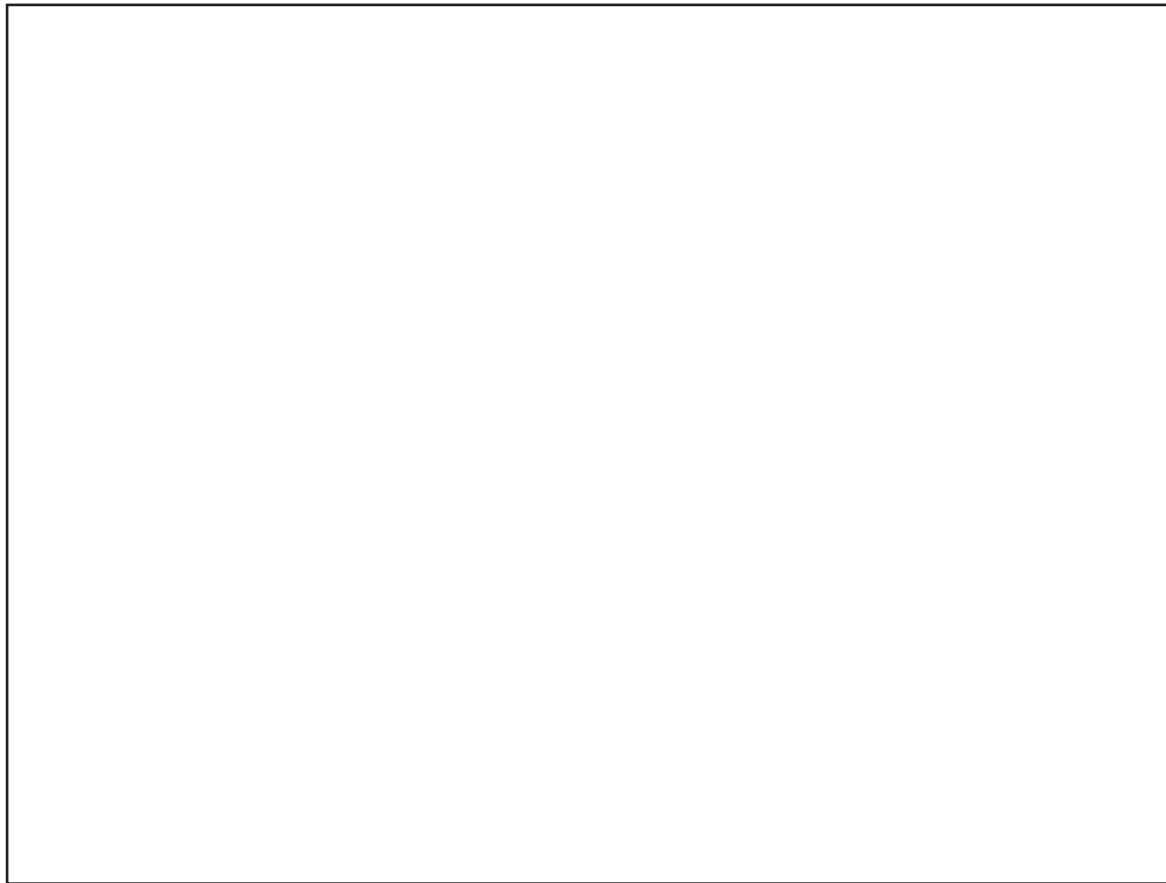

Statistical standouts were senior Aubree Zimmer with 8 kills, 1 ace, 5 digs and 1 assist, sophomore Celeste Wilson with 7 kills, 1 dig and 1 assist, senior Aliyah Meyer with 6 kills, 4 aces, 7 digs and 7 assists, freshman Malia Goff with 4 kills, 4 aces, 4 digs and 15 assists, senior Ashlyn Wolsleben with 2 kills, 3 aces, 5 digs and 3 assists, sophomore Kimber Jones (libero) with 1 kill, 1 ace, 10 digs and 1 assist, and freshman Aubrey Penney had 1 block and 1 dig.

The Mustangs were in Horseshoe Bend for their Homecoming match against the Cascade Ramblers. The ladies took the win in the 1A DII Long Pin Conference match 25-7, 25-5, 25-12.

Stat leaders were Meyer with 6 kills, 5 aces, 3 digs and 6 assists, Penney with 5 kills, 2 blocks and 1 dig, Zimmer with 4 kills, 10 aces, 8 digs and 1 assist, Wolsleben with 3 kills, 4 aces and 5 digs, Jones with 3 kills, 2 aces, 4 digs, Wilson with 3 kills, 1 ace, 2 blocks, 1

dig and 2 assists, and Goff with 8 aces, 1 block, 4 digs and 11 assists. The team is currently 23-5 overall and 10-0 in conference play this season. The Mustangs host the Salmon River Savages on Friday, 10/18 at 4:45 p.m. The game will honor the Lady Mustang senior players.

Volleyball Terminology	
Ace	a serve which is unable to be played or returned by the opposing team
Assist	pass, set, or dig ball to another player who gets the kill
Block	blocking the ball into the opponent's court leading to a point or side out
Dig	passing a spiked or hard-hit ball
Kill	an attack on the ball which is not returnable by the opposing team
Libero	A player specialized in defensive skills: the libero must wear a contrasting jersey color from their teammates and cannot block or attack the ball when it is entirely above net height. When the ball is not in play, the libero can replace any back-row player, without prior notice to the officials

Idaho Power Issues Statement on Valley Fire

Submitted by Idaho Power BOISE COUNTY — The Idaho Department of Lands, which is leading the investigation into the Valley Fire that started east of Boise on Oct. 4, has finalized a report concluding that Idaho Power equipment was involved in the ignition of the fire.

The report states that a cross arm on an Idaho Power pole broke and likely caused an energized wire to contact the ground. The report found no

evidence of rot or bug infestation and no visible alterations to the cross arm other than those necessary to support the line. Idaho Power inspected this line three times this year, including the cross arm that appears to have broken, and no issues were noted in either ground or helicopter inspections. As noted in the report, the fire did not damage any structures, vehicles, or equipment.

Idaho Power acknowledges the conclusions of the Idaho

Department of Lands report and remains committed to safely providing reliable, affordable energy to its customers. The company is grateful for the first responders who worked to quickly contain the Valley Fire and the patience of the customers who were impacted by the fire.

The opposition to Proposition 1 is disheartening. Did you know our new State Representative, Seat A was elected by only 17% of District 8's registered voters? (Source: Secretary of State election data) How is that okay for anyone committed to a representative democracy? Opening up our primaries would solve this issue.

Contrary to what opponents say, out-of-state forces are not leading the initiative. I've volunteered for this campaign since May 2023. It's very much homegrown. The majority of donations for Idahoans for Open Primaries come from in-state donors. According to its 10/8/2024 Idaho Sunshine Financial Disclosure, \$1,457,639 has been donated to the campaign. \$911,823 of that is from in-state donations, and half of all donations are from individuals. The one major out-of-state donor is Unite America, a

philanthropic venture fund that invests in nonpartisan election reform. (www.uniteamerica.org)

Opponents say "Alaska hates their own open primaries and ranked-choice voting so much they're voting to repeal it." However, its implementation benefited both Republicans and Democrats in Alaska, and Alaska's legislature is now more functional and less polarized. (Alaska Beacon, 10/11/2024 article "What Alaska voters should know as they consider a repeal of open primaries and ranked choice voting.")

Another argument opponents use is that "Independents can register as Republicans, then switch back the next January after voting in the primary." While technically true, it's a pain for us Independents and a nuisance for county clerks.

Finally, the alarmist "not every vote counts" claim has been consistently debunked by the courts. (Source: Congressional Research Service,

Ranked Choice Voting (RCV) — more appropriately nicknamed Rigged Choice Voting — was already prohibited by law in Idaho via House Bill 179, but a leftist group is trying to overturn voter choice with a ballot initiative that eventually will destroy Idaho's primary and general elections. (In Idaho, the primary elections often determine the general election winners, so the open primaries of this initiative are particularly harmful.)

Prop 1 will completely restructure Idaho's election system and harm Idaho. How?

1. Requires all primaries to use a wide-open "top-four" scheme technically termed a "jungle" primary. The current partisan primary, where Republicans select the Republican nominee, Democrats select the Democrat nominee, and other parties select their own nominees, would be abolished. Replacing it would be a "top four" primary, where all candidates are on the ballot, and voters can choose any one of them. The top four vote-getters advance to the general election, regardless of party affiliation (or lack thereof). This is unfair! Why should your party choose the candidates from my party? Have your own party, if you please.

2. Implements Ranked Choice Voting (RCV) in our general elections. The general election would be conducted via an instant runoff, also known as ranked choice voting. In this system, voters rank candidates by order of preference, and votes are counted in multiple rounds. If nobody receives an outright majority, the lowest vote-getter is eliminated. This process — which requires computer intervention (what could go wrong?) and eliminates voted ballots — continues until one candidate has a majority. That candidate is then declared the winner.

3. Costs Idaho Taxpayers at least \$40 million by requiring new voting machines and extensive voter education while putting an undue burden on county elections (especially those that span counties such as state Senators and Representatives).

4. RCV votes would be nearly impossible to audit, so if you think cheating is difficult to catch and stop now, just wait until RCV is implemented.

5. Alaska already tried open primaries and RCV, which failed to achieve anything good for the state. Alaska hates this system so much, its citizens are

trying to repeal it.

RCV is incredibly complex, which is why its backers like it! But just ask them to explain it: They cannot! Check out these short YouTube videos so you too can be confused:

Dear Editor,

In November, Basin School District Zone 4 constituents will be voting on whether or not to recall Trustee Patrick Minto. At issue are his priorities and his handling of constituent input.

Mr. Minto has clearly stated that his primary duty is to taxpayers rather than to our children. (This fact is well documented in School Board minutes.) While I strongly support accountability, and want my taxpayer dollars spent wisely, financial accountability is only one aspect of a trustee's role. Minto's written rationale for his retention as a trustee includes unrelated culture war issues, presumably in an effort to win over folks who aren't acquainted with the actual reasons for the recall, and who react negatively to anything hinting of woke ideology. This diversionary, scaremongering tactic makes me question both his motives and his suitability to serve as a school board trustee.

I will be voting to recall Trustee Minto.

-- Pat has questioned many line items in the budget, but has not voted against any spending as a trustee

-- Pat has pushed for a ten year building maintenance strategic plan (even before it was mandated by the state), where previous serving trustees did not

-- Pat vehemently opposed the District's Gender Policy Number 513, which mandated the use of pronouns by teachers and staff, allowed for biological males to participate in female sports, and threatened teachers and student with disciplinary action for violations. The state legislature has since outlawed such practices, but previous trustees voted for it, some of whom are now circulating the recall petition

-- Pat has proposed that the Basin District look to consolidate certain services (such as speech pathologist and school psychologist) with other districts to save on overhead costs, but has not advocated for sending students out of the Basin District for education

-- Pat does not unreservedly support the Idaho School Board Association (ISBA) Code of Ethics, as the ISBA originally drafted the Gender Policy, which has since been overturned by state law and the vote of the Basin District board. He has said that state

law is the primary governing set of rules for the conduct of a trustee, not the code of ethics of a private organization that pushed a flawed policy which did not reflect our local values and was ultimately outlawed by the state

-- Pat is the target of KTVB, some members of the ISBA, and a local group angry that the outrageous Gender Policy has been overturned and that our school tax dollar expenditure is being scrutinized by a trustee on the school board

Basque Influence in the Boise Basin

IDAHO CITY -- The Idaho City Historical Foundation held their annual meeting on Sunday October 13, 2024, at the Boise Basin Senior Center. The meeting was well-attended by community members who listened to President Barbara McClain and Treasurer Beth Wilson give financial reports and ask for membership votes on five board openings.

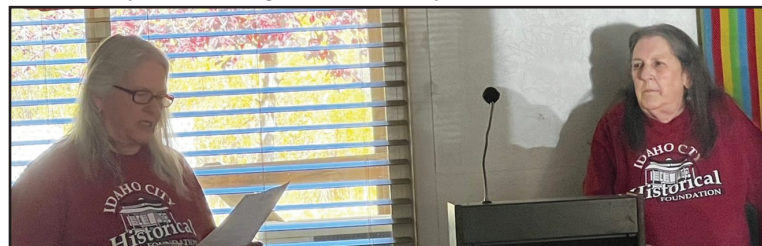
Over the last year, with the help of volunteers ICHF has rebuilt and installed ramps at the Wildfire Museum and in the Kenn Smith Gardens, in addition to building shelves in the Lippincott shed and at the Holcomb Garage. They also raked the Pioneer Cemetery, established a monument for fallen firefighters at the museum, and

helped Idaho City erect a 10-foot fence at the sewer lagoons.

After reviewing their accomplishments and goals, ICHF presented their guest speaker, Dr. John Bieter, who discussed the legacy of the Basque people in Idaho. Bieter stated: "The Boise Basin is much more than just the story of mining. The sheep industry was especially important in southern Idaho and brought a unique community of immigrants to

Boise Basin. At one point there were 3.2 million head of sheep in Idaho, and the influence that the Basque people brought was not only food, but it made a change in the social structure that changed their culture and ours."

Currently Dr. Bieter serves as a professor in the History department and as Co-Director of the Basque Studies Collaborative at Boise State University.

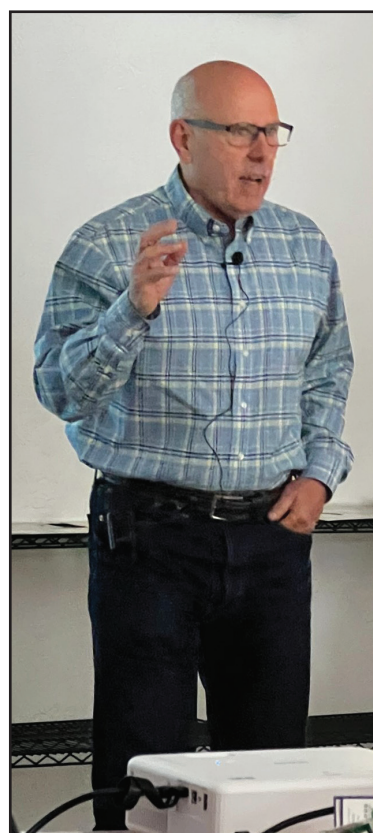

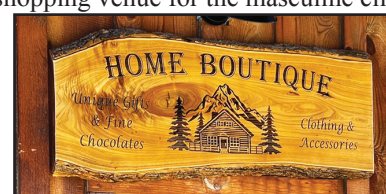
SPOOK ALLEY IS BACK!

Idaho Constitutional Amendment HJR 5

Legislative Council's Statement of Meaning, Purpose, and Result to Be Accomplished

This proposed constitutional amendment provides that only Idaho residents who are citizens of the United States are eligible to vote in elections in the State of Idaho and that noncitizens are not eligible to vote in any election in the State of Idaho. Currently, Section 2, Article VI of the Constitution of the State of Idaho provides: "[e]very male or female citizen of the United States, eighteen years old, who has resided in this state, and in the county where he or she offers to vote for the period provided by law, if registered as provided by law, is a qualified elector." This provision does not expressly prohibit noncitizens from voting. The proposed amendment adds language to provide that only United States citizens may vote in elections in the State of Idaho.

Statements FOR the Proposed Amendment

1. This constitutional amendment is needed to clarify that United States citizenship is a requirement for eligibility to vote in Idaho elections because the current language does not expressly prohibit noncitizens from voting. The proposed amendment will ensure that individuals who are not citizens of the United States do not vote in any government election in the State of Idaho.

2. The amendment is also needed to clarify that the right to vote shall not be granted in the future to individuals who are not citizens of the United States. Noncitizens have been granted the right to vote in some local elections across the United States. Legislation to expand voting to noncitizens has been considered in other states and cities in the United States.

3. Allowing noncitizens to vote in Idaho elections could lead to concerns regarding election integrity and allow for foreign influence in Idaho elections. The proposed constitutional amendment will protect the State of Idaho from such issues.

Statements AGAINST the Proposed Amendment

1. The proposed constitutional amendment is not needed because United States citizenship is currently required for participation in Idaho elections. Under current law, the Idaho Secretary of State requires citizenship and proof of residency with respect to individuals who register to

vote, and it is a felony for an individual to provide false information on an Idaho voter registration form. Additionally, federal statute provides that it is a crime for a non-citizen to vote in any federal election.

2. Election fraud involving voting or attempts to vote by noncitizens is not a significant issue in Idaho. Adding additional language to the Idaho Constitution in an effort to solve a problem that is not occurring could inadvertently create new problems or add an additional barrier to registering to vote by new citizens and state residents.

3. The proposed amendment undermines local control of local elections. The amendment would foreclose any opportunity in the future for the Idaho Legislature or local governments in Idaho to authorize noncitizens to vote in certain elections that might directly affect their interests.

Amendment Text

Section 2. QUALIFICATIONS OF ELECTORS. Every male or female citizen of the United States, eighteen years old, who has resided in this state, and in the county where he or she offers to vote for the period provided by law, if registered as provided by law, is a qualified elector. No person who is not a citizen of the United States shall be a qualified elector in any election held within the state of Idaho.

Thence in a Northeasterly direction along with Boise/Elmore County line to its intersection with the Custer County line. Thence along the Boise/Custer County line to its intersection with the Valley County line. Thence along the Boise/Valley County line to the point of beginning.

A map showing the boundaries of the proposed ambulance service district is on file in the Boise County Clerk's office located at Boise County Clerk's Office located at 420 Main Street, Idaho City, Idaho 83631 and is available for inspection during regular working hours.
