Remembering Dylan Bass

1993 - 2024

Dylan was born at St. Luke's Hospital in Boise, Idaho on February 4, 1993. He passed away on October 20, 2024 as a result of an ATV accident.

A Celebration of Life was held on Saturday, October 26, 2024 at Terrace Lakes Resort Pavilion, Garden Valley, Idaho.

Dylan's mom and dad were firefighters. But being the smart child he was...he wanted none of that. When he was three years old, he dragged his older sister Shauna and his unwitting parents to Garden Valley, Idaho, where he charmed the lady with the big house for sale by demonstrating his talents of putting on his own jacket. After donning it with a big "TAD

DA! "as only Dylan could exuberantly exclaim, the lady of the house pronounced "SOLD" to the young man...and the Bass Family began their wonderful adventure of life in Garden Valley. THEN the mania began. One day while playing in the pasture below the house, Dylan found a golf ball. He'd never seen anything like it, as none of the family were golfers (although they had joined Terrace Lakes Golf Resort as members so the kids could

learn to swim, and his parents could drink beer in the pool on Friday nights!) Apparently, the lone ball had travelled from Warm Springs Creek, which borders Terrace Lakes, and found its way through the irrigation ditches to the pasture. Dylan asked his dad about what kind of ball it was. Dylan had no understanding of anything that could not be swatted in the air with a plastic baseball bat, so Jeff took Dylan's little plastic baseball bat and attempted an on-the-ground golf swing to show him how it was "supposed" to be done. Dylan was hooked, as more of the "alien" balls continued to show up in the pasture.

Finding those random balls became an obsession for Dylan. Every waking moment became a search for golf balls. The search range increased from the pasture to the out-of-bounds land of the golf course. Every night, every weekend, the family activity was the golf ball search. The house, the barn, the garage...all overtaken by golf balls. And so, Dylan began his first career at the tender age of 7 - finding balls, then heading up to Terrace Lakes to sell them back to the folks that had lost them.

After a time, the obsession with selling golf balls turned into a desire to actually USE them. Dylan would peddle his bicycle up to Terrace with his bag of prized small kid clubs and just WAIT. WAIT for someone to take him out on the course! And...they came... those wonderful members that took the young boy out on the course to help him learn - not only about golf, but about a lot of other life things!

He was addicted. He played with the folks that were so kind to take him...every day.

His next career move was an easy pick. He set his sights on working at Terrace Lakes... and he finally found a chance.

Dylan was still too young to be hired, but he was de-

Implementing Pile Burns on Forest Land

BOISE COUNTY - With the onset of cooler weather, the Idaho City Ranger District of the Boise National Forest intends to implement the Buckskin pile burn project in the coming weeks. Provided favorable weather conditions and approval from Idaho Department of Environmental Quality (IDEQ), ignitions could begin as early as Tuesday, October 29. These operations will burn piled material remaining from previous mechanical treatments near the communities of Pioneerville and New Centerville approximately 11 miles northwest of Idaho City, Idaho.

In total, fire managers intend to complete approximately 1500 acres of pile burning over the coming weeks across the Idaho City Ranger District. There are no anticipated road or trail closures due to the pile burn projects. Smoke may be visible from a variety of loca-

tions including Highway 17 (Banks Lowman Road) as well as the communities of Pioneerville, New Centerville, and Placerville. Smoke impacts should be of short duration with smoke potentially settling in low lying areas near the project site during the nighttime hours.

EAST BOISE COUNTY -- What will you do if you need an ambulance, but the 911 operator's response is "I'm sorry, there are no ambulances available;" at least not one within Boise County? Drive yourself? Have your partner drive? What if you are hit on the highway just coming home from work by some flatlander pulling a side-by-side after one too many brewskis? How will you drive yourself then? What about when your mom comes

for Thanksgiving and collapses in your kitchen? Or your husband out by the grill? Can you move them to the car by yourself? If you are lucky, an ambulance could be dispatched from Boise. Let's hope it's not snowing; they don't have four wheel drive. Without the formation of a new ambulance district, there will very likely be large periods of time where the ambulance is out of service, and no one is available to respond to emergency calls. I am

October 22, 2024

Present: Commissioners Clay Tucker, Bob Callahan and Lindy Lindstrom

Pledge of Allegiance

CONSTITUENT INPUT: An individual from east Boise County spoke about a meeting with COMPASS that she attended with Commissioners Lindstrom and Tucker the previous day. She said that joining COMPASS will be a "good thing" for Boise County and spoke about "Communities in Motion," which is a long-range plan for "where growth needs to happen."

MINUTES: A motion was said to approve the minutes from October 15, 2024. The motion carried. A motion was also said for the Special Meeting held on October 16th and the motion carried.

ROAD AND BRIDGE: A request was submitted to purchase a crane. Road Superintendent Curtis Dill explained that the crane had become available through surplus. Dill said it would assist with putting the sanders on the heavy equipment trucks and that "there have been some issues." Commissioner Lindstrom motioned to approve the request purchase of a crane in the amount of \$9,000. Commissioner Callahan seconded the motion and the motion carried.

INSULATION: Commissioner Callahan explained that spray foam insulation would be used, up to eight feet, for building maintenance and repair. Lindstrom motioned to approve insulation for the Idaho City Road and Bridge shop in the amount of \$27,980. All were in favor and the motion carried.

FORESTER: Lindstrom made a motion to approve reimbursement requests in the amount of \$76,156 for the Department of Lands for torch-fire payment. The motion carried.

PLANNING AND ZONING: A request from the Forest Service was received to wave

fees for a flood development permit. P&Z Administrator Alex Gross stated that the Forest Service was going to build a boat ramp near Banks, off of the Banks Lowman Road. Lindstrom said they wanted the commissioners to waive the \$100 fee. He then motioned to approve the request from the Forest Service to waive the fees for the flood development permit. The motion carried. Commissioner Callahan had additional questions regarding testing.

POLLING LOCATION AGREEMENTS: A motion was made for each of the Boise County polling locations and some of their associated costs. The motions carried.

SHERIFF: Sheriff Scott Turner spoke about radios and those currently in the vehicles. There were two types of radios discussed with quotes. Sheriff Turner said all the radios and installment costs were budgeted. Commissioner Lindstrom motioned to approve the radio quote in the amount of \$10,042. The motion carried. A vehicle update [perhaps for the K9 vehicle] was discussed and a motion made for \$32,302. The motion carried. Another motion was made to approve a quote in the amount of \$19,332. The motion carried.

Two Chevys and one Ford were discussed for purchase. Chairman Tucker asked if the Sheriff's Office was still trying to rotate three vehicles a year. Sheriff Turner said this was a competitive state bid and disclosed, "When I first took over as Sheriff, we paid off the leases and got rid of the leases, because of what it was costing the county in interest. What we were paying in lease payments far exceeded [the cost] to just purchase the vehicles outright. This is a lot better for taxpayers and we're not paying interest that we don't need to pay." Commissioner Callahan asked what would be done with the older trucks. Sheriff Turner responded, "A couple

trucks we're going to rotate out, to keep for spare trucks and then the spare trucks that we have currently, will be taken down and auctioned." The trucks were publicly auctioned through an auction house and the money made from that auction was put back into the Justice Fund, the sheriff reported. Commissioner Lindstrom motioned to approve the quote to purchase two Chevy 1500s and one Ford 1500 through Mountain Home Auto Ranch in the amount of \$144,986. Commissioner Callahan seconded the motion and the motion carried.

The Horseshoe Bend School District yearly SRO [School Resource Officer] contract was discussed. Sheriff Turner said nothing had changed in the contract. Commissioner Tucker asked about the Garden Valley SRO contract and said that they had approved it at the last school board meeting. The sheriff had not received the contract yet, or the Basin School District - Idaho City contract. Commissioner Lindstrom motioned to approve the Horseshoe Bend School District and Boise County agreement for a School Resource Officer for FY2025. The motion carried.

CLAIMS APPROVAL REPORT: Two reports were prepared, one for FY2024 and the other for FY2025. Lindstrom motioned to approve the Claims Report for FY24 in the amount of \$120,404. The motion carried. He then motioned to approve FY25 Claims Approval Report in the amount of \$213,200. The motion carried.

FIRES: Sheriff Turner addressed the current status of the fires, "All of the Type 1 fire teams within the county have transitioned back to local Type 3 district resources on all the fires. And they're just working on all their suppression line repair and rehab work." He said it was winding down, "It's been a long, long fire season." Commissioner Callahan agreed. Sheriff Turner said the

area closures are shrinking as they get work done.

EXECUTIVE SESSION: Chairman Tucker motioned to go into executive session under pending litigation. [Time 9:43am to 10:32am] No action

was required. No meeting will be held on November 5th, election day. Adjourned at 10:36am until October 29th.

| <p>IDAHO CONSTITUTIONAL AMENDMENT</p> <p>This proposed constitutional amendment provides that only Idaho residents who are citizens of the United States are eligible to vote in elections in the State of Idaho and that noncitizens are not eligible to vote in any election in the State of Idaho. Currently, Section 2, Article VI of the Constitution of the State of Idaho provides: "every male or female citizen of the United States, eighteen years old, who has resided in this state, and in the county where he or she offers to vote for the period provided by law, if registered as provided by law, is a qualified elector." This provision does not expressly prohibit noncitizens from voting. The proposed amendment adds language to provide that only United States citizens may vote in elections in the State of Idaho.</p> <p>Question: Shall Section 2, Article VI of the Constitution of the State of Idaho be amended to provide that individuals who are not citizens of the United States may not be qualified electors in any election held within the state of Idaho?</p> <p>A YES vote would approve the proposed Constitutional Amendment for additional language providing that only United States citizens may vote in elections in the State of Idaho.</p> <p>A NO vote would make no change to the Idaho Constitution.</p> <p><input type="radio"/> Yes <input type="radio"/> No</p> | <p>Measure to:</p> <p>(1) replace voter selection of party nominees with a top-four primary;</p> <p>(2) require a ranked-choice voting system for general elections.</p> <p>This measure proposes two distinct changes to elections for most public offices.</p> <p>First, this measure would abolish Idaho's party primaries. Under current law, political parties nominate candidates through primary elections in which party members vote for a candidate to represent the party in the general election. The initiative creates a system where all candidates participate in a top-four primary and voters may vote on all candidates. The top four vote-earners for each office would advance to the general election. Candidates could list any affiliation on the ballot, but would not represent political parties, and need not be associated with the party they name.</p> <p>Second, the measure would require a ranked-choice voting system for the general election. Under current law, voters may select one candidate for each office, and the candidate with the most votes wins. Under the ranked-choice voting system, voters rank candidates on the ballot in order of preference, but need not rank every candidate. The votes are counted in successive rounds, and the candidate receiving the fewest votes in each round is eliminated. A vote for an eliminated candidate will transfer to the voter's next-highest-ranked active candidate. The candidate with the most votes in the final round wins.</p> <p>Funding Source Statement: The Idaho Open Primaries Act will be funded by an augmentation of existing state and county expenditures for advertising and tabulation. Implementation of the act will require 1.) A public awareness effort to inform voters, candidates, and election workers about changes to the election process, and 2.) The purchase of ballot tabulation equipment capable of conducting instant runoff elections.</p> <p>Fiscal Impact Statement: Under this initiative, new software for tabulating ballots via instant runoff voting is needed; no federally certified software exists for this process, though there is open-source software for tabulation. We cannot estimate the cost of software for tabulation.</p> <p>Seventeen counties need to purchase an election management software at an estimated cost of \$300,000. Material costs for a May primary election have been above \$800,000. By 2026, the (inflated, population) adjusted value is \$1,600,000. Against Salmon River, Horseshoe Bend stat leaders were senior Aliyah Meyer with 15 kills, 2 aces, 16 digs and 14 assists; senior Aubree Zimmer with 10 kills, 2 aces, 11 digs and 1 assist; sophomore Celeste Wilson with 8 kills, 1 ace, 2 blocks, 4 digs and 2 assists; freshman Malia Goff with 5 kills, 1 ace, 4 digs and 21 assists; senior Ashlyn Wolsleben with 4 kills, 1 block, 7 digs and 3 assists; sophomore Libero Kimber Jones with 4 aces, 3 digs and 1 assist; and freshman Aubrey Penney with 1 block.

Back in McCall on Saturday, October 26, Horseshoe Bend went up against the Council Lumberjacks to secure both their Idaho State Championship berth and the 1A DII Long Pin Conference Championship! The Mustangs took the match 25-20, 25-21, 23-25, 25-19.

Statistical standouts were

Meyer with 16 kills, 3 aces, 1 block, 18 digs and 18 assists; Wilson with 12 kills, 2 blocks and 2 digs; Zimmer with 10 kills, 1 ace and 25 digs; Wolsleben with 6 kills, 2 aces, 19 digs and 1 assist; Goff with 5 kills, 1 ace and 15 digs; Libero Jones with 1 kill, 4 aces, 21 digs and 1 assist; and Penney with 1 block, 4 digs and 1 assist.

The Horseshoe Bend Varsity Mustang Volleyball team ended their season undefeated in the Long Pin Conference with a record of 14-0, and 27-5 overall.

The Mustangs will travel to Twin Falls for the Idaho 1A State Championship Tournament which begins on Thursday, October 31 at Canyon Ridge High School and concludes on Saturday, November 2. Horseshoe Bend will compete in match #2 against fellow Long Pin Conference rivals the Council Lumberjacks at 3:00 p.m. on October 31.

Football: The Mustangs took a loss, 70-0, at Tri-Valley against the Titans on Friday, October 25 in their last game of the season. Riddled by injuries to their starting lineup, the Horseshoe Bend Mustangs finished their season 0-5 in 1A DII Long Pin Conference play, 1-6 overall.

terminated. He saw his chance when one of the young ball boy/pickers didn't want to come to work all the time, so he "sub-contracted" Dylan, at the young age of 10, to do the picking work. After many weeks of picking balls, Brent (the pro at the time) came out and asked Dylan "Who the heck are YOU, and why are you picking the balls?" Dylan explained that he had been hired by the un-named "Real" picker.....Brent just laughed and said that it was crazy that he was doing the ball picking job at a cut rate, and hired him on the spot with full pay. Finally - he nailed his first goal - a REAL JOB at Terrace Lakes.

And yet, Dylan was restless - he needed more -- he coveted the job of working the course for Destry Jones, the Superintendent, where he could run the BIG equipment. The time finally came and armed with his newly minted driver's license, he joined the grounds crew - a spot he continued to hold as time permitted clear up through this year.

It was around this time that Dylan got the notion of wanting to make the Golf experience his life/professional goal. He was preparing for his next chance to spread his wings.

His years of school in his small valley were some of the best. He made lifelong friends

of not only his peers, but their parents - he continued to thrive in the "village" that raised him. He felt so blessed to live and grow in his beautiful mountain home. Excelling in football, basketball, and golf- he loved being part of the team.

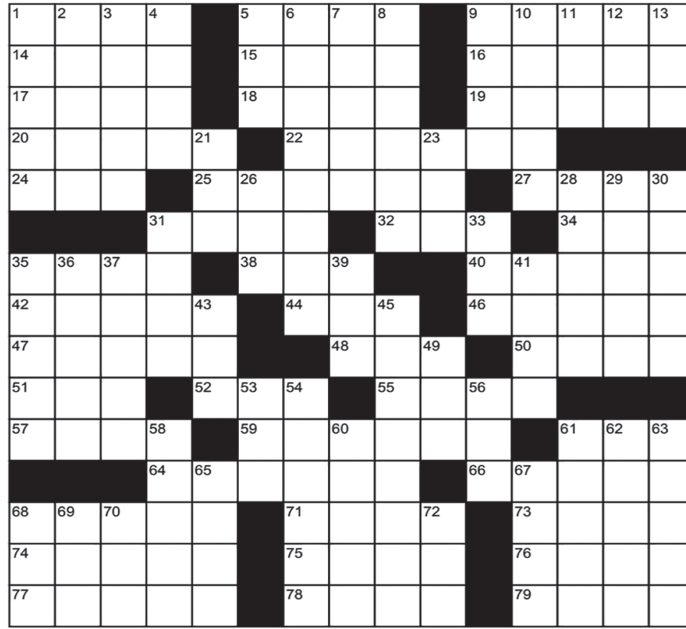

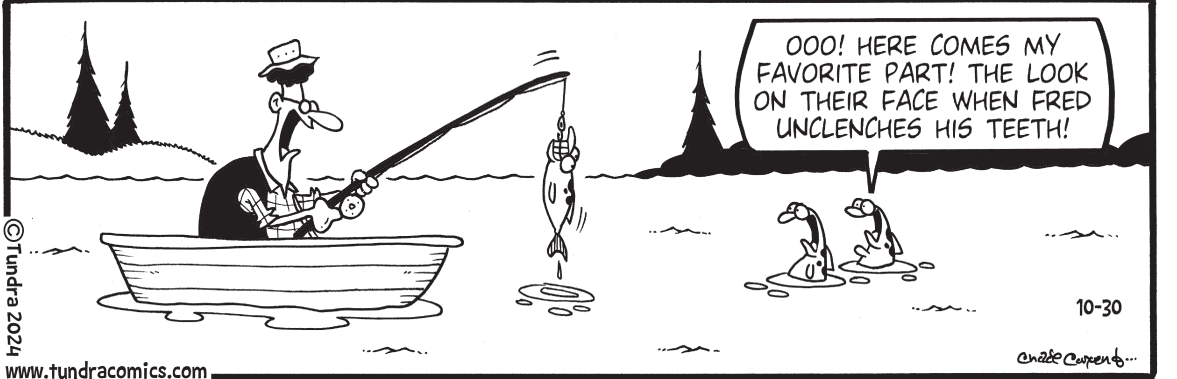
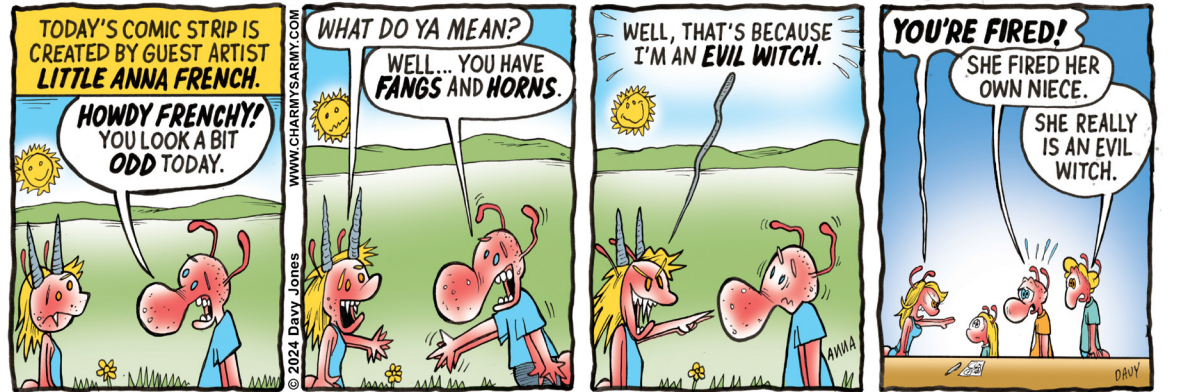

Proposition 1 does two things: it creates ranked choice voting and is requires open primaries. We've all seen ads urging us to vote NO on Prop 1 because "ranked choice vot-

ing will turn Idaho blue." This is disingenuous nonsense. It will do no such thing. Ranked choice voting doesn't change a red vote blue. Only the voter can do that. How many Republican voters will suddenly vote for Democrats because ranked choice voting is enacted?

The people who want you to vote No on Prop 1 are actually afraid of something else, namely open primaries. Dear Editor,

I have been looking for a format to generate discussion regarding the termination of East Boise County Ambulance Taxation District and the creation of the East Boise County EMS District. The purpose of this change is to raise the tax levy to solve a financial insolvency problem. I think a very good argument can be made that EBCAD has been chronically mismanaged for many years. I don't believe more taxes and more government ever solve a problem. I did my first EMT shift with Mores Creek Ambulance in 1995. I have run dozens of Boise County EMS calls between then and now. Early intervention is the key factor in a medical emergency. In Boise for example, the average response time for a Fire Fighter EMT or Fire Fighter Paramedic is four minutes followed by a transport ambulance / Paramedic in eight minutes. EMTs provide very limited and basic medical interventions. Paramedics pro-

vide advanced life support that includes pain medication, cardiac drugs, and a host of other advanced options. Air medical provides ALS support. I would argue that every EBCAD response is far in excess of that response time and I would also argue that all the money in Boise County would only marginally reduce response times.

Most ambulance calls are not life-threatening emergencies, and if they are, air medical is automatically dispatched depending on weather and availability. The local fire department will set up a landing zone and transport the medic to the patient, or vice versa. My family and neighbors know that in a medical emergency find private transport, call 911, and request a rendezvous with air medical at the landing zone or with Ada County's EMS system at the county line.

The new district will most likely have only an insignificant impact on ambulance response time, which are highly extended in every occurrence. It will not increase or change the level of care you receive when you call the ambulance. State law says that the responsibility for Emergency Medical Services fall on the individual County and therefore its commissioners. What it would do is create another level of bureaucracy with an additional governing body and take the elected County Commissioners off the hook and removing

their control for County EMS services.

I am not saying the new District is a bad idea, but as with any decision a cost benefit analysis must be considered. The persons receiving the greatest benefit from this change and contributing the least are the uninsured and the transportation challenged in East Boise County. Often EBCAD is paged out for individuals that find it the easiest and most reliable way to get to town.

I recognize the infrastructure is crumbling and volunteer EMTs are difficult to retain. I attribute these issues to years of mismanagement, a lack of vision, and a lack of management flexibility. The EMS system at present is made up of caring and compassionate people. I believe with an all-inclusive mentality and a team approach EMS in east Boise County will succeed and grow. The new EMS system is much like electric vehicles, they are a great idea and a personal choice, but when they become a practical solution, it will be obvious. I am not in favor of growing a dysfunctional system.

I realize this will create a great deal of negative emotions and my greatest hope is it will be treated as my opinion and not as a personal attack on persons or systems or the position of any of my group affiliations.

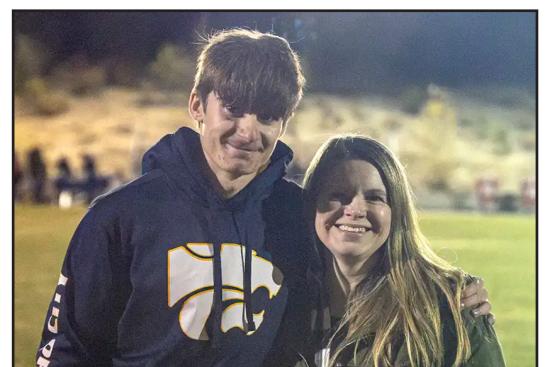

The proposed amendment adds language to provide that only United States citizens may vote in elections in the State of Idaho.</p> <p>Question: Shall Section 2, Article VI of the Constitution of the State of Idaho be amended to provide that individuals who are not citizens of the United States may not be qualified electors in any election held within the state of Idaho?</p> <p>A YES vote would approve the proposed Constitutional Amendment for additional language providing that only United States citizens may vote in elections in the State of Idaho.</p> <p>A NO vote would make no change to the Idaho Constitution.</p> <p><input type="radio"/> Yes <input type="radio"/> No</p> | <p>Measure to:</p> <p>(1) replace voter selection of party nominees with a top-four primary;</p> <p>(2) require a ranked-choice voting system for general elections.</p> <p>This measure proposes two distinct changes to elections for most public offices.</p> <p>First, this measure would abolish Idaho's party primaries. Under current law, political parties nominate candidates through primary elections in which party members vote for a candidate to represent the party in the general election. The initiative creates a system where all candidates participate in a top-four primary and voters may vote on all candidates. The top four vote-earners for each office would advance to the general election. Candidates could list any affiliation on the ballot, but would not represent political parties, and need not be associated with the party they name.</p> <p>Second, the measure would require a ranked-choice voting system for the general election. Under current law, voters may select one candidate for each office, and the candidate with the most votes wins. Under the ranked-choice voting system, voters rank candidates on the ballot in order of preference, but need not rank every candidate. The votes are counted in successive rounds, and the candidate receiving the fewest votes in each round is eliminated. A vote for an eliminated candidate will transfer to the voter's next-highest-ranked active candidate. The candidate with the most votes in the final round wins.</p> <p>Funding Source Statement: The Idaho Open Primaries Act will be funded by an augmentation of existing state and county expenditures for advertising and tabulation. Implementation of the act will require 1.) A public awareness effort to inform voters, candidates, and election workers about changes to the election process, and 2.) The purchase of ballot tabulation equipment capable of conducting instant runoff elections.</p> <p>Fiscal Impact Statement: Under this initiative, new software for tabulating ballots via instant runoff voting is needed; no federally certified software exists for this process, though there is open-source software for tabulation. We cannot estimate the cost of software for tabulation.</p> <p>Seventeen counties need to purchase an election management software at an estimated cost of \$300,000. Material costs for a May primary election have been above \$800,000. By 2026, the (inflated, population) adjusted value is \$1,600,000. a volunteer EMT for East Boise County Ambulance District (EBCAD), and I live and work and pay taxes in Boise County. And I am asking you to please **VOTE YES** for the formation of a new ambulance district.

EBCAD is bankrupt. After all tax payments and collecting fees for transporting patients are put into our coffers this fiscal year, we will not have enough money to pay all the bills we will have this year for staff, to maintain the fleet, and to ensure we have life-saving equipment and medications at the ready. Recently, to repair ambulances that have broken down, we have sought out grants and donations in order to get them back in service. More importantly, because the district does not have enough money to pay staff to keep the ambulance in service, it relies heavily on us volunteers to provide emergency medical care in over 2/3 of Boise County. Currently, there are only 11 of us that are putting in the time to ensure the Ambulance is staffed. We love providing this service and serving our community. But we are tired. We are burnt out. We get texts, emails, and calls every day begging us to run shifts to ensure the ambulance stays in service and our Director of Operations can have a night off. We do what we can, but it is not enough. There is a crisis of volunteerism in America that all volunteer-reliant districts are struggling to overcome. EBCAD is no different. And to be clear, neither the current governing board nor the paid staff were present when the financial problems started; they are trying to fix them.

Enough doom and gloom; what is the solution? The new East Boise County EMS District! This initiative, started by the Boise County Commissioners (who are the current EBCAD governing board), will result in the dissolution of the current EBCAD taxing

district and the formation of a new taxing district, the East Boise County EMS District (EBCED). The new district will replace the old district (and inherit the equipment and property) and will help to ensure continuity of ambulance service in East Boise County with new commissioners to steer the ship. Yes, this new district means slightly higher taxes. Currently, property owners pay approximately \$13 for every \$100,000 in assessed value after all exemptions. But, if a new district is formed on a majority yes vote, then Idaho Code limits the levy rate to \$40 for every \$100,000. That is the maximum a new board would be able to collect from property owners; and the budget may not even be that high. Seems like a small price to pay to make sure help is on the way when you need it.

The new district would ensure 24/7 coverage of the ambulance by paid staff. Yes, volunteers like myself will still be needed for larger events, to put multiple ambulances around the county in service in peak times, and to supplement the paid staff; but the staff will be able to work their 40 hours and be done. Not kill themselves like they have been doing for years to ensure our safety. And it would allow us volunteers to feel better about saying no and living our lives when we can't be on call. Additionally, EBCED will have new, elected commissioners that are dedicated to emergency medical services and will ensure responsible fiscal policies with an eye towards the future. And perhaps most importantly, it will provide us comfort to know that when our loved ones are on the road, perhaps driving to town every day for work like my wife does, if something happens and they call 911, the answer will be "help's on the way." Please **VOTE YES** on November 5.

BOISE COUNTY -- According to Boise County Clerk Mary Prisco, there has been a record number of voters turning out for early voting. At the Boise County office in Idaho City, Election Clerk Valerie Dresslar had the foresight to set up five voting stations. There continues to be a steady stream of voters filling each of those stations. Clerk Prisco estimated that by 1pm on Tuesday, approximately 460 people

had taken advantage of the early voting. She added that this number does not include the numerous absentee votes that have also been received.

This provision does not expressly prohibit noncitizens from voting. Under current law, political parties nominate candidates through primary elections in which party members vote for a candidate to represent the party in the general election. The initiative creates a system where all candidates participate in a top-four primary and voters may vote on all candidates. The top four vote-earners for each office would advance to the general election. Candidates could list any affiliation on the ballot, but would not represent political parties, and need not be associated with the party they name.</p> <p>Second, the measure would require a ranked-choice voting system for the general election. Under current law, voters may select one candidate for each office, and the candidate with the most votes wins. The candidate with the most votes in the final round wins.</p> <p>Funding Source Statement: The Idaho Open Primaries Act will be funded by an augmentation of existing state and county expenditures for advertising and tabulation. Implementation of the act will require 1.) A public awareness effort to inform voters, candidates, and election workers about changes to the election process, and 2.) The purchase of ballot tabulation equipment capable of conducting instant runoff elections.</p> <p>Fiscal Impact Statement: Under this initiative, new software for tabulating ballots via instant runoff voting is needed; no federally certified software exists for this process, though there is open-source software for tabulation. Material costs for a May primary election have been above \$800,000. By 2026, the (inflated, population) adjusted value is \$1,600,000.
