Valley Fire Threatens Homes in East Boise County

EAST BOISE COUNTY -- The Valley Fire started in the early morning hours of October 4th in Ada County and burned several thousand acres before approaching the Boise County Line; threatening the Robie Creek area. In response to the threat, Boise County Sheriff's Office, Robie Creek Fire, and Wilderness Ranch Fire mobilized to prepare for evacuations if needed; while also supported by East Boise County Ambulance, Idaho Mountain Search and Rescue, and Boise County Search and Rescue, ISP, WR Fire Department Auxiliary,

and others. Clear Creek and Thorn Creek Fire Departments both had themselves placed on standby to help support if needed. Idaho City Fire Department kept close tabs as well. The sheriff working with the incident placed the Robie Creek area into Stage 2 (Set) Evacuation Orders and the Wilderness Ranch area up to Daggett Creek, into Stage 1 (Ready). Fortunately, we never had to pull the trigger on Stage 3 (Go). Robie and Wilderness Ranch Fire Departments helped with notifications and begin setting up stable water sources throughout the Robie Creek area to prepare for struc-

On Friday afternoon, October 4, IMSARU was called out to support fire operations in Boise County as the Valley Fire quickly grew to over 7,700 acres. The Robie Creek area was quickly escalated to a Level 2 evacuation order, with Wilderness Ranch at a Level 1. The Boise County Sheriff's Office requested that IMSARU deploy teams into those areas to go door-to-door to every residence and ensure that they were fully aware of the order and to make preparations for evacuation. By 4:00PM, five vehicle teams consisting of off-road vehicles and UTVs were quickly deployed into two divisions with mapped assignments. The lead vehicles in each case were equipped with Starlink and radio communications to coordinate the exercise with incident command and ensure no residences were left out of the alert.

ture protection. When notifications were complete, crews monitored the fire through the night and into the next day. A cold front moved through the area, bringing higher winds to the fire, causing a slight increase in fire behavior.

That night a fire started near the high bridge, prompting our resources to respond, even though it was in Ada County, it further threatened the Robie Creek area if left to burn into the main Valley Fire. It was caught at around 3 acres or so. Around midnight, most of our resources were able to go home, though we kept an engine on patrol through the night. This engine ended up assisting in some structure protection between hilltop and the high bridge, as the main fire made its way to those structures. The Valley Fire Resources also remained on the fire through the night.

Saturday, October 5th, we kept two engines on patrol through the day to monitor the fire progression. The incident management team for the Valley Fire was able to retain the aircraft they had the first day and bolster their ground resources to get a significant amount of work done on the Boise County side of the fire. They hit it hard with air resources and strategically placed dozers and hand crews to help contain the fire.

After Saturday, things were looking far better prompting Boise County to downgrade the evacuation orders. Thankfully, we had the agency resources we did on this incident, as this is the time of year agency re-

sources become limited. Many crews are being laid off and air resource contracts are ending. As time goes on through the fall, we will have less and less agency support around, but the weather is still warm and dry, so please be careful and stay alert to help ensure a prompt response to any new fire.

Our emergency notification system largely relies on you having power or some type of phone/internet service in order to receive alerts. Evacuation orders are backed up by door-to-door notifications as well. With the power down to part of Robie Creek during the incident, it is likely many residents didn't get the initial notifications. I encourage you to invest in either landlines or backup power supplies that can keep internet access up if you rely on internet for phone service. This will help ensure you get timely notifications and updates during these types of incidents. We are always working on improving these systems, but they are mostly reliant on the grid at this point. We will of course do our best to do an in-person notification to every residence in these events. Luckily, we have had the time to push notifications and go door-to-door before fires have reached communities this year, but it is always possible for a fast-moving fire to start in the middle of a community, prompting evacuations and leaving us little time to get notifications out and reach all residents before a community is impacted, so we ask that you do your best to keep your

Continuation of September 26, 2024

COMMUNITY JUSTICE DEPARTMENT: Amanda Leader said there would be a few people providing community service for the upcoming Idaho City Days event.

ROAD DEPARTMENT: Curtis Dill said there had been a good community meeting regarding the progress on the Gardena Bridge. He said they are still down two hires, one in Horseshoe Bend and the other in Garden Valley. However, they did hire one person for Garden Valley earlier in this meeting.

SOLID WASTE: Kirk McGee said they have been pretty busy.

FORESTER: Jordan Jones said there were some projects to reduce slash with the chipper around Lowman, and work to be done around Castle Mountain and Terrace Lakes in Garden Valley. He has also been working with Fire Chief Colton McCarthy for Wilderness Ranch to provide community outreach.

SHERIFF: Sheriff Scott Turner reported that the fires were winding down and that there were no more community meetings. He said the fire closures were starting to open up.

PLANNING AND ZONING: Alex Gross said the county was going to start doing inspections for Idaho City. He said people are trying to get their building done quickly before the snow flies, so they are trying to get inspections done. There are more building permits still being received.

Gross noted that the Boise National Forest gave approval for the CuMo Mine to do their exploratory drilling. He said, "I think we should be having conversations with them about what that's going to be doing to our roadway." There will be an objection period provided by the Forest Service.

Gross also said that most of the building materials had been purchased to do half the roof of the P&Z building, along with the skirting.

CLERK: Clerk Mary Prisco spoke about the FY2024 claims to be paid though the end of October.

Their office is working on compensation statements for each employee. They are also getting a lot of absentee requests to vote, so they have been sending those out.

EAST BOISE COUNTY AMBULANCE: Mari Adams

thanked the board for the "amazing" heating and air conditioning system they had installed. The volunteers are very grateful and excited about it. Adams says their call volume is still up and they are "responding to a lot of calls."

EXECUTIVE SESSION: Alex Gross suggested going into executive session to discuss "risk management and personnel" issues for the county. [Time 10:27 - 11:16am] Coming back into session there was no action required.

OPENING OF THE 2024 BUDGET PUBLIC HEARING: Clerk Prisco said this was done annually and it was "basically a formality" to pull all the budget resolutions made during the fiscal year into one document. It covers expenses and revenues. Chairman Tucker asked Prisco to "explain how the resolutions change the original budget to the amended budget." She spoke to how grants would be considered a revenue, and then explained reserve funds, etc. There were no public comments.

Commissioner Lindstrom motioned to approve Resolution 2024-47 and the motion carried.

EXECUTIVE SESSION: A motion was said to discuss appointed Robie Creek Fire Department Commissioners, "to hire employees." [Time 11:26 - 11:32am] Commissioner Lindstrom motioned to appoint or approve three commissioners for the Robie Creek Fire Protection District - Zone 1 Nathan Bowers, Zone 2 Valerie Dresslar, and Zone 3 Ted Frisbee. Lindstrom followed by saying, "All of our candidates were good... We thought all of them were very qualified and hope that they continue to participate in the Robie Creek Fire District." All were in favor and the motion carried.

PUBLIC HEARING: The East Boise County Ambulance District opening of the FY2024 budget. Clerk Prisco said they only had one budget amendment the entire year, in the amount of \$6,630. This was a grant awarded to fix the ambulance. There was no public comment.

There was a motion to approve Resolution FY2024-05 and the motion carried.

Although the notices were not published in the Idaho World newspaper, some notice was given by the board of county commissioners of the public hearings in their agenda

and they found that the closing was "as nearly practical as possible."

Adjourned at 12:37pm.

CONSTITUENT INPUT: None

MINUTES: A motion was said to approve the minutes from September 26, 2024. The motion carried.

ELECTIONS: Approval of the polling places for the General Election was discussed by the clerk, and Chairman Tucker mentioned that all the locations would be the same again for this election. Commissioner Lindstrom motioned to approve the polling locations for the November General Elections. The motion carried.

SOLID WASTE: A motion was said to approve the Starlink internet setup for the solid waste department.

SHERIFF: A federal drug reimbursement purchase was discussed. Sheriff Scott Turner explained, "Every year the DEA and Forest Service, they reach out to us, ask us if we want to participate in - we fly around the county, looking for marijuana grows and that type of thing." Turner said the money would be used to buy binoculars for the patrol officers. Sheriff Turner added that it was kind of like a grant and had 100% reimbursement. Lindstrom motioned to approve the federal drug reimbursement purchase and the motion carried.

AGREEMENT: An agreement to work on the Gardena Bridge design and replacement was discussed by Boise County Road and Bridge Director Curtis Dill. Commissioner Lindstrom motioned to approve the agreement between Boise County and the Local Highway

Technical Assistance Council (LHTAC). The motion passed.

IDAHO TRANSPORTATION DEPARTMENT: Dill said he would like to work with ITD's program to get used equipment. Lindstrom motioned to approve the ITD letter request. The motion carried.

ADA COUNTY JAILING AGREEMENT: Sheriff Turner explained that this was the yearly housing agreement with Ada County; however, the costs per day had increased \$4 or \$5. "The price of doing business is still cheaper than maintaining our own jail," Turner said. "We still pay for anybody that has to have medical treatment, but again, what would it cost the county for insurance if we had our own jail? It would be significant, along

with the liability. To spend a couple thousand dollars a year to house our inmates, verses probably roughly a million and a half." He estimated it would take about a million and a half to operate and staff a jail within the county. Lindstrom said, "It think it's a good deal for Boise County," and Commissioner Callahan agreed. Sheriff Turner went on to say, "We're still saving taxpayers' money and the liability is on Ada County." Commissioner Lindstrom motioned to approve the Ada County Sheriff's Office Jail Inmate Housing Agreement. The motion carried.

E911 GRANT: Sheriff Turner explained that they would be receiving a grant to replace

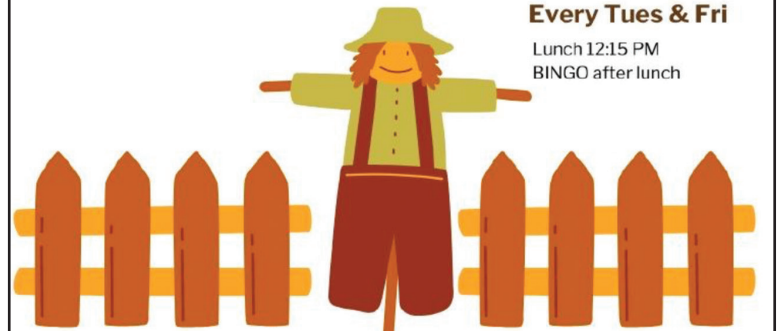

computers and perform additional maintenance for dispatch. He said this will go a long way in supporting the 911 system. He added that there were no strings attached to the grant.

Lindstrom motioned to approve the Idaho Public Safety Communications Commission grant. All were in favor and the motion carried.

FEMA EMERGENCY GRANT: A 2022 grant was discussed by the clerk, and it was decided that it should be closed out. Lindstrom motioned for the Emergency Management 2022 FEMA grant to be closed out. The motion carried.

GOOD NEIGHBOR AGREEMENT: Forester Jordan Jones spoke about reporting the spending of \$600,000, separate from the \$75,000 that was given in the first modification. Lindstrom motioned for the Forester Modification Good Neighbor grant and the motion carried.

CATERING PERMIT: A motion was said to approve a catering permit for a wedding and the motion carried.

COMMISSION OF THE AGING: Their board for the Commission of the Aging asked that a commissioner sit on their board. Lindstrom volunteered and said, "If it means something more for our seniors in Boise County, I'm willing to do it." Chairman Tucker motioned to nominate Commissioner Lindstrom for the Southwest Idaho Area Agency on Aging board. The motion carried with the support of Commissioner Callahan; Lindstrom abstained.

EAST BOISE COUNTY AMBULANCE DISTRICT: EBCAD Director Mari Adams said the two heart monitors, attachments, and supplies were covered under a grant. The match was paid for by dona-

tions. Commissioner Lindstrom motioned to approve the demand warrant for a medical supply company in the amount of \$93,164. The motion carried.

Adams reported that the Unit 15 ambulance has an antifreeze leak and is going back into the shop because the headlight is "smoking really bad from it burning." She is hoping that the shop will cover the cost for their mistake.

EXECUTIVE SESSION: This closed meeting was to discuss a personnel issue. [Time 9:43 - 10:36am] Lindstrom motioned to approve the payroll changes that were discussed in executive session. The motion carried.

EXECUTIVE SESSION: Chairman Tucker motioned to go into executive session to discuss risk management. [Time 10:39 - 11:25am] No action was required.

EXECUTIVE SESSION: Chairman Tucker motioned to go into executive session to discuss "acquiring real property." [Time 11:26 - 12:10pm] Coming back into session, Tucker said there was no action required.

FUTURE AGENDA ITEMS: Clerk Prisco discussed a few items for the agenda. The week of the election there may not be a scheduled commissioner's meeting because the clerk's office will be very busy. She said that on Tuesday they may be there very late or there through the next day. Lindstrom suggested holding a meeting only if it's an emergency.

On October 9th, Idaho City is hosting the Idaho Association of Counties, District 3, meeting at the Ray Robison Community Hall building. Prisco asked for a count of elected officials that planned to be in attendance.

Adjourned until Tuesday, October 8th.

The team traveled 220 miles on Saturday, 10/5 to take part in the "I Pink I Can" tournament at Butte County High School in Arco. In pool play the team defeated Sun Valley Community Schools, Challis and Rockland, but fell to hosts Butte County.

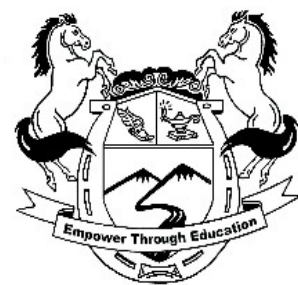
In bracket play the Lady Mustangs came out on top against Challis but lost to Rockland, which ended further competition for the team. Coach Sharsti Moore said, "Overall, a long day of volleyball with a lot of good competition. We battled, we learned, we grew. Onward and upward from here."

GARDEN VALLEY -- On Friday, Sept. 27th, the Wolverines were close up until the half, but then the game kicked up a notch. The Wolverines blew past the Salmon River Savages, 56-26 at home. Fans of the Wolverines have seen this all before: every one of the games they've played this season has ended in a blowout of 20+ points.

Garden Valley didn't go easy on the quarterback and picked off two passes before the game was over. The picks came courtesy of Cody Perrin and Maxon Yearsley. What's more, Yearsley also racked up 96 rushing yards, the most he has had since back in September of 2023.

Community Levies and Grants Enhance Education Amid Funding Gaps at Horseshoe Bend School District

HORSESHOE BEND --

Public schools in Idaho conduct levy elections to secure additional funding for vital programs and services that state funding does not fully cover. These levies can help schools finance salaries, classroom supplies, technology, extracurricular activities, and other operational expenses. The funding for education in Idaho largely depends on state funding formulas, which often do not adequately address the unique needs of individual districts, like the Horseshoe Bend School District. By participating in levy elections, local communities can directly support their schools, helping to ensure that students receive a quality education despite budget challenges. Idaho law requires local school boards to obtain voter approval for these additional funds, making the success of many essential programs and services reliant on the outcome of these elections. Typically, Horseshoe Bend seeks community approval for a levy every two years. As a rural community, Horseshoe

Bend faces unique challenges that differ from those in urban Idaho schools. For instance, extracurricular activities such as sports often require longer travel distances for students. This travel is not funded by the state, placing additional financial burdens on the district. Furthermore, school districts often struggle with insufficient funding for support staff, including cafeteria, maintenance, custodial, and paraprofessional staff.

While levies help bridge some of the funding gaps, they are restricted to the specific purposes outlined to voters. This is where grants become invaluable. Grants can provide necessary funding for essential supplies, technology, and educational materials that the district may lack due to budget limitations. They can also support the development or expansion of programs like Career & Technical education, art education, STEM initiatives, facility improvements, and extracurricular activities that enhance student engagement and learning. During the 2023-2024 and 2024-2025 school years, mem-

bers of the Horseshoe Bend School District staff have successfully applied for the following grants: Idaho Career Ready Students-CTE building expansion and upgrading welding/woodworking equipment and tools (\$500,000); Secure Our Future Phase 1 & 2 - Improve campus security by installing perimeter fences and

gates, increase campus signage, upgrade security cameras and radios and install electronically-controlled exterior doors to all student-occupied buildings (\$239,000); EPA Clean Bus Grant (\$200,000); Strengthening Communities (\$150,000); and Office of Drug Policy (\$80,000) - Community education courses including before, during, and after school activities to promote drug-free lifestyle; St Luke's Foundation for Health PreK Grant - Extending our PreK program including salaries, professional development, field trips, curriculum and supplies (\$50,000); Digital Content and Curriculum - Elementary reading/writing curriculum and diagnostic assessments (\$50,000); Healthy Schools - Part-time nurse (\$120,000: \$40,000 for three years); Vape Detector Pilot Grant - Vape detectors in all bathrooms and locker rooms, including installation and licenses (\$38,000); Expanding Arts Access in Rural Public Schools - Art supplies and equipment (\$30,000); Steele-Reese Foundation - Community school efforts including the purchasing of supplies, paying for medical treatments for the underinsured and/or uninsured students, senior meals, and others (\$18,000); HOPE Grant - Community school efforts to provide students with positive childhood experiences including after school activities, family outings, and field trips (\$16,925); Idaho STEM Action Center and Micron - Esports and coding classes and software (\$15,000); Office of Drug Policy Substance Abuse Block Grant (\$10,000);



and Partnership for Success (\$7,500) - Community school efforts to provide mental health and addiction support for the underinsured and/or uninsured students.

When asked about the number of grants coming into the district, Superintendent Dennis Chesnut said the following, "Our staff has done a tremendous job in finding and successfully applying for these grants. Most grant applications are very extensive, take a lot of time to write, and are quite competitive, so success is no guarantee. They do most of the grant writing outside of their contractual hours, meaning they are generally donating their time to help our students, school, and community. The reality is, state and federal funds are not sufficient to provide our students with the positive educational experience they deserve. Our patrons have generously supported a supplemental levy which helps provide funds for areas not covered by grants (athletics, student resource officer, staffing, building maintenance, etcetera, and we are determined to continue finding alternative sources of funding for areas not covered by state, federal, and local funds." By strategically applying for and utilizing grants, underfunded schools like Horseshoe Bend can enhance their educational offerings and better support their students.

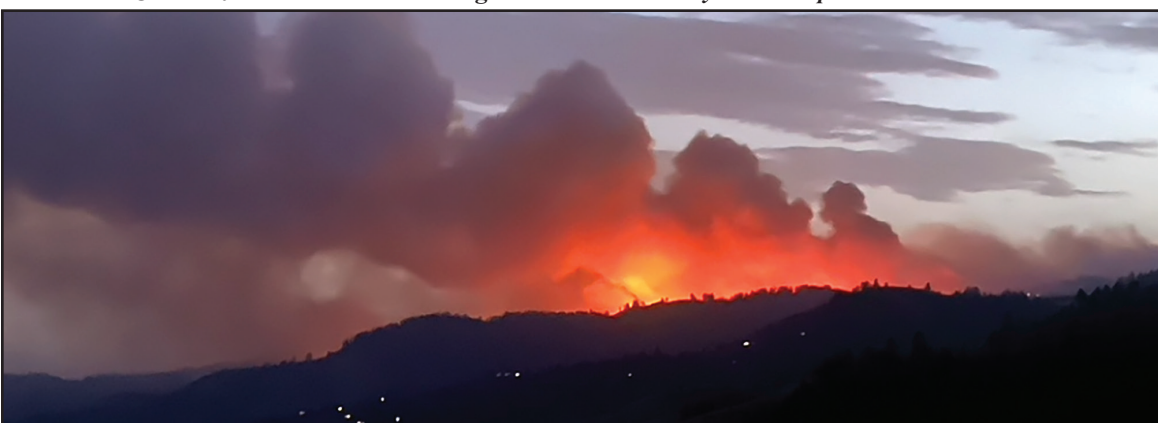

ORDINANCE NO. 272

AN ORDINANCE OF THE CITY OF HORSESHOE BEND, IDAHO, AMENDING SECTION 4, CHAPTER 5, TITLE 1, HORSESHOE BEND CITY CODE BY AMENDING SUBSECTION A AND B, MAYOR AND CITY COUNCILMEMBERS SALARIES; DIRECTING THE CLERK TO ASSIGN THE NEXT ORDINANCE NUMBER AND SCHEDULE FOR PUBLICATION AND CODIFICATION; AUTHORIZING PUBLICATION BY SUMMARY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Horseshoe Bend, Idaho, is a municipal corporation organized and operating under the laws of the state of Idaho; and

WHEREAS, pursuant to title 50, Chapter 3, Idaho Code, the City has the authority to adopt, establish and amend its municipal code; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HORSESHOE BEND, BOISE COUNTY, IDAHO, as follows:

Section 1: That Title 1, Chapter 5, Section 4 "Salaries": of the Horseshoe Bend City Code be, and hereby is, amended as follows:

CHAPTER 5: MAYOR AND CITY COUNCIL 1-1-5-4: SALARIES:

The salaries of the mayor and of the members of the city council shall be as follows:

A. Mayor: The mayor shall receive a monthly salary of four hundred dollars (\$400.00).

B. City Council Members: Each member of the city council shall receive a monthly salary of two hundred dollars (\$200.00). (Ord. 272, 9-11-2024)

Section 2: Severability. If any

section, subsection, clause or phrase of this Ordinance is held by a court of competent jurisdiction to be invalid, such decision shall not affect the remaining portions of the Ordinance.

Section 3: Repealer. All previous ordinances, resolutions, orders, or parts thereof, in conflict herewith are hereby repealed, rescinded and annulled.

Section 4: Ordinance Number; codification. The City Clerk is hereby directed to assign the next ordinance number in sequence and schedule this Ordinance for publication and codification.

Section 5: Effective Date; Publication. This Ordinance, or a summary thereof in compliance with Idaho Code 50-901A, shall be published once in the official newspaper of the City, and shall take effect immediately upon its passage, approval and publication.
