Celebrating Boise County Veterans in Idaho City

BOISE BASIN -- Idaho City's VFW Post 142 Commander Jim White addressed the students of the Basin School District. White held up a photo of himself as an 18-year-old, sharing that it was taken 56 years ago. He also held up a

helmet that he had worn in Vietnam, which would later be viewed by students over at a display table with military gear and other memorabilia. White mentioned each of the six branches of the armed forces: Army, Navy, Marine Corps, Air Force, Space Force, and the Coast Guard. White said, “The Coast Guard kind of gets left out of the equation,” so it was decided this year that VFW Junior Vice Commander Steve McCade would be invited to the podium to represent the Coast Guard.

“The Coast Guard originally started out in 1790,” McCade said. “We were responsible back then for keeping pirates and contraband and for keeping stragglers off our coasts.” After WWI, the branch was respon-

sible for escorting convoys over to England and France, and they also protected the east coast in U-boats, or naval submarines. The Coast Guard was heavily involved in WWII. McCade followed this brief

history with his personal experience in the Coast Guard and discussed how veterans had recently been invited into the school to offer a “bootcamp” for 7th, 8th, and 9th grade students. An obstacle course was set up in the gymnasium and drills were run. McCade asked the graduates of this camp to stand and offered them some applause. He expressed hopes to hold the camp again next year and concluded by exclaiming the Coast Guard motto: “Semper Paratus” — Latin for “Always Ready.”

Idaho Senator Geoff Schroeder followed by explaining the reasoning behind Veterans Day, “The 11th hour, the 11th day of the 11th month is known as Armistice Day.” It was the day marked to celebrate the end

of WWI and the horrific fighting. In 1954, President Dwight Eisenhower signed a bill to proclaim Veterans Day, “a day to honor those that have served in our armed forces and were honorably discharged. That’s what today is about.” Schroeder spoke of how he joined the

Idaho National Guard to help pay for college and through this experience came to realize “we carry a connection to the past... an integral part of our nation’s defense.” He was deployed and served in Iraq. Senator Schroeder spoke from experience of the importance of a free and fair election. Although he lost in the Primary Election in May, he wished his opponent well. He emphasized, “It’s this process, the process of having free and fair elections, that we fight for.”

Senator Schroeder discussed the importance of a good education to qualify for the armed forces. “Although we owe a debt of gratitude to veterans

that served, we also owe a debt of gratitude to teachers and educators who made it possible for them to serve.”

Airman Gillis spoke about his service and experiences in the U.S. Air Force over 24 years. He said, “The underly-

ing reason why people join the military, why people serve our country, is because we truly do have the best country on this planet. The Constitution of the United States is a beautiful document... The ability for this country to grow and become better is something that is worth defending and it’s something worth fighting for, and it’s the reason why people sacrifice their time away from their families.” Gillis concluded by saying, “Living in Idaho City is a privilege because of the support that you give our veterans. And without community support, we can’t go do our jobs... [Thank you] for allowing us to serve you.”

HORSESHOE BEND -- After taking the 1A DII long Pin Conference championship title the Horseshoe Bend Lady Mustang Varsity Volleyball team traveled to Twin Falls to take part in the 1A Idaho State Tournament at Canyon Ridge High School. The team took the floor against Long Pin Rivals, the Council Lumberjacks, on day one of the contest and

took the win 25/20, 25/14, 25/15. On day two, the Lady Mustangs battled Mackay Miners and came away with another win, 25/16, 14/25, 25/13, 25/23. On day three of the state tournament, Horseshoe Bend played three matches. The first, against the Grace Lutheran Royals, resulted in the Mustang's first loss of the tournament, 18/25, 22/25, 22/25,

which forced the team to fight their way back to the championship round by defeating the Rockland Bulldogs, 17/25, 25/20, 18/25, 25/12, 15/12 in a five game showdown. Facing the Royals once again in the final match of the tournament, the Lady Mustangs fell short, 25/23, 25/12, 25/23, and finished in second place.

Mercantile Construction Uncovers Treasures of Archeology

IDAHO CITY -- The Mercantile on Main Street has been in the process of renovation since Brent and Pam Adamson bought it four years ago. Pam Adamson said, "we are always organizing projects and striving to restore the beauty of this old building and its history."

The Adamsons recently hired trained bricklayers to work on the outer wall and secure the foundation. While the bricklayers were digging, they felt like archeologists as they discovered many buried treasures. Metal locks, antique mule shoes, and pottery were found, among other items.

Inside the building, when the wooden boards were removed, the bricklayers discovered plaster, paint, two layers of wallpaper, and finally the bare bricks which were in need of enforcement.

The basement of the Merc, once used for storing freight and supplies, has a large wooden door to Main Street and a large open area which has been reinforced with new wooden beams. This will now be open for viewing.

Pam Adamson has gathered antique historical items and curated a display which will be located near the front door on Main Street. Visitors will be able to view these artifacts when the doors are open and read the history of the building.

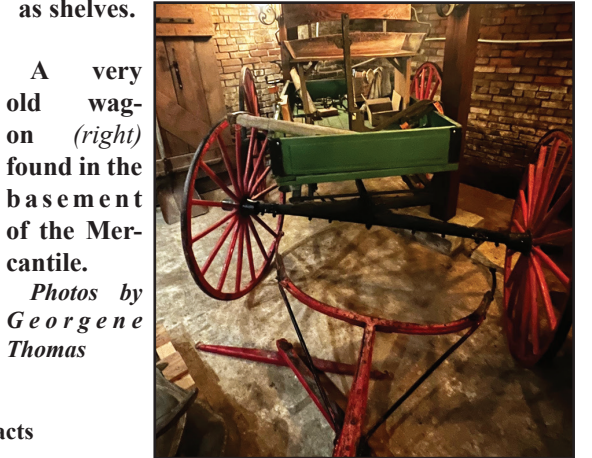

Kirkham Hot Springs is Temporarily Closed for Bridge Upgrade



BOISE COUNTY – The Boise National Forest will temporarily close the access bridge to Kirkham Hot Springs Recreation Site, located 3 mi. east of Lowman, from Nov. 11-15 as contractors replace the bridge’s surface. There will be no public access to the recreation site during this time.

This bridge work is part of an effort to improve and add amenities to the popular recreation site. Once the bridge is complete, other construction around the site will continue as weather allows. Additional upgrades are being made to parking, trails, pool access and other infrastructure, with all work expected to be completed by summer of 2025.

Funding for this work comes from the Great American Outdoors Act of 2020.

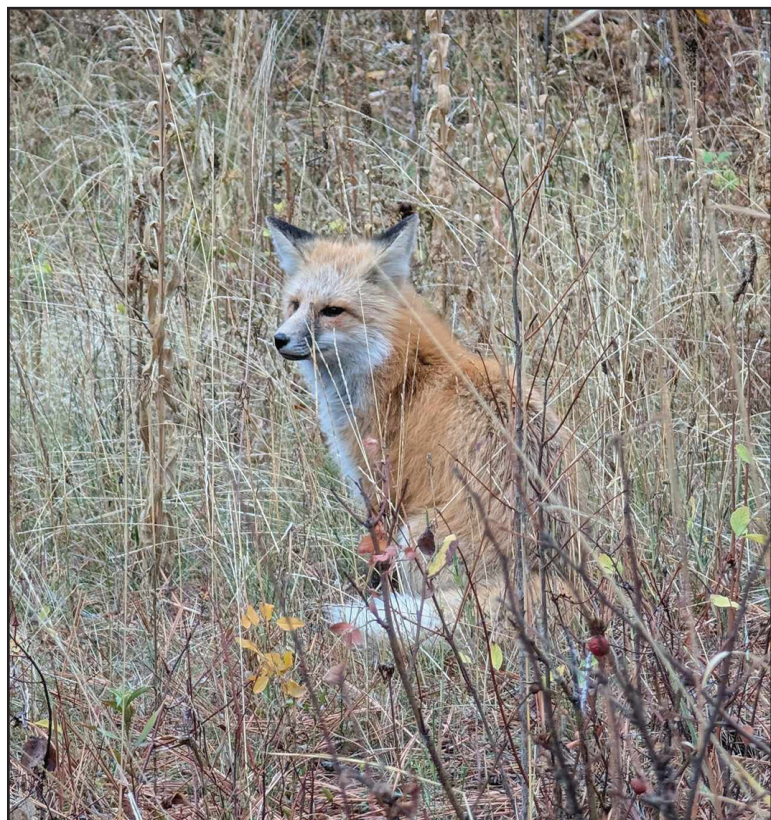

Rural Schools Legislation Passes in the Senate

Washington, D.C.—A bipartisan bill to reauthorize the U.S. Forest Service's Secure Rural Schools and Self-Determination Program (SRS) through 2026 introduced by U.S. Senators Mike Crapo (R-Idaho) and Ron Wyden (D-Oregon) has been unanimously approved by the Senate. Crapo and Wyden were joined by Senators Jim Risch (R-Idaho) and Jeff Merkley (D-Oregon) in reintroducing the legislation in 2024.

"Today's action in the Senate gets us one step closer to providing the funding certainty upon which rural county governments can rely," said Crapo. "I encourage the U.S. House of Representatives to swiftly reauthorize the SRS program to avoid any disruption to this vital program as rural counties rely on these continued payments to ensure funding for schools, road maintenance, public safety, search and rescue operations as well as mental and physical health services."

"Building on a history of bipartisanship, today, the Senate reiterated its support for rural communities," Wyden said. "I think

Senators Crapo, Merkley and Risch for their partnership to extend this critical funding – a lifeline that helps rural communities keep open their schools, libraries, roadways, and supports other vital resources. Once we've completed the remaining work to secure this three-year extension, I will be using it as a bridge to a permanent fix for providing services to rural Oregonians and Americans in every corner of our country."

U.S. Representatives Joe Neguse (D-Colorado), Cathy McMorris Rodgers (R-Washington) and Val Hoyle (D-Oregon) introduced companion legislation in the U.S. House of Representatives.

SRS was enacted in 2000 to financially assist counties with public, tax-exempt forestlands. The U.S. Forest Service and the U.S. Bureau of Land Management administer the funds. The totals are based on a formula including economic activity, timber harvest levels and other considerations that vary from county to county. SRS payments are critical to maintain education programs for many rural counties that contain federal lands exempt from property taxes.

History of the Boise Basin Bring on the Bucket Dredges

BOISE COUNTY -- Long after the peak of mining in the Boise Basin, a new technology was discovered that renewed interest in gold mining throughout the major placer mining districts of the West, including the Boise Basin. This was the invention of the bucket-line dredge, a massive piece of equipment designed to process huge amounts of riverbed gravel. First used in Bannack, Montana at Grasshopper Creek, eventually there were hundreds of dredges being built and operated around the West.

These dredges were used to sift through miles of river bottoms. The old tailing piles are most evident along Grimes Creek near Centerville. They extend for miles and miles.

The amount of gold that was recovered from these operations was immense, even though the dredges were inefficient at times and known to miss a lot of gold.

Stamp mills sprang up in Boi-

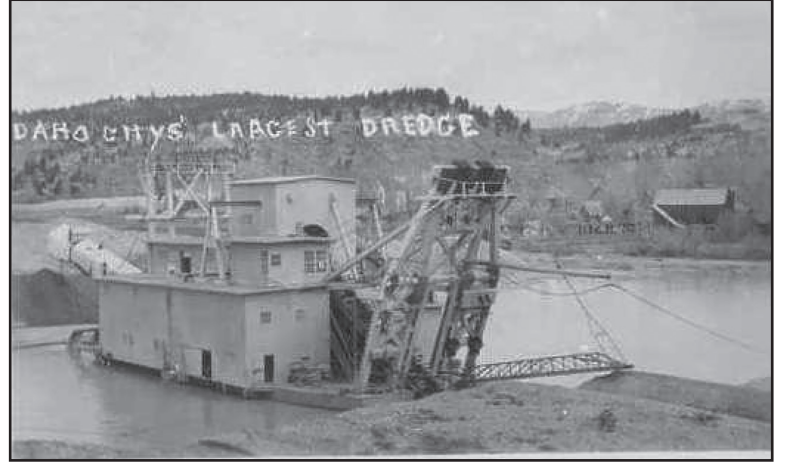

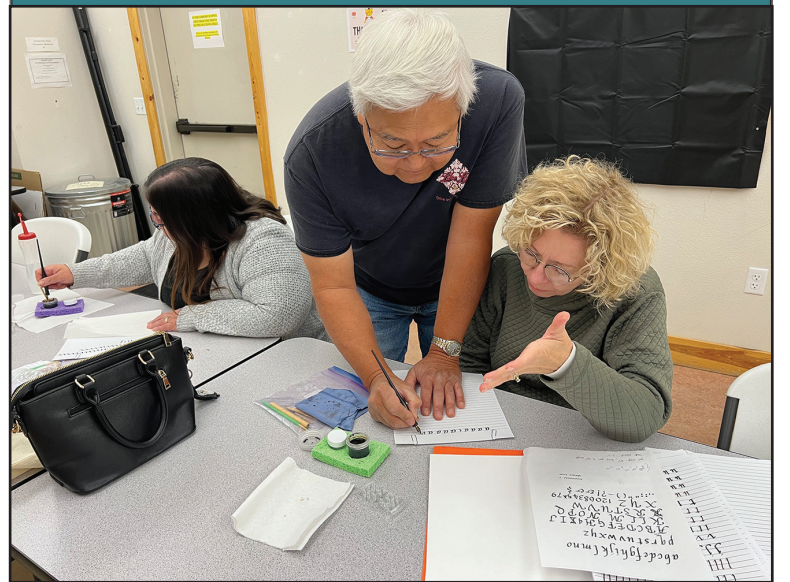
se as hard rock mining got established, but this always was primarily a placer district. Certainly, there are many mines that were built to extract lode gold from the mountains north of Boise, but most of the gold recovered was from the placers.

It is said that more than 2 million ounces were produced just within Idaho City during

the period from 1863 to the turn of the century.

Here is a picture of a dredge in Idaho City, Idaho. Behind it, the large building with the staircase is the Masonic Lodge. This picture was taken from what is now called Montgomery street, between Idaho City and Buena Vista Bar, a small mining village just West of Idaho City.
