### Emergency Training Among Volunteers

#### EAST BOISE COUNTY –

The Idaho City Fire Protection District held a basic patient care and moving techniques training on Saturday, December 14th. The Clear Creek Volunteer Fire Department also attended. Joey Araiza, the Clear Creek Training Officer, gave a thorough presentation on initial patient assessment. He covered what to take note of, to ask, watch for, and other important patient information to gather. This information gathering is especially useful if the fire department is first on scene or if the ambulance crew is delayed due to other calls, weather, equipment failures, etc. The more information that can be obtained quickly gives the EMTs and/or paramedics an advantage when it comes to understanding the situation as they arrive on scene. This information gathering can also escalate the urgency of the call, if the incident is life critical.

Attendees then went into training on how to safely, quickly, and effectively move a patient from a tight space or a dangerous situation, to an area to better provide care. This may involve moving a patient to better access ambulance equipment.

The group practiced proper lifting techniques both to avoid further injury to the patient and

for the crew members' safety. Several scenarios were practiced, along with drills to move a patient quickly and safely.

At the end of the class, the attendees went over a few RIT (Rapid Intervention Team) techniques to help move a downed firefighter out of an IDLH (Immediate Danger to Life and Health) environment.

Please remember to thank all the volunteers in our community for what they do and the help they provide. They can all use the aid and human power.

## BOISE COUNTY COMMISSIONERS

**December 10, 2024**

**Present:** Commissioners Clay Tucker, Bob Callahan and Lindy Lindstrom

**Pledge of Allegiance**

**Oath of Office for Planning and Zoning Commission:** Benjamin Williams raised his right hand and repeated the oath of office to support the Constitution of the United States and State of Idaho.

**CONSTITUENT INPUT:** None

**MINUTES:** Commissioner Lindstrom motioned to approve the minutes from December 3<sup>rd</sup>, 2024. The motion carried.

**HOMEOWNERS EXEMPTION:** Assessor Chris Juszcak reminded the board that homeowners can apply for a homeowner's exemption any time of the year, according to "newer law." Tax cancellations were presented to the board. Each was motioned and approved.

**FORESTER:** An opportunity to update the Hazard Mitigation Plan. Three proposals were received, and Jordan Jones discussed the process. Commissioner Lindstrom motioned to approve the Fairhaven's Solutions proposal to Boise County's Emergency Management request for all Hazard Mitigation Plan update. The motion carried.

**SNOWGROOMER:** Lindstrom motioned to approve the Garden Valley 2025 agreement. The motion carried.

**COMMUNITY JUSTICE:** There was an annual agreement for heating and air conditioning with YMC service. Commissioner Callahan said the pricing was good and no one was opposed. Lindstrom motioned to approve the agreement to service county office buildings.

**CLAIMS APPROVAL REPORT:** Commissioner Lindstrom motioned to approve the Claims Approval Report in the amount of \$143,233.64. All were in favor and the motion carried.

**PHONE NUMBERS:** There are efforts underway to maintain the same phone numbers, and the county will be going with a new carrier.

**SHERIFF:** Assessor Juszcak addressed the board on behalf of the sheriff, who was not in attendance. He reminded the board that the sheriff's office is reimbursed for their search and rescue efforts. Lindstrom motioned to approve the demand warrant to Idaho Mountain Search and Rescue Unit in the

amount of \$8,243.87. All were in favor and the motion carried.

**PUBLIC REQUEST:** A constituent from Garden Valley spoke about the property below the dump, and a stream that runs in the spring for a couple of months. He presented pictures including a ditch, a culvert that runs under Middlefork Road, and eventually into the Middle Fork River. However, it flows across a property that floods a few months out of the year, and there is a concern about how this may interact with the new construction. Lindstrom was concerned that there was a lot of water and that other landowners may feel that they should receive special

consideration too. Chairman Tucker said that the land would need to be surveyed. Commissioner Callahan said the water has proved over time that it will flow in that manner and was concerned that it may run into the yards of others. The board will do some consulting and determine if permits are required.

**EXECUTIVE SESSION:** Closed session to discuss personnel issues. [Time 10:27am to 11:47am] No action was required.

**FUTURE AGENDA ITEMS:** A couple of items were briefly discussed.

Adjourned at 11:50am.

## Let's Talk About Winter Bird Feeding

Turn your backyard into a bird B&B with these helpful wintertime bird-feeding tips

**BOISE COUNTY** -- We all know that neighbor that takes bird feeding to Olympic games-level extremes. With tree limbs sagging under the weight of countless feeders and a back lawn that looks like it was ripped straight from Augusta Country Club, they stand out on their back porch with arms outstretched as a myriad of birds swoop in to feed directly from their palms.

That may be a bit of an exaggeration, but you don't need to be Snow White to attract backyard birds. Many species — including finches, chickadees, jays, nuthatches, sparrows, doves and more — may very well settle on your backyard bed and breakfast with a proper bird-feeding setup this winter.

Usually, feeding wild animals is not a smart move. Feeding birds, however, is a special case, since they don't often become dependent on feeders alone, and instead use feeders to supplement their daily natural diet. Winter feeding also gives a little assistance to our feathered friends during the harsh, colder months.

Here are a few ways to spice up your bird-feeding buffet and enjoy an enchanting opportunity to observe wildlife right in your own backyard.

### Seed. It's what's for dinner

Before you go hanging your feeder (or feeders) all across your backyard, you'll need some seed. Depending on the types of birds you're hoping to attract, there are many feed and feeder options available. For

instance, hanging-style feeders can attract songbirds, such as house finches, chickadee, jays, nuthatches, and others. Thistle feeders can bring goldfinches, siskins, and house finches, and suet can attract woodpeckers, chickadees, and nuthatches.

There are many kinds of birdseed out there on the market. Be sure to source your birdseed from reputable sources to avoid dust, insects, weed seeds, or any other impurities from making their way into your feeder. Black-oil sunflower seed is a favorite of many species. Millet and cracked corn are favorites for many ground-feeding birds. Finches and siskins love nyjer thistle.

To avoid freeloaders like squirrels, rats, and mice ruining your supply, store birdseed in tight, waterproof containers. This will also help prevent mold.

### Feeder placement

Birds don't have the same pleasures that we do when it comes to drive-thru windows. Placing a bird feeder too close to hazards can end up doing more harm than good. Avoid placing feeders near windows or doors, and keep placement height and accessibility in mind. Predators such as hawks or free-ranging house cats can quickly become uninvited backyard dinner guests when feeders are put out in the open or near low-hanging ledges.

### Wash it all down

A hearty meal wouldn't be complete without a drink. Birds utilize birdbaths throughout the year not only to stay clean but to keep themselves hydrated—a luxury we humans should not try in our baths at home.

If possible, include a bird-

bath in your backyard bed and breakfast. There are several types on the market, but you can't go wrong with a simple clay potting saucer.

This time of year, however, it might be a little troublesome keeping that bath ice-free. There are a couple solutions, including special birdbath heaters, to help keep their baths from freezing over. And no, they don't come with little mini Whirlpool jets and colored LED lights.

### Sanitation

A bird's bath or feeder only does its job when it's clean. Imagine inviting over the whole cul-de-sac for a hot tub party and leaving the chlorine float in the garage. It's very important that backyard bird enthusiasts keep their feeders and birdbaths tidy and disinfect at least once a month to prevent the spreading of diseases.

Along those lines, aim for using perch-style feeders rather than open, saucer-style feeders. Because of their openness and contamination from bird feces, open feeders and baths can become a breeding ground for disease.

To clean your feeders, make a household bleach solution using one part household bleach mixed with nine parts lukewarm water. Make enough solution to immerse an empty, cleaned feeder completely for two to three minutes, then air dry.

### No beak, no feathers, no service

Remember that feeding wildlife (other than birds) is not recommended. Birds are unique in that they don't solely rely or become hooked on free, backyard birdseed. The same can-

not be said about other wildlife. If food set out for birds is being eaten by other wildlife, move the feeder to a safe location or discontinue feeding.

Feeding birds is a gratifying experience that can be enjoyed

by anyone. So pull out the binoculars and the bird-watching guide and enjoy this simple pastime all year round right from the comfort of your backyard.

## Watch for Power Poles and Downed Lines When Driving

**BOISE COUNTY** -- Over the past few days — and every winter — Idaho Power receives numerous reports of weather-related car/pole accidents and resulting power outages. The energy company asks drivers to take extra care and be aware of power poles along the roads.

Idaho Power also reminds customers that vehicle accidents, as well as heavy ice or snow, can cause power lines

to fall, and you should always consider power lines energized and dangerous. If you encounter a downed line, stay as far away as possible but at least 100 feet.

If a line falls on your vehicle, stay inside if it's safe to do so. If you must leave the vehicle because of a fire or other life-threatening situation, jump out and as far away as possible with both feet landing on the ground at the same time. Keeping your feet together, shuffle as far away from the scene as possible — at least 100 feet.

DO NOT touch the vehicle and the ground at the same time. For a video demonstration, visit [idahopower.com/safety](http://idahopower.com/safety).

**Editor's Note:** Boise County Sheriff Scott Turner said on Tuesday, Dec. 17th, after the big snowstorm that there had been several vehicle crashes and a lot of slide offs. No power poles had been hit, but there had been one hit by a vehicle in Ada County that caused a power outage. There were powerlines down throughout the county due to heavy snowfall.

## Be Prepared for Weather-Related Outages

**BOISE COUNTY** -- Although the average Idaho Power customer is without power for fewer than three hours per year, heavy snow on lines or strong winds can cause longer outages. Idaho Power wants to ensure you're prepared this winter by following these tips:

- Gather an outage kit with items like blankets, flashlights, and non-perishable foods.
- Plan for any unique medical needs, such as refrigerated medication or life-support systems.
- Keep electric space heaters away from flammable materials.
- Always operate portable generators in open or well-ventilated

areas and follow the manufacturer's instructions.

- Download the Idaho Power mobile app to track an outage's restoration status.

Idaho Power also recommends keeping an emergency kit with essentials in your car in case you get stranded (or come upon someone who is). Check out [idahopower.com/safety](http://idahopower.com/safety) for suggested items to include.

**Editor's Note:** On Tuesday, December 17th, there were 3,259 out of 3,913 tracked meters (83.29%) without power in Boise County, Idaho. On December 16th, there were 3,765 out of 3,913 tracked meters (96.22%) without power.

## Winter Driving Tips to Keep Idahoans Safe on Snowy Roads

**BOISE COUNTY** -- Idaho's iconic snow-covered landscapes are here for the season, and the Idaho Transportation Department (ITD) is urging drivers to prepare for winter road conditions. Whether you're a seasoned winter driver or facing your first Idaho winter, being "Idaho Ready" is essential for safety.

"There is so much to love about Idaho in the snow, but drivers need to be cautious," said ITD Director Scott Stokes. "Giving driving your full attention and taking extra precautions could make all the difference this winter."

ITD's winter maintenance

team works tirelessly to clear over 13,000 lane miles of highways across the state. Last winter alone, 429 plows traveled a combined 4.5 million miles. However, safe roads require effort from drivers too.

**Essential Winter Driving Tips from ITD:**

**Give snowplows space:** The safest place to be is a comfortable distance behind the plow.

**Prepare your vehicle:** Check your windshield wiper fluid, battery, and tires. Consider winter tires or chains for added traction.

**Pack a winter emergency kit:** Include items like a first aid kit, blankets, jumper cables, tire chains, and non-perishable

food.

**Plan your trip:** Download the Idaho 511 app or visit 511.idaho.gov for real-time road conditions.

**Drive cautiously:** Slow down, increase stopping distance, and avoid driver assistance systems like cruise control, lane-keeping, and other auto-pilot features on wet or icy roads. Remember, bridges and overpasses freeze first.

**Stay calm if you skid:** Gently brake and turn into the skid, avoiding overcorrection.

"Idaho's winter roads can be challenging, but with preparation, attentiveness, and patience, we can all stay safe," added Stokes.

## Horseshoe Bend City Council Meeting

**GARDEN VALLEY** -- The following is a synopsis of the Horseshoe Bend City Council meeting that was held on Wednesday, December 11, 2024. All councilmembers were present. Mayor Pat Goff made the call to order at 7:00 p.m. then led the Pledge of Allegiance. After unanimous approval of the agenda, minutes from the previous meetings on November 13th and 25th, plus the authorization to pay the city's bills, Goff opened the meeting with a public hearing listed on the agenda as *Deer Valley Subdivision: Amending Preliminary Plat*. City Attorney Tony Pantera spoke first. He told the council that the proper notice was not served to the correct people and groups. Pantera recommended that the city not proceed with the public hearing and that they instead schedule a special meeting or hold the public hearing at the next scheduled meeting of the council. Pantera said that the Idaho Transportation Department (ITD), the Horseshoe Bend Fire Department, the Horseshoe Bend School District, as well as appropriate residents were not given the necessary 15 days notice of the public hearing. Councilmember Stephen Chartier inquired about setting up a special meeting after giving notice but Goff stated that the timeline would be around Christmas. Goff said the council could meet without him, but some councilmembers discussed rescheduling the hearing until the next regular meeting on January 8, 2025. Councilmember Patti Burgess

said, "Unfortunately, with the holidays" the next meeting would be best. The hearing was rescheduled for January 8.

**New Business:** With the public hearing rescheduled, the first item under new business, Deer Valley: Approve the amended preliminary plat (action item) was rescheduled. Resolution #2024-3, Establishing Ambulance Billing Procedures, an action item, was presented by city treasurer Terrie Nolan. Nolan told the council that they needed to set up billing procedures as well as a billing schedule for the new billing company. Nolan provided a resolution for the council to look at. The resolution passed unanimously. Resolution #2024-4-Establishing Ambulance fees, an action item, was next on the agenda. Chartier made a motion to increase the ambulance fees but no numbers were included in the resolution. Nolan said she would fill those in at a later date, as the original numbers she had were too low according to the ambulance billing company. The resolution passed unanimously. A motion was made to approve the pay application for the State Highway 55 sidewalk project. City engineer Amy Woodruff told the council that the billing would be divided in sections based on the completion progress. The application presented was #1. The application was approved unanimously.

**Department Updates:** EMS-Rindy Quijas reported that the department had nine calls in November. Acute Rescue & Transport handled most of the calls as the department is

shorthanded. Quijas stated that the mini house was still unoccupied because of power issues that were still four weeks out from getting someone out to look at it. Goff said he would take care of that issue. Councilmember Martye White asked where the department was on training. Quijas replied that there were a few people interested in training and she was working on arranging it. A question in the audience from a member of the Horseshoe Bend Fire Department came up regarding where the mini house was going to draw power from. Goff said it would be from the fire station because it would be too costly to install a new breaker box but the city would pick up the extra usage costs.

**Public Works:** The department reported that they had been busy during the past month as a "slug of something"

took two weeks to get out of the system but was eventually diffused. The Department of Environmental Quality (DEQ) came out for a sewer inspection. The department said it was a "pretty big" inspection as it is only done every 4-6 years. The update ended when the department said, "we're just plugging along."

**City Engineer:** Woodruff reported that the sidewalk project is underway with a mid-February completion date and reiterated that the DEQ sewer inspection was very detailed and a "big deal." Woodruff added that the Office of Energy and the Governor's office had approved moving forward with the booster station.

**City Attorney:** Pantera reported that fee liens would need to be drafted to mirror new state court opinions and that going forward, open

meeting laws and agendas need to follow Idaho code given the recent University of Idaho and University of Phoenix dealings. Pantera also reported back that contracted raft and boat rentals from city properties are usually done through sealed contractor bids. White asked if Pantera would write up new ordinances for the fee liens. Pantera said they would be ready by the next meeting. Goff ended the meeting saying, "Wishing everyone a Merry Christmas and Happy New Year." The mayor also thanked the EMS and Fire Departments for all they do and added the city council members, Woodruff and Pantera. The meeting adjourned at 7:22 p.m. The Horseshoe Bend City Council meets on the second Wednesday of each month at City Hall, 112 Ada Street. Meetings start at 7:00 p.m.
