Present: Commissioners Clay Tucker, Bob Callahan and Lindy Lindstrom

Pledge of Allegiance **CONSTITUENT INPUT:**

A presiding officer with the Daughters of the American Revolution spoke on behalf of the Idaho State Society's 900 DAR members, "Asking you to issue a proclamation recognizing Veterans and Military caregivers in Boise County." She provided some history on the organization, "We were created in 1890 as a service organization comprised of about 200,000 active members, all of whom are women, you can trace their lineage back to a Patriot of the American Revolution. Our ancestors were our country's first veterans, and our first DAR members were the first military caregivers. We focus our service on the areas of historic preservation, education, and patriotism. We pride ourselves on being the largest service organization for veterans, comprised entirely of women." There are approximately 14.3 million military caregivers identified. "In 2024, we've worked to educate Idahoans about who qualifies as a military caregiver, identify military caregivers, and get them connected to resources in Idaho and a larger community of caregivers nationwide." The DAR officer said that currently, they have proclamations from 42 of Idaho's 44 counties, "and we would be honored to welcome Boise County to our team as the 43rd Idaho county to announce the support of military caregivers. All of our participating cities and counties are identified on a website built specifically for caregivers at hiddenheroesidaho.org, so that when caregivers connect to learn more about the services available for them, they can also see that incredible outpouring of support from communities all around our state. Fundamentally, all we want is for Boise County's caregivers to know that we see the tireless dedication they have for our ill, injured or wounded veterans. And we want them to know that they are not alone." Chairman Tucker stated that they would like to sign the proclamation, but would need to put the item on the agenda for next week in order to sign it. She is hoping that Canyon County would be next to sign a proclamation, "It really means a lot to be able to say in one voice that all of Idaho, without

exception, supports our military caregivers and our veterans, and I thank you for considering this request."

A constituent from the Centerville area and Transportation Specialist with the Basin School District specified that they have two new certified drivers for the school bus and that all the routes will now be operational. She shared concerns about the weather and would like more communication with the road department. Chairman Tucker said the board would talk with the road superintendent.

MINUTES: [Addressed later in the meeting] Commissioner Lindstrom motioned to approve the minutes from November 19th, 2024, and the motion car-

SNOW CHAINS: Commissioner Lindstrom motioned to approve the request purchase of snow chains for the Solid Waste Department in the amount of \$2,160. The motion carried.

JOB DESCRIPTIONS: Two job descriptions were discussed and can be found in the classifieds, for a maintenance position and a janitor. The job fair went alright, but more employees are needed to fill positions with the county. Lindstrom motioned to approve the job descriptions with the changes that were discussed, and the motion carried.

PROSECUTOR: A summer intern was discussed and has been budgeted for. The issue was tabled until next week's meeting.

APPROVAL: **CLAIMS** Commissioner Callahan asked about the \$8,000 for the porta potties. They were for the road department and the cost was over budget. The department fielded questions and agreed upon costs. Commissioner Lindstrom motioned to approve the claims approval in the amount of \$185,443.11. The motion carried.

AMENDED JOINT QUAR-TERLY REPORT: The Clerk/ Treasure's quarterly report was reviewed by Treasurer Gina Turner. Lindstrom motioned

to approve the amended Treasurer/Auditor Quarterly Report of October 1st, 2023 to December 31st, 2023. All were in favor and the motion carried.

CERTIFICATES OF RESIDENCY: Lindstrom motioned to approve the certificates of residency and the motion carried.

COMPASS APPLICA-TION: An update was given by a constituent. Commissioner Lindstrom will reach out to a COMPASS representative.

EXECUTIVE SESSION: A motion was said at the request of Planning and Zoning to discuss pending litigation. [Time 9:32am to 9:37am] No action was required.

DEMAND WARRANTS: A demand warrant for Computer Arts was motioned and approved for \$1,006.14.

EXECUTIVE SESSION: A motion was said to discuss a personnel issue with the Solid Waste Department. [Time 9:47am to 10:20am] No action was required.

EAST BOISE COUNTY AMBULANCE DISTRICT: The board of commissioners interviewed potential EBCED commissioners. Jim Anderson interviewed and said he had some volunteer experience as an EMT and fireman with Meridian. He also has ample experience with Hazmat, has been a leader in a company handling budgets and employees, and now owns the hardware store in Idaho City. He is excited for the challenge, and if chosen, will be looking for ways to recruit and retain personnel.

Another candidate is Deputy David Gomez, a Corporal with the Boise County Sheriff's Office and Officer Gomez with the City of Idaho City. He has worked as a school resource officer for many years, and before that was a Micron engineer. Gomez said, "My passion lies in helping people. I've been involved almost since I got here with EBCAD, so I've driven the ambulance, I've probably done CPR five times since I've

been up here, and so I know how that works and the people who volunteer and the people we work on, the people that we go and see. Some of our regular people, I'm very familiar with, not only just from the ambulance standpoint but from the police standpoint as well. Even as a deputy, I'm not afraid to get in there and do CPR and help out however that I can. Or drive the ambulance or whatever is needed. And sometimes I feel bad that I can't volunteer as much as other people, because I have my deputy job. So, I decided to step in and do this to help out and do my part with the community that I love being a part of up here. I mean, my wife and I love, love, love Idaho City and all of Boise County. And all the people, good, bad and ugly." Commissioner Callahan asked if he had "Board experience." Gomez did not, but said he can get along with anyone, attended school board meetings, and had a math background and could "crunch numbers."

Alex Gross, a third candidate, said he'd been a Boise County resident since 2019, employee of the county, worked as a driver for EBCAD, then went through the EMT course in 2021. He had helped "lead the charge" to get the new district

passed. He has experience as an attorney, EMS, and working with boards. He said EBCAD will continue to operate until the end of the fiscal year, Sept. 30th, 2025. Gross said, "So, there will actually be two boards kind of in place. One for EBCED, the new district working to get everything set up, all the agreements transferred... by October 1st of next year. Everything going forward will be EBCED." He said that even with the new district, "We're still going to face some problems. We can't pay for staffing all four ambulance sheds with this new budget, 24/7. Will it improve things? Vastly." Commissioner Callahan asked, "Where do you see EBCED in five years?" Gross replied that it would depend on the state and what they do with essential services. He said, "The ideal would be that it would become an essential service, we would get a lot of state funding and Boise County taxpayers wouldn't have as much of a burden, which would be great." Gross spoke of volunteer incentives, reliable vehicles, staffing 24/7, and better retention.

PUBLIC HEARING FOR TRAIL CREEK MEADOWS SUBIDVISION ONE: Planning and Zoning Administrator Alex Gross gave a report on the final plat with the accompanying conditions. The property is located just south of Star Ranch along Harris Creek Road. It is a 31-lot subdivision with a creek running through it and the land is pretty flat. He said there was an issue with the road and there was a grade of the road that will need to be fixed. Conditions for the approval were reviewed. Gross recommended approval of this subdivision.

There were no comments made by the community or constituents. The public hearing was closed and the commissioners deliberated. Commissioner Lindstrom motioned to approve the Trail Creek Meadows with the proposed conditions for approval and for allowing construction on lot one. The motion carried.

MOTION: Commissioner Lindstrom motioned to approve the Consolidated Development agreement for Trail Creek Meadows subdivision and Harris Creek Heights. The motion carried.

He then motioned to approve the Findings of Fact for Trail Creek Meadows subdivision and the motion carried.

EXECUTIVE SESSION:

A motion was made to enter executive session to discuss risk management and a personnel issue. [Time 12:22pm to 12:45pm] No action required and adjourned.



Placerville Fire Protection District Announces Year-Round Water Supply for Fire Suppression

PLACERVILLE -- In a groundbreaking development for fire safety in our community, the Placerville Fire Protection District proudly announces that, for the first time, we have year-round access to water for fire suppression. This essential enhancement is made possible by a proposal from Chief Bourret and an agreement with the developers of the Trail Creek Meadows subdivision and the Boise County Planning and Zoning Board.

Historically, irrigation water from the Bureau of Land Management pond above Placerville was turned off during the winter months because the pipes were not deep enough to prevent freezing. Not surprisingly, this severely limited our ability to respond effectively with water to fire emergencies.

However, with the recent agreement, the developers

have committed to providing a minimum of 30,000 gallons of water over a two-hour period, in alignment with the National Fire Prevention Association's requirements for rural fire protection.

"We are excited to have secured this vital resource for

the community," said Chief Bourret of the Placerville Fire Protection District. "This vear-round water supply will significantly enhance our firefighting capabilities, ensuring that we are better prepared to protect our community from the threat of fire."

This initiative not only strengthens our

firefighting efforts but also reinforces our commitment to safety and preparedness within the community.

We encourage residents to remain vigilant and proactive in fire prevention efforts as we work together to safeguard our homes and environment.



BLM to host adoption event at Boise Off-Range Wild Horse Corral

Wild horse only adoption event open to the public

BOISE COUNTY – The BLM Boise District Office will host a wild horse adoption December 13-14 at the Boise Wild Horse Off-Range Corral just off Pleasant Valley Road. There will be approximately 70 wild horses available next weekend.

- Friday, December 13
- 10 a.m.– 4 p.m., first come, first served adoption
- Saturday, December 14
- 10 a.m. 4 p.m., first come, first served adoption

As part of the program's efforts to find every wild horse and burro a good home, the BLM offers up to \$1,000 to adopt an untrained animal.

This incentive will be offered for every animal in Boise. The Wild Horse and Burro Adoption Incentive Program has played a vital role in supporting our mission to manage healthy herds of wild horses and burros on healthy public rangelands for the past five years. This not only saves taxpayers money, but it helps alleviate the strain on their natural habitats and promote long-term health and prosperity for our wild herds and other wildlife.

Since 1971, around 300,000 wild horses and burros across the country have been placed in loving homes. With some time and patience, adopting a wild horse or burro can be a very rewarding experience. Wild horses and burros are extremely adaptable and can be trained for many uses. They are known for their sure-footedness, strength, intelligence, and

endurance.

The BLM staff will approve applications onsite for individuals who demonstrate humane care for the animal and meet the following qualifications:

- Applicants must be at least 18 years old with no record of animal abuse.
- Homes must have a minimum of 400 square feet of corral space per animal, with access to food, water and shelter.

Corral fence must meet height requirements:

- Adult horses 6 feet
- Yearlings 5 feet
- Burros 4.5 feet
