
GARDEN VALLEY – On Sunday (1-26-25), the Garden Valley Fire District firefighters were continuing their smoke trailer training at Station #2. Within the trailer, they had to negotiate their way through halls, stairs, a second story, and various rooms. Along with the GVFD were members from Lowman and the Horseshoe Bend Fire Department, as they trained with the state instructors to deal with several smoke and fire scenarios. This provided our fire personnel with a unique access to the training trailer. The various fire departments have had a very busy January, training the last three weekends. Garden Valley Fire Chief Paul Cleaveland was pleased with the opportunity to train on structure fires. Unfortunately, the temperature on Sunday dipped down to 6 degrees and froze the propane tanks, which caused the delay in the fire training.

The GV Fire Auxiliary group prepared a lunch for the community firefighters. Garden Valley is very fortunate to have so many dedicated volunteers who commit their off-time to train and improve their skills to keep us safe.







BOISE COUNTY COMMISSIONERS

January 24, 2025

Present: Commissioners Clay Tucker (remote call-in by Zoom), Bob Callahan (present) and Lindy Lindstrom (absent, but reached via phone for Commissioners' minutes).

Pledge of Allegiance

CONSTITUENT INPUT: Steve Moore was concerned about the same potholes in the same place. There has been no compaction in the potholes, and the roads are back to the bedrock base. He said the paved roads are also deteriorated. He's concerned that on Grimes Creek Road there are a few potholes on blind corners that have pushed cars to travel into oncoming traffic. The constituent said, "Since the taxpayers and residents of the county are the owners of the county roads, we should be informed of projects and maintenance to be done and the timeline of when they will be done."

Commissioner Callahan said he would not disagree with the statement.

On a different note, Moore informed the board that the Lincoln Dinner for the Boise County Republican Party will be held on April 5th in Idaho City and Raúl Labrador will be the guest speaker.

Chairman Tucker asked if there was anything further that Callahan would like to add. Commissioner Callahan responded, "Moving into spring and summer, I think we all agree that we're going to do some major road repairs this year. We have some money that was allocated in the budget for it." He agreed with the constituent that a schedule needed to be put together, "and hit the main problematic areas on the roads and then we can build off that." The constituent said that he would like it published in the *Idaho World*.

Chairman Tucker said that the board would be interviewing for the Road Supervisor position on February 4th. "So, we're working on this problem," Tucker said. "I think publishing a schedule in the *Idaho World* is a great idea."

MINUTES: The minutes were tabled, but then Clerk Mary Prisco had concerns that the Idaho City Snowmobile Club needed to have the minutes approved so that they can apply for a grant. Commissioner Lindstrom could not be reached by phone and Commissioner Callahan was not present for the last Com-

missioners' meeting to be approved. The prosecutor left a voicemail with Commissioner Lindstrom.

PAYROLL CHANGE: Chairman Tucker spoke regarding a possible meeting law violation and an email sent by Commissioner Lindstrom, which was scheduled to be addressed at this meeting.

Clerk Prisco said that data was loaded onto the board's hard drive concerning the "payroll change that I created based on the kinds and levels chart, and the market rate chart for fiscal year 2025. And the job description is attached." Commissioner Lindstrom's email was also attached. Prisco said she also included the market rate table.

Commissioner Tucker asked if he needed to read the email into the record and Prosecutor Sosa said, "[Due to] the fact that it's been essentially entered into the record at this point, you do not need to read it." Tucker replied, "Perfect."

Clerk Prisco clarified that they were discussing the position of Office Manager, which is a level 6, and Commissioner Lindstrom's request that an employee of the county be recognized for her years of service, and moved to a higher pay bracket in her new position. Prisco said that the budget was not the issue. Callahan recognized that this job included more or different responsibilities with the Road Department. Callahan would like to retain employees, "and not about punishing employees for stepping up and bumping them back. For that reason, I am in favor." Callahan motioned to move Kristi Coffelt for the Office Manager of the Road and Bridge Department to a Level 6, Bracket A2. Commissioner Tucker seconded and the motion carried.

PAYROLL ADDITION: There were two applicants for the Road Department, and Callahan stated that they needed to check on one of the applicants. He said he'd heard that the applicant had declined the position. Callahan said he did not want to approve the applicant if he didn't accept the position. The clerk's office had reached out to the individual, but there was no response.

Clerk Prisco said there was some concern regarding the timing of the next meeting to be held on Feb. 4th. Callahan made a motion for an individual for 40-hours a week, it was seconded, and the motion carried.

Commissioner Tucker said that he just received a text from Coffelt, which said that the individual declined the job offer. There were no further motions.

PAYROLL ADDITION FOR I.T. ASSISTANT: Callahan recognized that this was a good addition that would bring some additional I.T. help for the county. Commissioner Callahan said it was at 16 hours a week, and Clerk Prisco said the individual was interviewed by the sheriff, assessor, and herself, and is "ready to go." Callahan motioned to approve the payroll addition of an I.T. Assistant at 16 hours a week and the motion carried.

MINUTES: Chairman Tucker motioned to approve the minutes from January 13th and January 21st, 2025. Commissioner Lindstrom seconded and the motion carried.

SHERIFF: A request for a replacement vehicle and equipment was presented by Sheriff Scott Turner. He said there was approval from the board to order a new vehicle to replace the vehicle that "got wrecked and was totaled out." However, "We're probably not going to see that vehicle until the end of the year, maybe." He would like to buy another truck off the lot, which is "like a hundred-dollar difference" and will cancel the other order.

Callahan said, "I don't have a problem with that." Sheriff Turner said the insurance was paying \$41,925 for the claim on the other vehicle. Clerk Prisco said the money had been received. Callahan motioned to pay Communications Northwest to outfit the Sheriff's truck with a radio in the amount of \$6,221.67. He then motioned to approve the payment in the amount of \$50,390.20 for a Chevy pickup. The motion carried. Sheriff Turner put on the record that he had compared the state contract pricing and this offer was lower, looking from Mountain Home to Ontario for the best price. Callahan said, "Awesome."

CLAIMS REPORT: Commissioner Callahan recognized a few "overages" for supplies in the clerk's office. And some for the road department for items like links, padlocks, and chains. He pointed out, "And we are quite a bit over on East Boise County Ambulance's maintenance and repair." Clerk Prisco addressed the issue for EBCAD, and said there was going to be a budget amendment for that with a \$25,000

donation that they received from the Collins family. Chairman Tucker said, "That was pretty awesome."

Callahan motioned to approve the claims approval report in the amount of \$84,860.17. The motion carried.

DEMAND WARRANTS: Callahan motioned to pay the invoice for the Sheriff's vehicle pickup truck in the amount of \$50,390.20. The motion carried.

He then motioned to pay a bill from Idaho Power for the Sheriff's office in the amount of \$1,508.66. The motion carried.

A motion was said for the invoices from CenturyLink in the amount of \$785.48 and \$361.57. The motion carried.

Callahan then motioned to

pay the City of Idaho City for water and sewer service in the amount of \$425.24. The motion carried.

He motioned to pay CenturyLink Lumen in the total amount of \$417.88. The motion carried.

Another motion was said to pay Zippy Fiber in the amount of \$233.68 for the E911 phone service. The motion carried.

NO MEETING THE LAST WEEK OF JANUARY. The Commissioners were all attending the Idaho Association of Counties conferences. The next regular meeting for the Board of County Commissioners was to be held on Feb. 4th. Clerk Prisco added that the agenda for that week was filling up quickly.

Adjourned at 9:42 am.

IDAHO CITY – The Idaho Department of Environmental Quality (DEQ) seeks representatives to fill vacancies on the Boise-Mores Watershed Advisory Group (WAG).

The Boise-Mores WAG is a group of citizens from a diverse set of interests dedicated to successful restoration and protection of Mores Creek, Grimes Creek, all tributaries upstream to the headwaters, Lucky Peak Reservoir, Arrowrock Reservoir, and the Middle Fork Boise River to the confluence of the North Fork Boise River.

The WAG is currently seeking representation from the following interest areas:

- Forestry and forest products
- Fisheries
- Idaho City municipal
- Recreation
- Shoshone Bannock Tribe
- Upper Umatilla Tribe
- Northern Paiute
- Local interests

The group will meet quarterly or as needed. Responsibilities include working with DEQ on the following deliverables:

- Developing water quality improvement plans known as total maximum daily loads (TMDLs) for streams, lakes, and rivers with degraded water quality conditions within the watershed.

- Helping identify contributing pollution sources in the watershed.

- Recommending specific actions needed to effectively control sources of pollution to the water bodies.

- Helping develop and implement a plan to meet water quality targets identified in the TM-

DLs.



ana. She "set up shop" in the local library and assisted several kids with their schoolwork and education for years. She found such enjoyment in working with and encouraging children to LOVE learning.

Carol worked in the health insurance industry at the start of her adult life. She worked for Indiana BCBS and Campus TriCare. After a time, she applied for a position with an Edward Jones Financial Office and worked in the investment/financial field many years, working her way up Branch Office Administrator (BOA) until her retirement in 2018. She adored and treasured her boss, DonJay and her coworker, Samantha and their families; they will always be considered "family". She enjoyed being a part of the small-town community which included her niece, Courtney and her family; husband Jason, and sons, Sam, Ian, and Mac and many, many Idaho City friends. Carol's younger sister, Sheree, lived nearby in Kuna and all three sisters would meet in Boise for lunch and also spend time together during the holidays. Carol embraced the Idaho City Community and enjoyed going to football, basketball, and volleyball games and to school events to support and cheer on all the kids. She bought herself a golf cart to go

"tooling around" Idaho City, waving at everyone she knew, and even those she didn't with a big smile on her face. Most knew her as "AC" (Aunt Carol), a nickname given to her by Jason. It was very common to hear "Hey AC!" being shouted in her direction, no matter where she was, followed by a smiling face, waving. She was very much part of this wonderful mountain community.

Her love for reading was shared with all in Idaho City on Halloween as she passed out hundreds and hundreds of brand-new books to trick-or-treaters (and their parents) and we heard over and over that the house was lovingly referred to as "the book house". She bought books all throughout the year to be sure she had a great variety from color books and crayons, early readers, chapter books, and young adult series. She loved talking with all the children, from two years old to teens, asking who their favorite authors were and would share "her favorites" to those who could not decide. She was always tickled when they would pick her favorite and would ask them to be sure they came back next year to tell her what they thought of the book. This was so dear to her heart, one of her final wishes was to be assured this would continue, and it will.

Carol spent the last three months of her life under St. Luke's Hospice Care and received absolutely the best care anyone could have. Her hospice team included Deanna, Anna, Ian, Kelli, and Chaplin Craig and there are not enough good words to say about this caring, giving team of medical professionals and beautiful people. Carol also received great support within the Idaho City Community; from the East Boise County Ambulance first responders to the Idaho City Community Club, from folks caroling at Christmas to friends and extended family stopping by and sending cards. You gotta love a small town!

Carol is survived by her sisters, Charlotte Watson and Sheree Van Hise; her niece, Courtney Roeber; husband Jason, great nephews, Sam, Ian and Mac; her sister-in-law Tracy Van Hise and nephew, Kurt in Indiana; Aunt Dottie in Virginia, and Aunt Anne in Florida; cousins in Alabama, Virginia, Kentucky and Florida; and many friends and extended family members in Idaho and Indiana. A Celebration of Life ceremony will be held early summer in Idaho City, Idaho.
