Motorcycle Safety and Avoidable Accidents | Garden Valley Baseball

BOISE COUNTY -- Boise County Sheriff Scott Turner reported that there has been a total of four motorcycle accidents so far this year. Fortunately, none of these accidents have resulted in fatalities.

Sheriff Turner offered valuable advice to motorcyclists, urging them to slow down and respect the flow of traffic. He emphasized that most fatalities are related to speed and/ or reckless operators. He also cautioned against passing over double yellow lines, which can lead to accidents.

On the evening of April 20th, an accident occurred on Highway 21, about a mile past the county line into Ada County. A motorcyclist heading towards Boise County lost control and collided with a cement barricade. The driver, a 52-year-old male from Boise, was transported by ground ambulance to a local hospital. His female passenger, aged 46, from Washington, was flown by Life Flight to an area hospital.

Both individuals were wearing helmets at the time of the accident. Three Idaho State Police vehicles were utilized to block traffic around the incident. The crash is still under investigation, and there has been no update on the condition of the driver or passenger.

"Motorcycle-related crashes, many of which are preventable, continue to be a major concern for our community," said Boise Police Cpl. Kyle Wills. "With the warmer weather and

increased riding season upon us, it's crucial that riders, drivers, and the public pay close attention to safety."

Idaho State Police was assisted in this accident by Ada County Paramedics, the Boise Fire Department, and Boise Police Department.

Sheriff Turner said these motorcycle accidents were due in part to the warmer weather that has brought the riders out early.

The late afternoon game was cancelled for Garden Valley to allow students sufficient time to get ready for prom.



Present: Commissioners Clay Tucker, Bob Callahan, and Lindy Lindstrom.

Pledge of Allegiance CONSTITUENT INPUT: None

MINUTES: Commissioner Lindstrom motioned to approve the special meeting minutes from April 3rd, and the motion carried.

ANNUAL MAINTE-NANCE RENEWAL: Clerk Mary Prisco discussed the software used by the county and the maintenance annual agreement. The topic was tabled.

PLANNING AND ZON-ING: Previous hearings and their conditions were presented to the board for signature. Lindstrom motioned to approve the conditions for Deer Ridge Miners Subdivision, all were in favor, and the motion carried. He then motioned to approve the signature on the White Miner Subdivision, which was also approved.

SOLID WASTE/ NOX- IOUS WEEDS: A change to the payroll for the Noxious Weeds Superintendent open position was discussed.

EXECUTIVE SESSION: The board motioned to go into executive session to discuss this issue. [Time 9:23am to 9:35am] Coming out of executive session, Lindstrom motioned to approve this payroll change. The motion carried.

CENTRAL DISTRICT
HEALTH: Russ Duke was
present and discussed the CDH
proposed budget for Boise, Elmore, Ada, and Valley County.
He explained that they used to
get more money from the state

from the counties. He said that covid-related positions had been eliminated. However, "the personnel budget has gone up slightly and what that includes is a reduction in personnel overall, that is the reduction of staff, and then built back into that is salary increases that we're proposing, as well as a pretty sizable increase in the cost of health insurance benefits." Duke discussed the opioid settlement funds that provide money for specific programs. The CDH is requesting a 3% increase for salaries and will be voting on this budget on May 9th. Duke said that there was money from pharmaceutical companies to help those struggling with addiction.

GRANTS: A grant writer came in to discuss community improvement projects, using AI to discover new grants, grant writing assistance, etc. Commissioner Callahan would like to pursue more rural grant money. Chairman Tucker would like to add the grant writer position back to the budget for Boise County.

ANNUAL MAINTE-NANCE RENEWAL: Specialized audio equipment was discussed with the IT employee, and he advised renewing the contract. Commissioner Lindstrom motioned to renew the For the Record (FTR) quote for \$795 for the program. The motion carried.

KINDS AND LEVELS: There was a discussion for this budget year and a question of updating certain positions for pay. A motion was said and the motion carried.

PAINT: The request to purchase paint to stripe Banks Lowman Road was discussed. Commissioner Lindstrom motioned to approve the purchase for paint and to stripe Banks Lowman Road in the amount of \$7,227.25. The motion carried

CONTRACTS AND AGREEMENTS: A motion was said to approve the agreement for the use of the Mutual Improvement Ladies Auxiliary Club as a polling place in the amount of \$100. The motion carried.


EBCED: The topic of the new East Boise County Emergency District was discussed with Prosecutor Alex Sosa regarding their fuel. Lindstrom motioned to approve the fuel agreement between EBCED and Boise County. The motion carried.

CLAIMS APPROVAL REPORT: A charge was discussed, then Lindstrom motioned to approve the Claims Approval Report in the amount of \$182,526.26. The motion carried.

BALLOT: A motion was said to re-appoint a doctor to the Public District Health Board. The motion of approval carried.

EXECUTIVE SESSION: Commissioner Callahan called for an executive session under risk management. [Time 10:52am to 11:15am] Coming back into session, there was no action required.

Adjourned at 11:20am.

Boise National Forest Issues - Flat Fire Post Recovery Decision

BOISE COUNTY — The
Boise National Forest has issued a decision for its post-fire
recovery efforts on the 2024

Flat Fire which burned 2,832 acres of National Forest lands three miles east of Pioneerville. Work will focus on hazard tree mitigation for public safety, salvage logging for economic value, reforestation for watershed recovery, and protecting recovery efforts by addressing unauthorized access.

"Felling hazard trees along motorized routes within the fire perimeter on National Forest land is a top priority," said Idaho City District Ranger Joshua Newman. "We'll have saw crews out doing this work once the melting snow allows for road access for forest visitors."

The public may encounter short-term road delays during hazard tree felling operations. This work is expected to be completed by fall, with monitoring over the next few years.

Commercial harvesting of fire damaged trees along and in the vicinity of roads 380G and 319 will be offered for sale later this spring, totaling up to 411 acres. Salvage logging would provide a vital source of timber to support the region's forest

products economies.

Reforestation using desired native tree species is being planned on about 1,650 acres where natural regeneration may be limited. This replanting will help to maintain appropriate forest cover and restore the area for wildlife, watershed functionality, and recreational experiences.

Trail repair and stabilization will occur along trail 163 to prevent trail structure loss and soil erosion. Structures will be placed at the beginning of trails 163 and 690 to allow for currently authorized motor vehicles 50 inches or less. Natural barriers will be positioned at key locations to discourage the creation of unauthorized motor vehicle routes.

The Flat Fire was one of many large fires in the Forest in 2024. This decision is the first of several post-fire recovery efforts aimed at addressing safety concerns, salvage logging opportunities, and reforestation needs

Idaho Medical Freedom Act

BOISE COUNTY -- On

April 4th, Governor Little signed the Idaho Medical Freedom Act, SB 1210a. The Idaho Code for this is Chapter 5. Title 73. This law will be effective on 01 July 2025. You will not be able to get full information on the Idaho Code until the law goes into effect. To read the bill in its entirety, search for Idaho SB 1210a in your browser. The Idaho Legislature page shows the full text of the bill. This gives everyone in the state of Idaho more freedom in making medical decisions for themselves and their families.

The main thing that this bill does for the people in Boise County and the State of Idaho, is that it prevents the state. county, local authorities, any school, and businesses from making any medical intervention mandate for entry, attendance (school), employment, or receiving services. Examples include disallowing mask mandates and prohibiting any type of mandated vaccines. These are the two recent mandates that citizens of Boise County have encountered.

This law would not apply to any situation that has a requirement for Personal Protection Equipment (PPE) as required by a business entity in the private or public sectors. This would be based on traditions, industry standards, or any federal law. Some examples of this would be handling hazardous materials/chemicals or many jobs in the medical field. It would not exempt any other requirements like masks and vaccines.

This bill does not remove the

immunization requirements for attending school K-12. Parents that desire to have exemptions for their children will still have to follow the exemption procedures in Idaho Code 39-4802.

There are a few exceptions. Federal laws and day care businesses (as defined by the Idaho Code 39-1102) would be exempted from this prohibition. Exceptions for businesses that require foreign travel. Lawmakers say that a Presidential Executive Order would not be an exception. Medical Intervention "means a medical procedure, treatment, device, drug injection, medication, or medical action taken to diagnose, prevent, or cure a disease

or alter the health or biological function of a person."

I talked with our District 8 Rep. Rob Beiswenger to get some clarifications. Rep. Beiswenger, Sen. Christy Zito, and Rep. Faye Thompson helped pushed this into law and voted for the final bill.

Our state is the first in the country to have medical freedom to this degree. If you have any questions, reach out to one of our District 8 Congressional Representatives.



History of Garden Valley ~ Monument to Charles Ostner



By Dawna Booth GARDEN VALLEY -- On Alder Creek Road, one mile above the South Fork, is an unusual monument. A monument to a TREE! The plaque reads:

"Washington In Idaho memorial to Charles L Ostner.

Site of pine from which Charles L. Ostner at his homestead in Garden Valley, Idaho carved 4 years on the George Washington equestrian statue.

Presented to Territorial Legislature Jan 1869 in memory of early pioneers.

Erected by Syringa Club 1976."

Over a century after its creation, the Syringa Club—a local civic organization—erected this memorial near the original carving site.

It's a quiet spot, marked more by reverence than spectacle, nestled among the Idaho woods where Ostner once shaped wood with devotion and vision.

Charles L. Ostner, an Austrian immigrant, spent four painstaking years carving a monument to a man he had never met, in a country still forging its identity. From 1865 to 1869, he shaped a single pine tree into something extraordinary: a statue of George Washington astride a horse.

Ostner was no ordinary sculptor. With only a postage stamp for reference, he modeled the face of the first American president with uncanny precision. Before even touching the wood, he sculpted the statue in snow—his own study in form and figure. It was an act of sheer determination, driven not by commission, but by deep respect for American ideals and a wish to honor the pioneers of Idaho Territory.

The result was breathtaking: an equestrian statue over nine feet tall, painstakingly carved and presented to the Idaho Territorial Legislature in January 1869. The gift was accepted with awe, and Ostner was awarded \$2,500—a considerable sum at the time. The statue was placed on a pedestal outside the Capitol for 65 years, enduring snow, rain, and time,

until it was finally brought indoors and gilded in gold.

It found a fitting home inside the State House. Although, for a time, it stood outside the attorney general's office, pointed in such a way that secretaries had a constant, if unintentional, view of the horse's rear end.

The statue still stands—now on the fourth floor of the Idaho State Capitol—where golden light glints off Washington's form. Few passersby realize the story behind it: one man's tribute to both a founding father and the wild new land he'd come to love.
