# 2025 Esto Perpetua Awards Honor Dedication to Idaho's History

BOISE COUNTY -- Governor Brad Little and First Lady Teresa Little recognized the recipients of the 2025 Esto Perpetua Award, honoring individuals who have made exceptional contributions to preserving Idaho's rich history.

This year's awardees, Skip Myers of Idaho City and Justin Smith of Pocatello, have played a crucial role in making Idaho history accessible and engaging through their widely followed Facebook group, IDAHO HISTORY 1800 to PRESENT. With 110,000 members, it has become a daily source of historical insight for Idahoans. Myers, deeply rooted in the Boise Basin's heritage, launched the group six years ago to share and preserve the everyday stories that shaped the state. Smith, a columnist and Bannock County Historical Society board member, later joined as a co-administrator, helping curate content that includes photos, in-depth articles, and even a published book featuring select stories.

Their commitment to keeping the group interactive has fostered a thriving space where Idahoans contribute personal and family histories, ensuring





that "little histories" are recorded and celebrated.

The award ceremony, hosted by KTVB News Anchor Brian Holmes, reinforced the importance of living and preserving history. First Lady Teresa Little emphasized the significance of honoring those who inspire, educate, and connect communities through storytelling, restoration, research, and collaboration. "Your work is a gift to Idaho," she said, "giving us space to reflect, learn, and grow. On behalf of the Governor, myself, and the people of Idaho, thank you for your dedication, vision, and heart."

The Idaho State Historical Society presented the awards

at a special ceremony on June 5, 2025, at the Idaho State Museum in Boise. The Esto Perpetua Awards, now in their 26th year, celebrate those who have helped ensure Idaho's rich history remains vibrant for future generations.



# Idaho City Honors Retiring Educator Tom Standerwick

**IDAHO CITY** -- Friends, family, and former students gathered on Sunday, June 8 at Majestic Mountain Ranch to celebrate the retirement of Mr. Tom Standerwick, a beloved educator who has devoted 30 years to teaching and mentoring in the community.

Overwhelmed by the heart-felt appreciation, Standerwick reflected on his career, describing his retirement as a "real mixed emotion"—excited for the next chapter yet deeply sentimental about leaving behind the students, staff, and hallways that have defined his life's work. He shared how a student-led retirement party brought him to tears, showcasing just how much he impacted

generations of learners.

Throughout his career, Standerwick taught nearly 600 students, serving as a shop teacher, middle school football coach, sixth-grade teacher, and even filling in as a bus driver when needed. 
alistic artwork captivated attendees, with over three dozen people gathering to celebrate the launch.

# **New Tax Reductions and Savings for Idahoans**

BOISE COUNTY -- This year, Idaho had four new tax laws passed which will allow everyone to keep a little bit of their money going forward. The four laws are - decrease in Idaho State Income Tax, increase of the Idaho Grocery Credit, Idaho Parental Choice Tax Credit, and a slight increase in Property Tax Relief. I have provided the bill numbers so that you can look up each bill and read it in entirety if you are interested in the details. I will cover the highlights of the bills that affect most people.

The reduction in state income taxes was House Bill 40. This will reduce the individual and corporate tax rate from 5.695% to 5.3%. This bill exempts military pensions from Idaho State Income tax. It removes the capital gains tax for the sale of gold bullion.

House Bill 231 increased the Grocery Tax Credit this year. It increases the Grocery Tax from \$120 to \$155 per person. Not a significant increase, but it does give us a little extra money. Remember that even if you are not required to file an Idaho Income tax return. you still can get the Grocery Tax Credit. This does require you to file your state tax returns.

Idaho Parental Choice Tax Credit House Bill 93 provides a tax credit for families that are home schooling or pursuing other non-public schooling. It provides a \$5000 tax credit per student and \$7500 tax credit for a child with disabilities requiring ancillary personnel as defined in section 33-2001 of the Idaho Code. This will be for qualified expenses. You

will need to retain your receipts and provide them to claim the tax credit. This has different qualifications, and I highly recommend you read the bill if it may apply to you. The Idaho Tax Commission states it will require an application. There is not any information available on this application that I can find. It appears to be a work in progress. The Tax Commission has this statement on their website, "When we have program details available, we'll make them public."

Property tax reduction was increased this year, with House Bill 304. This was a temporary relief until this year, when it was made permanent. This only applies to properties that have a Homeowner Exemption attached to the property. Chris Juszczak, the Boise County Assessor, said that calculating the reduction is complex and will be different each year. You can see how much this is on your tax bill. There is a line towards the bottom that will say "Homeowner Tax Relief." This line item is not included in the Summer Assessment Notice. An example of this reduction for 2024 is "Current value assessment of \$154,833, the relief last year was \$50.84." This amount will change each year.

All the information above is provided for public awareness. It is recommended that you read the bills for more details and consult with your tax preparer for further information and to learn how you can take advantage of these tax re-



# The Abbott Brothers: Building Roads and Dreams in Early Idaho

BOISE COUNTY -- James Asahel Abbott ("Asa") and Anna Maria Shelby married in Missouri in 1852 before heading west to Oregon, where they homesteaded 640 acres. Asa soon made a name for himself, serving as a captain of volunteers during the Rogue River War and later as County Sheriff

Seeking new opportunities, the Abbotts relocated to Pine Grove—also called Morestown—one mile above Idaho City, Idaho, during the Boise Basin goldrush. There, they

ran a General Merchandise store while Asa acquired several mining claims and the 160-acre Coffman Ranch along the Upper Payette River, later known as the Tucker Place.

Asa's brother, William ("Billy") Abbott, a former Justice of the Peace in Pine Grove, settled across the river. Billy purchased the Peter Haubrick Ranch one mile below Ostner's bridge. Together, the brothers employed several men growing and supplying fresh vegetables to miners, a much-needed service in the boomtown economy. They were community builders as well, constructing the first roads and founding the first school in Garden Valley.

Their efforts didn't go unnoticed. *The Idaho World* newspaper, on October 26, 1866, reported:

"ABBOTT'S NEW ROAD – the road some time ago laid out by J.S. Abbott, from Placerville to the Valley of the Middle Fork of the Payette, is now completed and open for travel. It runs northerly from Placerville to the old Lewiston trail, crosses the Payette near Thomas' bridge, and thence northwesterly to Ewing's bridge... It is Mr. Abbott's intention to complete the road to Round Valley early in the ensuing summer.... The energetic and public spirited projector merits not only the thanks of the public for it, but also an adequate substantial reward."

Asa, never one to miss an opportunity, introduced a bill in December 1866 during his time in the Territorial Legislature to authorize the road as a toll road. Rates were carefully structured: \$3.00 for each wagon with one span of animals, 50 cents for each additional pair, and 50 cents for each riding animal and man, 25 cents for a loose unpacked animal and only 10 cents for each sheep or hog. Return trips were half-

Thomas Faull

Thomas Faull, 78, of Horse-shoe Bend, Idaho passed away on May 30, 2025. Born Thomas George Faull to Thomas R. and Dorothy M. Faull on Octo-

ber 10, 1946, in Boise, Idaho. Thomas graduated from Boise High School in 1964, attended Boise Junior College, and graduated from The University of Idaho with a degree in Mechanical Engineering. He married Anita Dallolio in 1968, with whom he had two sons, James Aldo and Eric Jason. He married Donna M. Kent on August 6th, 2004, with whom he remained until his death. His engineering career started with the United States Bureau of Reclamation, and he later worked at J.U.B. Engineers, the Idaho Public Utilities Commission, and operated several of his own businesses. He enjoyed the outdoors, camping, and flying airplanes, and he was an accomplished mechanic and craftsman.

He is survived by his spouse, Donna M. Kent; children, James Aldo Faull and Eric Jason Faull; and grandchildren, James Allen Faull and Hudson Thomas Faull.

A casual memorial service will be held at the Horseshoe Bend Pioneer Cemetery at 10:00 AM on June 14, 2025.

Interestingly, on January 8, 1872, the Idaho World reported:

"County Commissioners ordered that the road leaving from Placerville to the Upper Payette Valley with the bridge across the Main Payette River be and the same is hereby declared a County Road and Public Highway." Why?

Although James Asa Abbott envisioned connecting Upper Payette Valley to Round Valley, he never finished the road himself. It wasn't until around 1882 that the Oregon Short Line Railroad completed a route through the area, shifting the course of development.

James' story ended far from the Payette Valley he helped shape. While living in Denison, Texas, he tragically took his own life on January 1, 1873.
