A Dream Built on Faith: The Story of Terrace Lakes Resort Celebrating 60 Years in Business 1965 to 2025

GARDEN VALLEY, ID

- Today, Terrace Lakes Resort has an 18-hole golf course, geothermal pool, restaurant, bar, and pickle bar courts. It's hard to imagine it all began as just a dream and a \$10,000 investment. Ilene Johnson, at 92, has been involved with the life of Terrace Lakes since the days of knocking on the doors of ranches in Garden Valley to find land where a campground and travel trailer park could be built, with distant hopes of having a golf course, pool, and snack bar. It was to be a relaxing weekend getaway destination. Today, Johnson and her kids, Lonnie Bramon and Val Wardle, are the majority stakeholders and the Board of Directors of Terrace Lakes Recreation Ranch, Inc., dba Terrace Lakes Resort. This unique development is a testament to what creativity, determination, and hard work can accomplish.

"We were young and dumb and really didn't know what we were doing or that it couldn't be done," Ilene Johnson recalls of the early days back in 1965. She and her husband, Jerry Bramon,

had a plan: to create a place where folks and their kids could enjoy the mountains. They called it "a thousand acres of family fun," driven by the belief that "a family that plays together, stays together." To make this dream a reality, Jerry Bramon gave notice to quit a secure government job of 17 years. He was in the civil service at Mt. Home Air Force Base. When they moved to Terrace Lakes, he withdrew his government retirement at 35. Jerry worked an average of 18 hours a day for 9 years, developing the resort, but was tragically struck by a massive heart attack that took his life at 44, too young to die.

The first hurdle the couple took on as they began their plan was finding the land. They were fortunate to find a property on the brink of foreclosure. It took \$8,000 to remedy the default. An owner carry contract was assumed and the sellers accepted no-par stock for the balance of their equity. This was only the beginning of a long and difficult struggle. In those early years, the project was kept alive by the incredible faith of friends, members, and acquaintances that believed in the idea

and had a lot of trust in what was happening. They often provided unsecured loans to make the payments to keep from losing the land.

Terrence Lakes was truly a community effort. Dozens of people traded their time and labor, working weekends for \$1.25 an hour to help build the resort from the ground up. "It took a lot of 'Blood, Sweat and Tears' and a lot of wonderful people to build Terrace Lakes, that is one of the reasons why it is such a special place," Ilene Johnson notes. Several children and grandchildren of the first members and property owners are active today, or are coming back with their children and grandchildren.

The resort's initial concept was simple: an "embellished campground." In the mid-1960s, travel trailers were everywhere, but campgrounds were not. Terrace Lakes offered travelers a place to park in the trees with the key amenity of two outhouses, for \$5.00 a month. There was no power or running water except for Warm Springs Creek, and members had to haul their

own drinking water. The first memberships sold for a modest \$200.

The resort grew step by step. In 1967, the geothermal pool was completed, and a major milestone came when the first indoor toilets were installed. A mobile home snack bar was acquired for a trade of \$2,000 in stock, and it opened the same weekend. It was a huge hit despite customers having to stick their heads through a small window to order. This quirky start and the gradual improvements that followed were part of what makes Terrace Lakes so unique.

All advertising came by word of mouth. All of the lots were leased until 1974. The restaurant, bar, and front nine of the golf course were completed in 1970. There were 300 members of Terrace Lakes by then.

The guiding philosophy was always to serve the average family. "Most resort areas want to appeal to the wealthy... and many of them have been bankrupt," Ilene Johnson says, "We didn't think about profit, mostly about survival, mainly we just wanted a place for people. This focus on affordability led to a non-traditional, non-assessable membership model that baffled bankers and real estate professionals alike." She remembers a

prominent realtor who came to check things out in the 1970s. After sitting on a log and looking around, he said, "There is something wrong here, everyone is too happy and too friendly, this is unbelievable." Ilene Johnson recalled that the realtor didn't buy anything, either.

Terrence Lakes was a "one-of-a-kind" development, built with homemade pencil sketches and a willingness to "figure out a way to do it" and make dreams into a feasible reality. The resort's survival, Ilene Johnson believes, proves it was simply "meant to be."

Today, Johnson finds the greatest reward is seeing happy members and property owners enjoying their time. The resort has evolved through the years. It has changed people's lives for the better, providing a haven where lifelong friendships are made and cherished memories are born. It's this simple joy that has made all the work worthwhile.

In the past 60 years, over 5,000 people have had a membership and/or property at the Resort. Come celebrate the years with Terrace Lakes! The anniversary party will be held on Saturday, August 23, from 1:00 to 6:00.

BOISE COUNTY COMMISSIONERS

Transcribed by Eileen Capson

August 12, 2025

Present: Commissioners Clay Tucker, Lindy Lindstrom, and Bob Callahan.

Pledge of Allegiance

CONSTITUENT INPUT: An individual came before the board to request that a public hearing meeting regarding a conditional use permit be moved to Garden Valley, commenting that many property owners would like to voice their concerns. He said it was “disrespectful” to the residents paying taxes who are “grossly affected by this deal not to have it were they can come and have their voices be heard.” [CUP 2025-003 Roots & Ridges Retreat]

EXECUTIVE SESSION: Commissioner Lindstrom motioned to go into executive session to discuss a personnel issue. [Time 9:06am to 9:38am] Coming out of executive session, Commissioner Lindstrom motioned to postpone the Roots and Ridges conditional use permit public hearing until a regular meeting on September 18th.

SHERIFF: Sheriff Scott Turner spoke of replacing nine deputy laptops by way of an Idaho Transportation Department grant. Lindstrom motioned to approve the purchase requests for the laptops for the ITD grant in the amount of \$24,563. The motion carried.

MINUTES: Commissioner Lindstrom motioned to approve five sets of minutes, spanning across 7/22, 7/29, 8/4, 8/5, and 8/8/2025.

CLEAR CREEK ROAD SPEED LIMIT: The road department suggested lowering the speed limit for Clear Creek Road, but stated that he realizes that people are going to speed if they want. The sheriff and Commissioner Callahan said they had received one email regarding the request to lower the speed limit. The board decided to “visit” this discussion again at a future date. Sheriff Turner offered to reach out to the gentleman who sent the email and inform him of the board’s decision.

SHERIFF: Sheriff Turner explained a proposal to share an expensive software with Valley County, including the splitting of the cost. He said that the software is desperately needed for work dealing with sex cases. Chairman Tucker thought it was a “great plan.” Commissioner Lindstrom said the software would potentially help “convict sex crimes.”

Lindstrom motioned to approve the memorandum of understanding between Valley County and Boise County.

CLAIMS APPROVAL: After seeing nothing unusual in the report, Commissioner Lindstrom motioned to approve the claims approval in the amount of \$207,262.43. The motion carried.

LIQUOR LICENSES: Lindstrom motioned to approve five individual licenses by stating their numbers. The motions carried.

DONATION OF PROPERTY DISCUSSION: A homeowner from Timber Mountain Ranch, about three miles up from the Lodge on Clear Creek Road near the summit, spoke about a common area that is a little over an acre in size. It has power and mailboxes and may be donated to the county. The Boise County Road Department may use it to store equipment. An agreement was briefly discussed.

EAST BOISE COUNTY AMBULANCE: The Wisconsin ambulance has arrived, paid for by the Collins family. Director Mari Adams said, “It’s an amazing rig! I think it’s going to be a really good rig for us to have.” This ambulance will be replacing Unit 12 in Lowman, “and finally, Unit 15,” said Adams. The “power loads” will need to be transferred to the St. Luke’s ambulance that was donated and the Wisconsin ambulance. Commissioner Lindstrom motioned to approve the swap of power loads from the old ambulances to the new ambulances in the amount of \$4,700. The motion carried. The Collins family again offered to help with that expense. Chairman Tucker thanked the Collins family for their generosity. Lindstrom said, “They are such a great help to this community.” Commissioner Callahan said they were a great asset, and Adams added, “We’re very lucky to have them. We couldn’t be where we’re at without them.” She also reported that the new grant ambulance was due later that week.

EXECUTIVE SESSION: The sheriff asked to enter executive session. Chairman Tucker motioned to go into executive session to discuss a personnel issue. [Time 10:14 to 10:38am]

No action was required. [Commissioner Lindstrom left prior to the public hearing.]

PUBLIC HEARING: Several ordinances were proposed and discussed. Amanda Leader with Juvenile Justice explained that the first proposed ordinance derived from an issue that they faced, “There were some juveniles that generated several calls for law enforcement when it comes to running away. And law enforcement didn’t have too many tools in their toolbelt to deal with that. There isn’t a county ordinance for that, and so this ordinance would be very helpful to law enforcement for that.” Leader said it would help with juvenile diversion and “holds the adults accountable for encouraging youth and assisting youth.” This ordinance was presented to all the county’s school superintendents. The ordinance is designed to keep the kids out of juvenile detention. Prosecutor Alex Sosa remarked that Boise County law enforcement already does a good job with juveniles. For example, if they make a traffic stop late at night, they will say to the juvenile, “Hey, call your parents. Let’s make sure that you can be out this late.” The statewide curfew is between midnight and 5am. Commissioner Callahan did not feel “that we can treat all youth the same” and was concerned about hunters and those youth returning late from a friend’s house with parental permission. He said there were a lot of good kids out late, and other provisions were discussed with the prosecutor. Sheriff Turner stated that “the intent of these ordinances is not to punish our citizens, our juveniles... or harass. The intent is to deal with some of our reoccurring offenders and parents who have no control or choose to not control some of these problems that we have and it’s a tool for us to use. And obviously, like any law, ordinance, whatever, we have discretion how we enforce it and who we enforce it on. So, I think my staff does a pretty good job of using their discretion.” The sheriff added, “The intent is to deal with offenders that are out causing problems in the county after hours, parents don’t care, and try to hold some accountability.” They can also provide additional resources and hope

PUBLIC NOTICE

The Boise County Board of Commissioners intends to use federal funds made available under Title III of the Secure Rural Schools and Community Self-Determination Act of 2000 and all remaining funds received from that time through the receipt of funds in 2025. These funds can only be spent for certain purposes set forth in 16 U.S.C 7142.

Proposed uses of federal funds The County proposes to obligate the funds, as set forth in PL 114-10, as follows:

Funds to carry out activities described by the Community Wildfire Protection Plan:

- \$121,764 to assist homeowners with professional management advice and modification of fuels within the home ignition zone and cover Wildfire Mitigation Department personnel while they work on these activities.
- Conduct Home Risk and Wildfire Mitigation Assessments on private properties throughout Boise County and have a centralized location to store and enter this data.
- Cover the salary and benefits of the personnel in the Wildfire Mitigation Department, as needed, while working on the projects listed for Title III funding uses.
- Aid communities by hosting volunteer days (e.g. Chipper Days events) for area neighborhoods in Boise County to come together and reduce hazardous fuels including disposal of woody debris.
- Design and implement fuel breaks and hazardous fuel reduction projects on private properties.
- Assist various local volunteer fire departments/fire protection districts by purchasing water tanks for water storage to be placed in areas of need within the jurisdiction of the departments/districts to address fire mitigation and suppression in the area.

Funds to reimburse the County for emergency services performed on Federal land:

- \$10,000 for the Boise County Sheriff for anticipated search and rescue emergency services performed on federal land and paid for by the County.

The reimbursement will be for the salary or wages of emergency response personnel deployed during an emergency response, the replacement of equipment, material and supplies expended, damaged or destroyed during an emergency response, the repair of equipment damaged during an emergency response, and the maintenance of vehicles, equipment, and facilities during an emergency response.

Public comments

The County is holding a 45-day comment period which will end at 5:00 pm on Saturday 09/27/25. The board is also sending this proposal to the Southwest Idaho Resource Advisory Committee pursuant to Section 302(b)(2) of PL 110-343. Please send the County any feedback, suggestions, or concerns that you may have regarding these proposed uses of these federal funds. Comments on this proposal may be sent by mail to the Boise County Board of Commissioners, c/o Boise County Clerk’s Office, PO Box 1300, Idaho City, ID, 83631, or by email to mlaurence@co.boise.id.us. Following the 45-day comment period, and after taking into full consideration the comments received, the Board will issue a decision on the proposed use of funds. If, in the future, the Boise County Board of Commissioners decides to use these funds for a different project that meets the

legal requirements other than the ones described above, a subsequent public notice will be issued for a 45-day public comment period.

Idaho History 1800 to Present

BOISE COUNTY — Many may not realize that the name-sake of Boise’s beloved Ann Morrison Park was born right here in the Idaho mountains. Anna Daly Morrison, born April 26, 1884, in Centerville, Idaho, spent her early years in the mining town of Quartzburg, where her father, Owen James Daly, was a gold miner and owner of the Daly Hotel.

At age 16, Anna moved with her family to Boise, graduating from high school and working as a secretary at the Idaho State Capitol. In 1914, she married Harry Morrison, co-founder of the Morrison-Knudsen Company—a firm that would go on

to help build the Golden Gate Bridge, Hoover Dam, and the Alaska Pipeline.

Anna, who later went by “Ann,” traveled the world with Harry, visiting construction sites and earning the nickname “First Lady of Construction.” She passed away in 1957, and in her memory, Harry purchased 153 acres of land between Capitol and Americana Boulevards, south of the Boise River. On June 7, 1959, he gifted the completed Ann Morrison Memorial Park to the City of Boise as “an enduring expression of a tender and revered memory.”

Her legacy lives on not only in the park that bears her name, but in the story of a woman

who rose from Idaho’s rugged mining towns to become a global figure in one of the most influential construction companies of the 20th century.

that they can create some positive contacts. The ordinance was tabled until the next meeting.

The next ordinance covered parking in known problem areas near water access in the county, including: Alder Creek Bridge, the Banks area, and the Robie Creek area. A deputy reported to the board that he counted 98 cars parked in Robie Creek on a busy weekend a few weeks ago. The ordinance includes a \$75 parking ticket and court costs, and then the deputies may tow the vehicle to allow traffic to flow and for emergency vehicle access. The county has introduced an electric reader board that reads, "No Parking," which was said to have helped in addition to the posted no parking signs. Commissioner Callahan motioned to approve the Boise County Parking Ordinance and the motion carried.

The last ordinance discussed was regarding "failure to obey the Highway 21 closure ordinance." Prosecutor Sosa said this ordinance was

derived from experiences like the times when people were found driving past the closure up at Grandjean during avalanche season. Currently, the fine is comparable to failing to yield to a stop sign. A sheriff's deputy recounted that, multiple times, Amazon semi-trucks have disregarded the signs posted by the Idaho Transportation Department saying the road was closed. Drivers continue, but then cannot turn around and need to wait for a wrecker to bring them out. There have also been search and rescue efforts at Mores Creek Summit for people that have driven up and gotten stuck in snow. Currently, this is just a \$90 infraction, and the county gets \$3 from the state for this penalty. Making this a misdemeanor offense is the only way the county can seek restitution. The deputy added that the ordinance would not likely have an effect on our county residents, "this is affecting a lot of the other people that are coming up that are unfamiliar with the area that are literally going out here in shorts in the middle

of winter and flipflops with no gear or anything in that sense. And now they're screaming for help. And we've got to have a way, if something happens, for us as a county, we can help recuperate some of that loss." The ordinance was discussed and the wording. Chairman Tucker stated that he wanted to hold off on a decision until the following week when they expect to have a full board to approve this county ordinance. The issue was tabled.

ITD: Representatives from the Idaho Transportation Department provided an update on the Gardena Bridge. They presented several different options and offered reasoning behind each preference.

EXECUTIVE SESSION: Chairman Tucker motioned to go into executive session to discuss exempt records. [Time 12:21 pm to 12:25 pm] Coming back into session, Commissioner Callahan motioned to approve the request for the release of lien on "2012-3." The motion carried.

Adjourned at 12:31 pm.

Two-Vehicle Crash Claims Life of Marsing Woman on August 16, 2025

BOISE COUNTY — A tragic collision on State Highway 21 in Boise County has left one woman dead and several others injured. The crash occurred at 7:03 PM on Friday, August 15, near milepost 49.5, prompting a swift response from emergency personnel and a prolonged road closure.

According to the Idaho State Police, a 19-year-old woman from Homedale was driving southbound in a 1997 Saturn SL1, accompanied by a 22-year-old female passenger

and a juvenile, both from Marsing. The vehicle reportedly ran off the road, then re-entered and crossed the center line, colliding head-on with a northbound 2014 Ram 3500 pickup driven by a 59-year-old man from Kuna, with a 64-year-old female passenger.

The driver of the Saturn was airlifted to a local hospital, while the juvenile passenger—secured in a child safety seat—was transported by ground ambulance. Tragically, the 22-year-old passenger, who

was the mother of the 7-year-old child (*verified*), died at the scene. Neither adult in the Saturn was wearing a seatbelt. The occupants of the Ram were uninjured and not transported.

The crash blocked all lanes of travel for nearly four hours, with southbound lanes reopening first. Northbound lanes remained closed for an additional hour.

The incident remains under investigation by Idaho State Police.

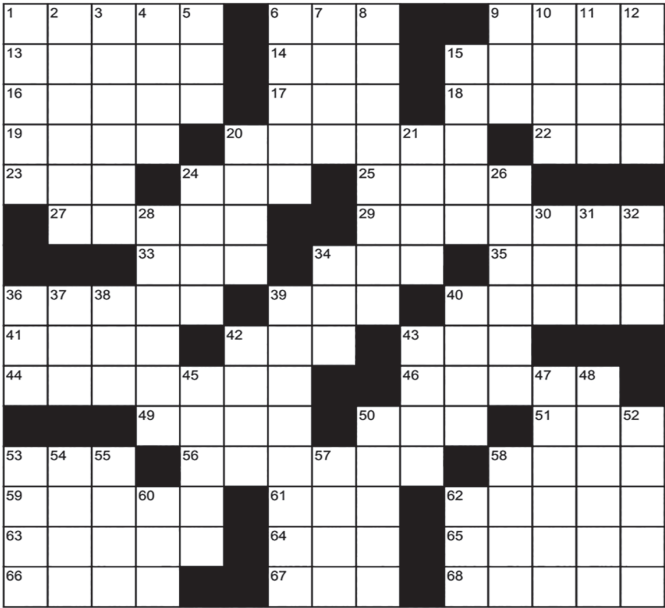
