Scott Keim Sworn In as Magistrate Judge for Boise County

BOISE COUNTY — On October 31, 2025, the Boise County Courthouse hosted the Oath of Office Ceremony for Michael "Scott" Keim, officially marking his appointment as Magistrate Judge of the Fourth Judicial District for the State of Idaho.

The ceremony opened with remarks from Douglas Werth, Lead Deputy Attorney General for the Idaho Department of Labor. The Oath of Office was administered by Judge Roger Cockerille, former Boise County Judge and Senior Magistrate Judge. In a heartfelt moment, Dayna Keim, Scott's spouse, presented the judicial robe.

Remarks were shared by John Lerma, partner at Le-

rma Grover Law, and Dawn O'Rourke, Deputy Prosecutor for Hennepin County and sister of Judge Keim. Attendees included family members Michael and Christine Keim (parents), Lt. Col. Erik Keim, USMC (brother), Gavin Keim (son), and members of the Idaho Judiciary. Refreshments followed the ceremony.

Keim was selected by the Fourth Judicial District Magistrates Commission following a competitive process that concluded on September 22, 2025. He succeeds Judge Adam Strong, who was appointed to the Power County bench. Other candidates included Gregory Stewart Loos, Trenton Alan McRae, and Alex Sosa.

Originally from Casper, Wyoming, Keim holds a B.S. in Psychology from the University of Wyoming and a J.D. from the University of Utah's S.J. Quinney College of Law. His legal career began in Canyon County as a deputy public defender, followed by work in civil litigation and personal injury law. Since 2006, he has served in the Office of the Idaho Attorney General, representing multiple state agencies.

A father of three, Keim enjoys skiing, hunting, and the outdoors. His appointment brings decades of legal expertise and public service to Boise County's bench, ushering in a new chapter for the local judiciary.

Lady Mustangs Capture Fourth State Title in Five Years, Cementing Volleyball Legacy

HORSESHOE BEND -- The Horseshoe Bend Lady Mustangs have done it again. For the fourth time in five years, Horseshoe Bend brought home the Idaho 1A State Volleyball Championship trophy, capping off an undefeated season and continuing one of the most dominant runs in small-school volleyball history! The Mustangs, who swept through the Long Pin Conference and District Tournament for the fifth straight year, entered last weekend's state tournament in

Coeur d'Alene as the top seed. The team didn't disappoint. After a heartfelt sendoff from students, staff, and parents on the Horseshoe Bend School campus — complete with an escort from local emergency responder vehicles — the Lady Mustangs made the 350-mile trip north to Coeur d'Alene, competing in the Pacific Time Zone.

Horseshoe Bend opened the tournament on Thursday, October 30, against the Coeur Du Christ Academy Saints (No. 8 seed), cruising to a sweep: 25-

11, 25-18, 25-15. Back home, Horseshoe Bend Secondary students watched the match live, cheering their team from the student center.

On Friday, October 31, the Mustangs faced the Rockland Bulldogs, winning in four sets: 25-21, 25-13, 24-26, 25-17, to advance to Saturday's semifinal. Saturday's semifinal brought a familiar foe — Long Pin Conference rival Salmon River, who earned their spot at state after a play-in victory over Deary on October 25. Horseshoe Bend prevailed again, 25-

16, 22-25, 25-16, 25-6, setting up a rematch with Rockland for the championship.

In the state title match, Rockland came out strong, taking the first two sets, 23-25, 23-25. But the Lady Mustangs showed championship grit, rallying to take the next three, 25-16, 25-22, 15-13, and secure the state crown. Head Coach Sharsti Moore, and Assistant Coach Kristin Goff have led the Mustangs to five straight district titles and four state

championships in five years. The 2025 championship roster includes juniors Kimber Jones and Celeste Wilson; sophomores Malia Goff and Aubrey Penney; and freshmen Trinity Catherman, Vilate Wilson, and Brooklyn Hess. Horseshoe Bend's remarkable season — undefeated in both conference and postseason play — continues a tradition of excellence that has become a point of pride for the entire community.

Oct. 28, 2025

Present: Commissioners Clay Tucker, Lindy Lindstrom, and Bob Callahan.

Pledge of Allegiance

CONSTITUENT INPUT: None.

MINUTES: Commissioner Lindstrom motioned to approve the minutes from Oct. 21, 2025, and the motion carried.

ROAD AND BRIDGE: Road Superintendent Jeremy Braughton discussed the purchase of six fuel tanks. He said these were made of thicker metal and the old ones are constantly needing repair. Commissioner Callahan asked what he meant by repair, “You mean patch and weld?” Braughton answered with a chuckle, “Yes, all of them. It’s extremely safe, yeah.” He recognized that the cost was steep but hoped it would last them awhile with the 30-gallon tanks. Commissioner Lindstrom motioned to approve the purchase request for six tanks in the amount of \$6,961.50. All were in favor and the motion carried.

Braughton then brought up for discussion the tires on the Gardena loader, “which are pretty much shot.” He shopped around and would like to go with the lesser cost estimate. Lindstrom motioned to approve Road and Bridge’s request to purchase tires in the amount of \$14,370. The motion carried.

Lastly, Braughton explained to the board, “I want my guys to look more professional, at all times.” He asked to have the safety allowance increased, “to where everybody can get a boot allowance now.” Cargo shorts will still be allowed, but no basketball shorts. The boot allowance will only apply to safety shoes. Chairman Tucker agreed, “I liked the dress code, looking a little better, because they represent the county.” Commissioner Lindstrom motioned to approve the dress code policy with the changes discussed. The motion carried.

AIR ST. LUKE’S: Full time employees are provided with Air St. Luke’s benefit. The solid waste supervisor said it cost \$55 a year and there are nine part time employees working in remote locations. Callahan said realistically that it may help save the county money if something were to happen to these employees, “I think that anybody that’s working up there, remotely, should have it.” The other commissioners agreed and Tucker said, “I

think it’s a very reasonable request.” Lindstrom motioned to approve the Air St. Luke’s benefit for the nine part time employees working at the county transfer sites. The motion carried.

TRAFFIC CONTROL: Sheriff Scott Turner addressed an annual ITD [Idaho Transportation Department] grant. Lindstrom quickly motioned, after there were no questions, to approve the ITD traffic enforcement grant. The motion carried.

CLAIMS APPROVAL REPORTS: FY2025 report was reviewed first, and then Lindstrom motioned to approve the claims report in the amount of \$48,652.02. The motion carried.

Commissioner Lindstrom motioned to approve FY2026 claims approval report in the amount of \$141,974.23. The motion carried.

CENTURYLINK: Commissioner Lindstrom motioned to approve the remaining for FY2025 fax line expense in the Prosecutor’s office in the amount of \$268.77. The motion carried.

DEMAND WARRANTS: Lindstrom motioned to approve a payment to Western States Equipment Company in the amount of \$39,307.09. The motion carried. Chairman Tucker said the next invoice was also for a 2025 150-all-wheeled grader. He said a second motion to approve the invoice for \$39,307.09, which was approved. Tucker said this next invoice was for the third grader and Lindstrom motioned to approve the demand warrant in the amount of \$38,756.82. The motion carried. Lindstrom motioned for the fourth time, which was for a backhoe, in the amount of \$27,012.88. The motion carried.

He then motioned to approve the demand warrant for the State Insurance Fund in the amount of \$10,043. The motion carried.

EXECUTIVE SESSIONS: Lindstrom motioned to go into executive session to discuss “acquiring real property.” [Time 9:26 AM to 9:47 AM] No action required.

He then motioned to go back into executive session to discuss pending litigation. [Time 9:47 AM to 10:02 AM] Lindstrom motioned to approve up to \$20,000 for surveying and related services on county property. The motion carried.

DEPARTMENT MEET-

ING

PLANNING AND ZONING: Alex Gross said he’d been meeting with Idaho Power in McCall regarding distribution lines. He also brought it to their attention that east Boise County Residents along Highway 21 were losing power a lot, and they are considering additional growth with the new Micron infrastructure coming in. Building permits are coming in for next year.

APPRAISER: Chris Juszazak said they have about 35 new homes in Avimor, well under their 95 building permits in the City of Eagle. The appraisers have been doing their re-evals.

SHERIFF: Turner said that they were able to hire another dispatcher and a front office person. He added that the backup batteries are not working on the E911 system when the power goes out, because they’re old and for the commissioners to expect this issue to come before the board.

JUVENILE JUSTICE: Amanda Leader is on a new board – Post Misdemeanor Council, which meets quarterly and offers trainings throughout Idaho. She said that their caseload is starting to go up and they received three new cases from Ada County.

SOLID WASTE: Kari Allred discussed a conference that she recently attended and a free glass recycling service that the county may participate in. They would have special containers at the transfer station(s) for glass. All the metals have been dealt with this year, but “during that process, we ran into a problem with any of the compressed air or liquid gas tanks. They will not bail those any longer... they will be rejected.” Allred said they will be asking residents not to drop those off at their metal piles. There are new signs with new prices installed. The department has two new laptops.

Garden Valley and Idaho City had loads of tires out. New cost comparisons will be done.

Allred had batteries hauled off from Garden Valley and Idaho City for recycling. She reported that a little bit of money was acquired for those, but there was a charge for the lithium batteries. She explained, “But that’s okay, we want to keep those lithiums out of the waste stream because they are what cause the truck fires.”

She reported, “I think everyone in Lowman got a new mat-

tress this year,” but got the mattresses cleared out.

The Garden Valley and Idaho City brush piles are closed for the season. There are also community service workers that have been helping with trash cleanup at the different transfer sites, like Styrofoam in the metal pile.

ROAD DEPARTMENT: Braughton said he had been kind of short on manpower this month due to hunting season. However, they were able to re-surface Alder Creek from the pavement to the summit. They were also able to add material and grade Grimes Creek this year. They are getting ready for winter, and already saw some snow in Lowman. The department is also getting some trucks for free, which they will use for parts to save the county some money. They plan to host an auction to sell some of the surplus equipment accumulated in the three yards. Braughton said, “All of the roads are getting graded now,” including Pioneerville and Horseshoe Bend. Chairman Tucker asked if there had been any news from the Atlanta Highway District, and there had not but he said the road was smooth.

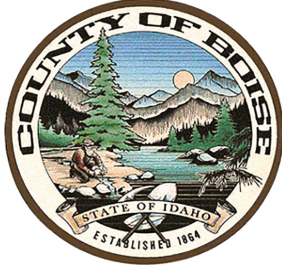

CITY OF HORSESHOE BEND NOTICE OF FILING OF A PETITION FOR JUDICIAL CONFIRMATION

NOTICE IS HEREBY GIVEN that the City of Horseshoe Bend, Boise County, Idaho (the "City"), has petitioned, pursuant to Idaho Code § 7-1301, et. seq. to seek judicial confirmation of the power of the City (1) to incur an indebtedness as an "ordinary and necessary expense" of the City authorized by the general laws of the State, within the meaning of Article 8, Section 3, of the Idaho Constitution, in a principal amount of approximately \$1,200,000 for the purchase of improvements to the water system of the City; (2) to issue a promissory note or other evidence of such indebtedness of the City for same, for the purpose of financing the cost of necessary improvements to the water system; and (3) to pledge the City's water system revenues and other lawfully available funds of Petitioner to the payment of such indebtedness for a term of years.

Interested parties who wish to review the Petition may do so during normal business hours at the Horseshoe Bend City Hall.

Any interested party may appear by written appearance or answer to the Petition filed with the Clerk of the above-entitled Court at any time prior to the date set for hearing on the Petition, which has been set before the Hon. A Lifeline for East Boise County Families

IDAHO CITY — For over two decades, the Idaho City Foodbank has quietly and consistently supported families across Idaho City and East Boise County, offering vital nutritional assistance and a sense of hope during uncertain times.

Operating with deep community roots, the foodbank participates in the Commodity Supplemental Food Program (CSFP), which provides additional food support to qualifying seniors. Thanks to generous local donations, the foodbank supplements its inventory from the Idaho Foodbank with essential protein items like cheese, tuna, and hotdogs—averaging \$700 in monthly purchases.

Recent economic challenges and reductions in SNAP benefits have heightened concerns, and the numbers reflect a growing need:

•Children under 18 served: 40 in July, 19 in August, 41 in September

•Adults over 18 served: 98 in July, 79 in August, 117 in September

•Families served: 71 in July, 75 in August, 82 in September, 86 in October

While the Idaho City Foodbank receives 23% of the total food poundage distributed in Boise County, it serves 45% of the county's recipients, underscoring its critical role in the region.

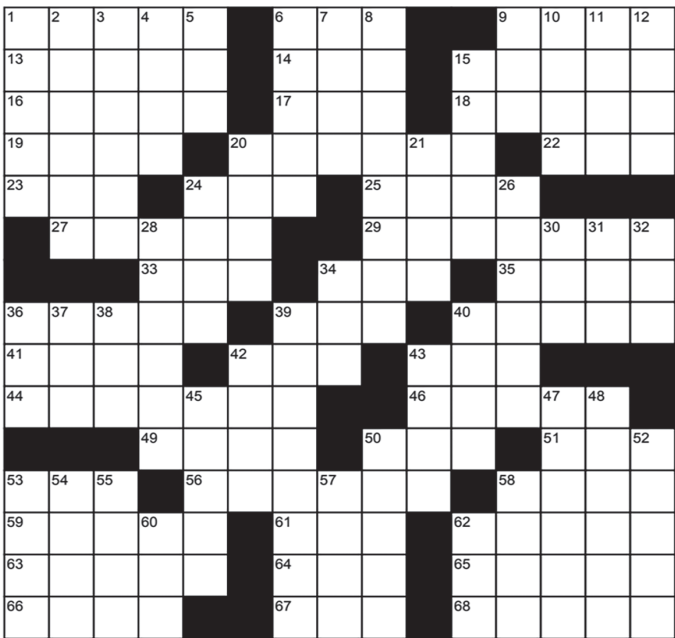

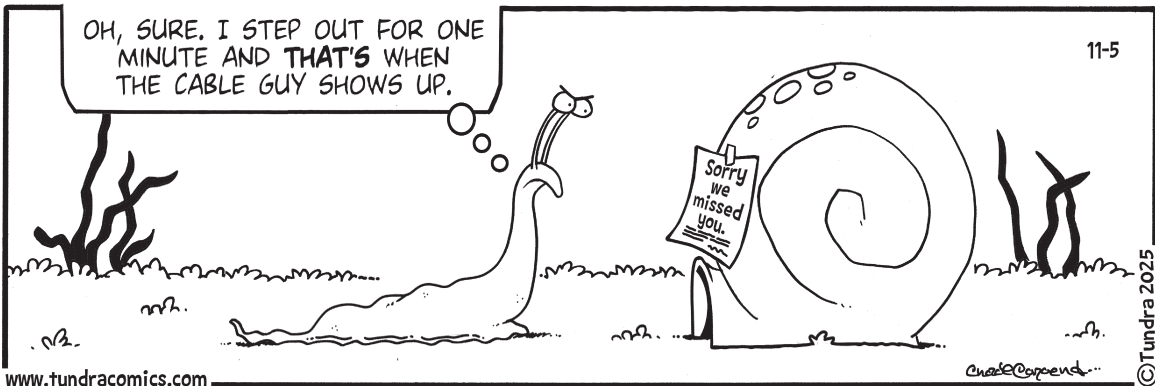

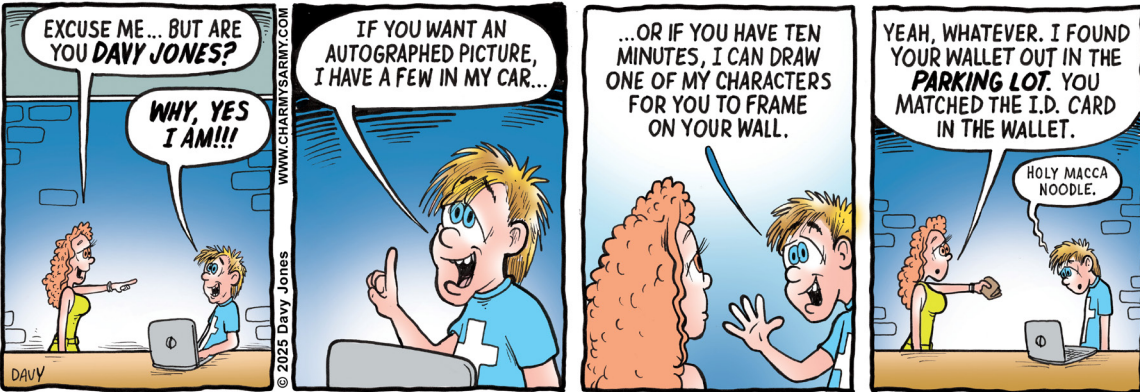

OPEN POSITIONS: There were no applicants for county building and grounds maintenance.

CLERK: Mary Prisco notified the board that they received communication from the state tax commission regarding the state levies, and one district had been noncompliant with the state controller registry, “Unfortunately, that impacts their ability to levy.” She will be notifying the undisclosed district.

Prisco said, “My new big push is finishing audit 2024, because back to that local registry deadline, it’s December 1st.” She hopes to have that complete sometime in November.

PROSECUTOR: Alex Sosa said that they are back in court and going well. He foresees community service getting “really ramped up” with the new judge.

Prosecutor Sosa said in terms of drug offenses, “My Chief Deputy has resolved some larger cases that is going to be pretty significant prison time for these individuals. And that’s all due in part to the Sheriff’s Office and making sure that we get those larger cases with statutory mandatory, minimums, and prison time.”

He added, “This past month, I was sworn in as the Vice President for the Third District, for the Idaho Association of Counties.” The board congratulated him.

GRANT WRITER: The individual said he was receiving feedback from the community and is developing a library of projects that they “would like and really, really need.” He spoke about IT needed at the Sheriff’s Office.

LIQUOR ORDINANCE: The alcohol licensing regulating sale and consumption ordinance was reviewed by Prosecutor Sosa during this public hearing. The hearing was posted in the Idaho World on October 8, 15, and 22. There were no public comments.

I am the CEO of Idaho Copper Corp., owner of the CuMo project in the Boise National Forest close to Idaho City.

I was recently provided with the above-referenced article [Idaho World article on Idaho Copper Corp., October 8, 2025] on the meeting in Placerville hosted by ICL and Idaho Rivers focusing on our activities.

The environmental groups, obviously opposed to our project, routinely misstate facts in order to form public opinion in their favor. In addition, there are a number of misunderstandings about CuMo. Some of these are as follows:

- Idaho Copper is a US corporation, publicly traded on US securities exchanges, headquartered in Boise, not based in Hong Kong as stated in the article
- While the land package currently owned by Idaho Copper encompasses 2,640 acres, only a maximum of 72 acres may be impacted by exploration activities under the Plan of Operations approved by the US Forest Service in March. This approval has been challenged by ICL and others in a federal District Court lawsuit filed in June.
- The CuMo deposit includes copper, silver, molybdenum, rhenium and tungsten. If a mine is eventually approved, there will be no cyanide leaching (alluded to in the article) which normally is associated with gold and precious metals deposits.

- While the environmental groups may rightfully challenge our project, the issues they raise have previously been litigated through two lawsuits. In the end, the science, not frightening headlines or misleading statements, controls whether a mining project will or will not cause environmental concern.
- There is no determination today to build a mine; first the company must undertake additional drilling and technical studies, and raise financing. Any decision to construct and operate a mine is years away. All the company desires today is to complete its exploration program.

Idaho Copper would appreciate the opportunity to have some or all of the clarifications described above printed.

Lavender, Love, and Local Craft: Garden Valley Farm Blossoms with Heart and Scent

GARDEN VALLEY— Nestled along the Middlefork River north of Crouch, the Garden Valley Lavender Farm has become a fragrant haven of beauty, community, and creativity. Owned and lovingly cultivated by Leslie and Rubin Lazo, the farm has flourished over the past three years, drawing visitors and locals alike with its vibrant lavender fields and hand-crafted products.

Amid the lavender-scented air, a heartwarming moment unfolded—Rubin asked Leslie to be his bride again. She said yes.

Lavender has been cherished for millennia for its culinary, medicinal, and aromatic uses. The Lazos have embraced this legacy, crafting a wide range of products available at the Summer Outdoor Market, holiday bazaars, and directly through their farm. Their offerings include:

- Moisturizing soaps and scrubs
- Insect repellent and calming roll-on perfume
- Scented dryer balls and sachets
- Lavender-infused spices and candles
- Pet shampoo for healthy coats

"My Newfy loved the shampoo," Ruppel said. "And the tomatoes with their lavender spice—SO GOOD."
